# Authorization of Fees for 2009-10

The following RESOLUTION for the 2009-10 academic year reflects the fee increases that have been proposed by the campuses. Chancellors recommended fee rate increases consistent with the tuition and fee guidelines established by the Board of Governors at the October 2006 meeting.

### RESOLUTION AUTHORIZING FEES

WHEREAS, G.S. 116-143 requires that the Board of Governors of the University of North Carolina shall fix the tuition and fees, not inconsistent with the actions of the General Assembly, at the constituent institutions of the University.

NOW, THEREFORE, BE IT RESOLVED, that, effective with the Fall Term 2009, the constituent institutions are authorized to charge and collect the following fees.

# **Application Fees**

This fee is charged to individuals submitting applications for admission as students to the University to offset the cost of handling applications and to provide funds for recruiting students.

# Athletics Fees

Athletics Fee revenues provide funds for intercollegiate athletic programs and for the maintenance and operations of athletic facilities.

For the 2009-10 year, increases in Athletics Fees are requested at thirteen institutions. The primary purpose for requesting these increases is to meet athletic conference/division requirements for scholarships and gender equity or to expand athletic programs. The cost of health insurance and medical treatment for student athletes has escalated. In addition, the cost of providing athletic scholarships has been impacted by recent tuition increases. The commitment that campuses have made to greater equity requires funds to maintain these scholarships at an adequate level.

The \$41 increase proposed by North Carolina A & T State University is part of a multi-year plan to reduce and eliminate departmental reliance on instructional resources (state auditor requirement); funds would also support a portion of the lease cost of the Aggie Buses and Title IX requirements. North Carolina Central University proposes a \$40.79 increase to support athletic scholarships, address inflationary operating expenses, support additional costs to meet requirements of NCAA Division I (financial aid, Title IX, travel) and funding for an additional staff member in the football program.

# Health Services Fees

Health Services Fees finance health and medical services for students, including the maintenance and operation of student health centers. For 2009-10, increases are requested at eleven institutions to expand services, extend operating hours, and provide for inflationary expenses, particularly in the cost of prescription drugs. At Appalachian State University, the \$42 fee increase supports expanded service delivery and inflationary costs associated with medical supplies, 2008-mandated legislative salary increases, and funding for the opening of a new women's clinic, which will require the addition of a physician, physician's assistant, two nurses, and associated operating costs. At UNC School of the Arts, the \$38 fee increase supports the rising costs of medical supplies, medications, and services offered at the Wellness Center and only partially covers the increase in 2008-mandated salary and benefit increases.

### Student Activities Fees

Student Activities Fees provide funds for nonacademic student services and for the maintenance and operation of facilities used in conjunction with those services. Included are funds to operate student unions and intramural facilities, and funds that provide for student organizations, newspapers, yearbooks, and entertainment programs. Increases in fees are requested at twelve campuses to provide for program expansion and to finance the rising costs of providing the current level of services. In addition, funding is required to support the 2008 legislative-mandated increase in state salaries, which has a particular impact to student activities. Security measures have been improved at many campuses during student events and operating funds have been proposed for new or expanded student unions and other recreational facilities.

UNC Charlotte proposes a \$102.00 increase to support the increased operating expenses associated with the new Student Union; also supports co-curricular activities of student organizations, including special lectures, concerts, recreational activities, intramural sports, maintenance for facilities and playing fields, and an additional staff position. UNC Greensboro is decreasing their fee by \$14.00 due to the end of a three-year transportation grant with matching funds.

# **Educational and Technology Fees**

Educational and Technology Fees were instituted as a result of the study of student fees conducted by the Board of Governors in 1992-93 and adopted in May 1993. The fees provide for specialized instructional supplies and services and for scientific and information technology equipment. Increases in fees are requested at ten campuses to provide for program expansion and to meet the rising costs of providing the current level of services.

UNC Charlotte proposes a \$50.00 increase to support the campus network systems, equipment and technology needs for labs and classrooms, and for materials and supplies for instruction. The increase also supports web-based services, classroom technology and direct access to electronic course materials such as Blackboard. The \$40.46 increase at Winston-Salem State University supports enhancement of telecommunications, data processing, and human support infrastructure. Funds would also be used to purchase laboratory equipment and provide maintenance of equipment in the Health Sciences area and to cover student support staff.

As additional information, it is noted that several institutions have a requirement that some or all students purchase computers. At UNC-Chapel Hill, UNC Greensboro, Western Carolina University, and Winston-Salem State University, all students are required to purchase their own computers. Information regarding these initiatives is available on the campus websites. East Carolina University, North Carolina State University, UNC Charlotte, and UNC School of the Arts do not require all students to purchase computers; however, some disciplines within these schools do have computer requirements for particular students.

### Indebtedness Fees

Under the policy for the establishment of fees adopted by the Board of Governors in 1993 and revised in 2003, fees for the retirement of indebtedness are approved at the time a project is approved and established at the time that debt is incurred. Indebtedness fees, once established, remain in effect until the debt is retired.

At North Carolina State University, an increase of \$88 in the debt service fee is a result of the following: a new fee of \$23 for Carmichael Complex and a new fee of \$30 for Intercollegiate Athletics (Phase II of the Track and Soccer Complex); a new fee of \$35 for the expansion to the Student Health Center (NCSU defeased debt for the Student Health Center in 2008-09 of \$28). The \$35 fee was approved for 2008-09 but will not be assessed to students until 2009-10.

A reduction of \$41.00 in the debt service fee at UNC Charlotte is due to defeasement of Cone University Center and Recreation Facilities Playing Fields bonds.

An increase of \$256.00 in UNC Wilmington's debt service fee is due to the issuance of special obligation bonds in order to construct the Student Recreation Center Expansion facility. The Board approved this project and the associated debt service fee in May 2008.

### Special Fees

Special Fees provide funds for specific needs that are not financed from other revenue sources. Except for the fees for administrative computing (charged to all students), special fees are charged *only* to students that participate in programs or activities financed from those fees. These are programs that have specialized instructional needs, e.g., programs in health affairs, law, business, engineering, and architecture. These needs are expensive and occur in curriculums where students must obtain a "competitive edge" to acquire highly desirable jobs upon graduation. In addition to the special fees listed below, all UNC students are charged \$1.00 per year for the Association of Student Governments Fee. There are no special fee increases recommended for fiscal year 2009-10.
