RESOLUTION HONORING

LLOYD V. HACKLEY

CHANCELLOR, FAYETTEVILLE STATE UNIVERSITY AND NORTH CAROLINA A&T STATE UNIVERSITY

THE UNIVERSITY OF NORTH CAROLINA

WHEREAS, Dr. Lloyd V. Hackley, Chancellor was selected as the eighth Chief Executive Officer of Fayetteville State University in 1988 and served until 1994; having ushered in a “New Era of Excellence” with four new undergraduate programs, fifteen new graduate programs which included FSU’s first doctoral program in educational leadership; having developed the University College curriculum core for successful matriculation of students in the first two years; having implemented the Chancellor’ Scholars program; and having increased student enrollment by fifty-six percent with increased diversity of students by ninety-five percent, and having increased the 5-year graduation rate by nearly fifty percent; and

WHEREAS, He greatly expanded FSU's community outreach, made a university education possible for at-risk children through the FIRST program, established articulation agreements with community colleges, established the Teacher Education Warranty which guaranteed the quality of Teacher Education Graduates, and received full accreditation from NCATE, DPI and SACS, and established the first endowed Distinguished Professor seat; received over \$50 million for capital improvement, achieved a successful \$4million Capital Campaign; and had five straight years of unblemished State audits; and

WHEREAS, On December 31, 1994, Chancellor Hackley left his post at FSU to become President of the North Carolina Department of Community Colleges, the first African-American to lead the state's system of 59 community colleges; and

WHEREAS, At the request of President Bowles, Chancellor Hackley served as Chancellor at North Carolina A&T State University from June 2006 – June 2007, while the University conducted a search after the resignation of the former chancellor. At North Carolina A&T State University, Chancellor Hackley supported shared governance, instituted a Transition Team, and required each area on campus to participate in an ethic workshop; and

WHEREAS, Chancellor Hackley contributed liberally to the Scholarship Funds at North Carolina A&T State University. Throughout his tenure, he was recognized as a leader who inspired others and he solved problems that others feared; and

WHEREAS, On July 20, 2007, Dr. Lloyd V. Hackley returned as Chancellor of FSU to again share his vision, wisdom, knowledge, and expertise to enable the continued growth and quality of the university into the new millennium, and through his generous philanthropic support initiated a \$2 million dollar capital campaign for student scholarships, and was the impetus for the campus going over the top in the State Employee Combined Campaign; and

WHEREAS, He has placed FSU on a sound course for fiscal solvency and clean budget audits; reinstituted the book rental policy to improve educational access and learning for students; and implemented widespread Campus Security measures cameras, lighting, computers, and sirens to make our campus safe; and

WHEREAS, He has opened a new Early Childhood Learning Center which supports Teacher Education programs; received reaffirmation of accreditation from NCATE and DPI for Teacher Education; and incorporated UNC Tomorrow in all campus initiatives;

WHEREAS, The University of North Carolina Association of Student Governments honored him with their highest award, the 2008 John L. Sanders Student Advocacy Award, for his contributions to the quality of the lives of students at Fayetteville State University, North Carolina A&T State University, the North Carolina Community College System, and the State of North Carolina; and

THEREFORE, BE IT RESOLVED that the Board of Governors of the University of North Carolina express its sincere gratitude to Lloyd V. Hackley for his superb and magnificent leadership and dedication to the ideals of higher learning of The University of North Carolina.
