**WHEREAS, BRADLEY T. ADCOCK**, has been a valued member of the Board of Governors of the University of North Carolina since 1997; and

**WHEREAS**, He served with distinction on three of the board's standing committees, the Committee on Personnel and Tenure from 1997 until 2001, serving as its secretary from 1997 until 1999 and then its chairman from 1999 to 2001; the Committee on University Governance from 2001 until 2005, serving as its vice chairman from 2001 until 2003 and its chairman from 2003 until 2005; and the Committee on Budget and Finance from 2005 until 2009, serving as its secretary from 2006 until 2007 and then its chairman from 2007 until 2008; and

**WHEREAS**, Mr. Adcock provided strong leadership to numerous special committees of the board, including the Committee on the University Award in 1998, 2002, 2003, serving as the chairman, and again in 2007, serving as the chairman; and the Committee on Committees in 1998, 1999, and 2002, serving as the chairman in 1998 and 1999; and numerous other special committees; and

**WHEREAS**, Members of the Board of Governors worked closely with Governor James B. Hunt, Jr., and members of the North Carolina General Assembly to secure legislation authorizing a referendum on a \$3.1-billion bond issue for university and community college construction; and

**WHEREAS**, On November 7, 2000, three out of four North Carolina voters cast ballots in support of the Higher Education Improvement Bonds, representing the largest bond referendum for public education in U. S. History; and

**WHEREAS**, Chairman Adcock successfully led the review and approval of setting tuition and fee rates in 2008 and continues to monitor and keep the University of North Carolina Bond Program on time and on budget; and

**WHEREAS**, He provided leadership in continuing the study of the cost of textbooks and insisted on keeping the cost as low as possible for students; and

**WHEREAS**, This distinguished executive, Mr. Adcock, served his alma mater, Appalachian State University, as a member of its Board of Trustees from 1995 until 1997, and has continued to demonstrate his Mountaineer spirit throughout his service on the Board of Governors; and
