Request for Authorization to Discontinue Degree Programs Identified in UNC System-wide and Campus Academic Program Productivity Reviews

Request

On a biennial basis, the UNC Office of the President and UNC constituent institutions review academic degree program productivity as statutorily required by the General Assembly in accordance with productivity criteria established by the Board of Governors. In response to this review process, which is described in the 2005 Review of Academic Degree Program Productivity report presented to the Committee on Educational Planning, Policies, and Programs this month, UNC constituent institutions request that the degree programs listed below be removed from the Academic Program Inventory (API).

In a number of instances the content of the deleted programs will still be available in more efficiently organized merged or new programs. In other cases the institution requests that the program be removed from the API because it has no enrollments or because the Chancellor has decided that low enrollments warrant a more effective use of resources in other ways. For teacher education programs, some institutions have decided that the content is better presented at the master's level, such as in an MAT program, in a comprehensive secondary education or curriculum & instruction program, or in a licensure-only format. All of the requested discontinuations are intended to enable institutions to realign organizations and resources for greater efficiency and productivity. Any student enrolled in a discontinued degree program will be able to complete and receive the degree, although new enrollments will not be accepted.

In an action separate from the biennial productivity review, UNC Greensboro requests discontinuation of the BS in Child & Adolescent Development in the Family. The campus notes that this program has become a concentration in the BS in Human Development and Family Studies degree program and should not be listed as a separate degree.

Recommendation:

It is recommended that as an outcome of the 2005 Academic Program Productivity Review the Board of Governors approve the requests of the institutions listed below to remove these degrees from the Academic Program Inventory effective January 1, 2006.
