REPORT OF THE COMMITTEE ON PERSONNEL AND TENURE

Mr. Davis, chair of the Committee on Personnel and Tenure, presented the committee's report.

Mr. Davis reminded the board members of the luncheon on May 13, 2005, to honor the recipients of the 2005 Board of Governors Awards for Excellence in Teaching. He asked all members to please attend this luncheon, as it is a very important honor for the recipients.

Mr. Davis then called upon President Broad for her report. President Broad stated that it was her great pleasure to make a recommendation for the appointment of a chancellor at the

University of North Carolina at Asheville. She began by introducing Ms. Susan H. McClinton, chair of the UNC Asheville Board of Trustees and chair of the Chancellor Search Committee.

Ms. McClinton thanked President Broad and the Board of Governors for the chance to report on behalf of the search committee. She stated that President Broad came to Asheville in January and charged the search committee to find the best candidates for consideration. She stated that the search committee, along with Ms. Shelly Storbeck from the Executive Search Consulting Firm of A. T. Kearney, did an outstanding job in bringing the committee a wonderful slate of candidates. The committee was made up of five members of the faculty, five members of the Board of Trustees, and five members of the community at large.

President Broad stated that she was pleased to announce the recommendation of Dr. Anne Ponder as chancellor of the University of North Carolina at Asheville, effective October 1, 2005, at an annual salary of \$200,000. She then reviewed the qualifications of Dr. Ponder who currently serves as President of the Colby-Sawyer College in New Hampshire. President Broad stated that she was delighted to bring this talented North Carolinian back home.

Mrs. Owen moved approval of the recommendation, and Mr. Cecil seconded it.

The vice chair put forth the recommendation and it carried. At the request of Vice Chair Souza,

Mr. Broadwell, Mr. Cecil, Dr. Key, and Mrs. Owen escorted Dr. Ponder into the room.
