2005 Board of Governors Non-Budget Legislative Initiatives

HIGHEST PRIORITY

Finance

1 Bond Project Modifications Campus Requests The following projects listed in Chapter 3 of the 2000 Session Laws and authorized by voter referendum in November 2000 have been recommended for scope modifications by the campuses. These suggested changes are consistent with the initial intent of the listed projects. However, these alterations are due to changed conditions or discovery of a more efficient means to accomplish the same end result.

1a) <u>North Carolina Central University</u>. Cancellation of Latham Residence Hall – Comprehensive Renovation (\$3,422,600) and transfer of residual funds to Eagleson Residence Hall – Comprehensive Renovation.

1b) <u>Elizabeth City State University</u>. Change scope of Mitchell-Lewis Residence Hall – Comprehensive Renovation (\$2,123,700) to a replacement project.

1c) <u>University of North Carolina at Wilmington</u>. Cancellation of King Hall Classroom Building – Comprehensive Renovation (\$3,527,400) and transfer of residual funds to the following projects: General Classroom Building, Academic and Classroom Facilities, Hinton James Hall Classroom Building – Comprehensive Renovation, Kenan Auditorium – Comprehensive Renovation, Friday Hall Laboratory Building – Comprehensive Renovation.
1d) <u>University of North Carolina at Pembroke</u>. Cancellation of West Residence Hall – Comprehensive Renovation (\$977,300) and transfer and transfer of residual funds to a new project, North and Belk Residence Halls – Fire Safety Improvements and Renovations.
1e) <u>University of North Carolina at Pembroke</u>. Cancellation of Campuswide Infrastructure Improvements (\$1,996,600) and transfer of residual funds to a new project, Biotechnology Teaching Labs and Classroom Building.

<u>1f) Western Carolina University.</u> Cancellation of Killian Education and Allied Professions Building and transfer of residual funds in the amount of \$1,297,924 to the Stillwell Lab Building – Comprehensive Renovation.

<u>1g) Western Carolina University.</u> Cancellation of Old Student Health Center to residential and Academic Space. Residual savings in the amount of \$1,496,945 will be allocated to Stillwell Lab Building – Comprehensive Renovation.

<u>1h)</u> University of North Carolina at Chapel Hill Proposed Scope Revision: After comprehensive programming and concept design, the University has proposed reprogramming the building project. In lieu of providing space for the relocation of the Music Library immediately, the new building will house the Department of Music. This will allow for the future renovation of Hill Hall for the Music Library. The Music Library has been temporarily relocated to Wilson Library.

- 3 Special Obligation Bonds For Acquisition of Equipment and Renovation or Repair of Existing Facilities

Place Enrollment Funding in the Continuation budget.

Amend GS 116 and GS 116D to provide low-cost financing for major equipment purchases and repairs and renovations to facilities for smaller-scale projects that are not considered to be Capital Improvement projects or determine an alternative method to make this type of financing available for this purpose.

4	Lead-Time For Acquisition Of Real Property	The acquisition of real property valued \$25,000 or greater by the UNC System requires approval by the respective Board of Trustees, UNC Board of Governors, Joint Commission on Governmental Operations (Gov. Ops) and the Council of State. However, only Gov. Ops does not have a regular, year round meeting time thereby creating delays. It is recommended that GS 146-22 be rewritten in a manner requiring the purchase of land be reported to Gov. Ops thirty (30) days prior to the sale.
5	State Land and Municipal Review	Amend or repeal G.S. 160A-392 where state land was added as being subject to municipal review and control.
6	Retain Proceeds from Sale of Chancellor's Residence	Retain the proceeds from the sale of the existing chancellor's residence at UNCA and appurtenant land and use those proceeds to construct or otherwise acquire a new chancellor's residence.
