## Authorization of Fees for 2010-11

The following RESOLUTION for the 2010-11 academic year reflects the fee increases that have been proposed by the campuses. Chancellors recommended fee rate increases consistent with the tuition and fee guidelines established by the Board of Governors at the October 2006 meeting.

# **RESOLUTION AUTHORIZING FEES**

WHEREAS, G.S. 116-143 requires that the Board of Governors of the University of North Carolina shall fix the tuition and fees, not inconsistent with the actions of the General Assembly, at the constituent institutions of the University.

NOW, THEREFORE, BE IT RESOLVED, that, effective with the Fall Term 2010, the constituent institutions are authorized to charge and collect the following fees.

#### Athletics Fees

Athletics Fee revenues provide funds for intercollegiate athletic programs and for the maintenance and operations of athletic facilities.

For the 2010-11 year, increases in Athletics Fees are requested at fourteen institutions. The primary purpose for requesting these increases is to meet athletic conference/division requirements for scholarships and gender equity or to expand athletic programs. The cost of medical treatment for student athletes has escalated and the cost of providing athletic scholarships has been impacted by recent tuition increases. The commitment that campuses have made to greater equity requires funds to maintain these scholarships at an adequate level.

The \$40 increase proposed by FSU would support an additional full-time certified athletic trainer and expenses associated with program operations and escalating costs for accidental medical insurance and stand-by services for student athletes. Although UNCC's increase is only \$12, their Board of Trustees has approved the establishment of a football program, including a projected \$50 a year increase in the athletics fee for four years beginning in 2011-12 to a total of \$200. WCU proposes a \$50 increase to address Title IX deficiencies, operating costs, and to begin phasing out the dependence on the full scholarship provision.

#### APPENDIX S

## Health Services Fees

Health Services Fees finance health and medical services for students, including the maintenance and operation of student health centers. For 2010-11, increases are requested at ten institutions to expand services, extend operating hours, and provide for operating expenses, particularly in the cost of prescription drugs. At ASU, the \$20 fee increase covers expanded service delivery, operating costs associated with medical supplies and implementation of an electronic medical records system, and also supports the recently opened Women's Clinic. At NCA&T, the \$15 fee increase supports the rising costs of medical supplies and equipment and also provides funds for the continued expansion of the medical records area and storage. At UNC Asheville, the \$33 fee increase supports the hiring of part-time mental health counselors, supplements the addition of one nurse position, and also funds replacement of outdated medical equipment. At UNC Greensboro, the \$26 fee increase covers increased operating costs associated with the Student Health Center and provides funds for a Tech Support Analyst to help with automated medical records.

## Student Activities Fees

Student Activities Fees provide funds for nonacademic student services and for the maintenance and operation of facilities used in conjunction with those services. Included are funds to operate student unions and intramural facilities, and funds that provide for student organizations, newspapers, yearbooks, and entertainment programs. Adjustments in fees are requested at fourteen campuses to provide for program expansion and to finance the rising costs of providing the current level of services. Security measures have been improved at many campuses during student events and operating funds have been proposed for new or expanded student unions and other recreational facilities.

NCA&T requests a \$30 increase to expand campus multicultural and diversity initiatives. The funding would also enhance programming for the Memorial Union, SGA, lyceum and intramural sports. NCSU recommended a \$2.70 decrease as a result of efficiencies in recreational sports, student center operations and the student affairs reserve. At UNC Greensboro, the \$23 increase provides for additional staffing with the Office of Leadership and Service Learning and funds operating and maintenance of student facilities. UNC Wilmington recommended a \$12.50 decrease as a result of elimination of the university support for bank service charges. UNCW will impose a 2.75% user fee for any student who chooses to use credit cards to make tuition and fee payments.

The proposed Student Activities Fees effective Fall Term 2010 are listed below.

#### Educational and Technology Fees

Educational and Technology Fees were instituted as a result of the study of student fees conducted by the Board of Governors in 1992-93 and adopted in May 1993. The fees provide for specialized instructional supplies and services and for scientific and information technology equipment. Increases in fees are requested at fourteen campuses to provide for program expansion and to meet the rising costs of providing the current level of services.

East Carolina University proposes a \$40.00 increase to enhance student support services with a learning management system, a synchronous learning system, a resume portfolio system, smart classrooms, computer laboratories, a virtual computing laboratory and various software programs. UNC Asheville proposes a \$36 increase for additional educational materials, specialized instructional supplies, scientific and computer processing equipment and expansion of the campus wireless network. At UNC Charlotte, the \$34 increase supports improvements to the stability of the campus network systems, equipment and technology needs for labs and classrooms and expansion of the wireless network. The \$45 increase proposed at the UNC School of the Arts supports the upgrade to the One Card System, including new network and electrical connections, new exit devices, new power booster and electrical strikes. Winston-Salem State University's \$25 increase would fund two additional technology support positions and replacement equipment for classrooms and laboratories.

As additional information, it is noted that several institutions have a requirement that some or all students purchase computers. At UNC-Chapel Hill, Western Carolina University, and Winston-Salem State University, all students are required to purchase their own computers. Information regarding these initiatives is available on the campus websites. East Carolina University, North Carolina State University, UNC Charlotte, and UNC School of the Arts do not require all students to purchase computers; however, some disciplines within these schools do have computer requirements for particular students.

#### Indebtedness Fees

Under the policy for the establishment of fees adopted by the Board of Governors in 1993 and revised in 2003, fees for the retirement of indebtedness are approved at the time a project is approved and established at the time that debt is incurred. Indebtedness fees, once established, remain in effect until the debt is retired.

ASU requests a \$100 increase to fund additional facilities in the Plemmon Student Union that will offer experimental and academic leaning experiences. Five existing Academic Affairs and Student Development departments will be co-located in the new addition. At NCSU, an increase of \$83 supports renovation of the existing Talley Facility plus expansion of the facility and renovation of the atrium court. NCSU's Board of Trustees plans to increase this new debt service fee for the Talley facility over a four-year period to a total of \$290.

The net \$27.35 increase at UNC-CH supports an \$18.10 increase in the Student Dining debt fee for additional floor space to the northeast fining room in Lenoir Hall and the addition of dining space in the Student Union. The \$16.75 increase in the Recreation Center and Union Debt fee will provide funding for updates to the Carolina Union. The \$7.50 decrease in the Rams Head Recreation Center fee resulted when the fee revenue realigned with the debt service—there is currently a higher student population compared to when the fee was originally instituted.

At UNC Charlotte, a new \$120 debt service fee is requested to fund permanent football stadium and field house, athletic offices, locker rooms and restrooms. UNCC's Board of Trustees has approved the establishment of a football program, including a projected \$50 a year increase for four years in the athletics fee to a total of \$200. UNC Wilmington's debt service fee is reduced \$20 as a result of retirement in P.E. Facilities bond debt in January 2010. WCU requests a \$13 reduction as a result of retirement of a portion of the University Center revenue bonds.

## Special Fees

Special Fees provide funds for specific needs that are not financed from other revenue sources. Except for the fees for administrative computing (charged to all students), special fees are charged *only* to students that participate in programs or activities financed from those fees. These are programs that have specialized instructional needs, e.g., programs in health affairs, law, business, engineering, and architecture. These needs are expensive and occur in curriculums where students must obtain a "competitive edge" to acquire highly desirable jobs upon graduation. In addition to the special fees listed below, all UNC students are charged \$1.00 per year for the Association of Student Governments Fee. There are no special fee increases recommended for fiscal year 2010-11.
