Campus Liaison Assignments / Responsibilities

Beginning in August 2009 and continuing throughout this reporting period, the Committee focused on defining campus liaison responsibilities which included the adoption of a form to be used in the trustee selection process. The committee underscored the notion that the form was to be officially signed by the chancellor/board chairman. The form can also be used for others who wish to make a nomination.

<u>Appeals</u>

In November 2009, the Committee received background information regarding the appeal of a student at North Carolina State University. The Board of Governors approved the Committee's recommendation that the campus decision be affirmed.

Also in November the Committee received background information regarding the appeal of a student at Winston-Salem State University. The Board of Governors approved the Committee's recommendation that the campus decision be affirmed.

Executive Orders

In January 2010, and then again in February, General Counsel Luger briefed the Committee on the three recent Executive Orders issued by Governor Perdue. She

focused on Executive Order Number 34 which addresses ethics and attendance standards for gubernatorial appointees to boards.

Litigation Requests / Settlements

In February 2010, General Counsel Luger reported on the settlement, in principle, of the case of T. J. Bryan v. the University of North Carolina and Fayetteville State University. Under its authority delegated in 1998, the Committee approved the settlement recommended by counsel.

In April 2010, General Counsel Luger reported on the settlement, in the case of Jane Helm v. Appalachian State University and Chancellor Peacock. Under its authority delegated in 1998, the Committee approved the settlement recommended by counsel.

In August 2010, the Committee approved the request from NC State University to initiate a law suit in the name of the University of North Carolina, on behalf of NC State University, against Wolfpack Auto Sales, Inc. Under its authority delegated in 1998, the Committee approved the request to file a Lanham Act complaint in federal court to enjoin Wolfpack Auto's unauthorized use of the mark, as recommended by counsel.

Department of Defense Classified Research

The accreditation process for the University of North Carolina at Charlotte Closed Facility to meet the requirements of the National Industrial Security Program Operations Manual under which the campus will be conducting research involving Department of Defense classified information requires the Board of Governors to pass a resolution naming those members of the Board who will not have access to the information and therefore not be required to have personal security clearances. The Board of Governors approved the required resolution in August 2010.

UNC Health Care System

In September 2010, the Committee received President Bowles' appointments of William Cameron of Wilmington, Rev. Lisa Fischbeck of Carrboro, Ernest J. Goodson of Fayetteville, and Barbara Jessie-Black of Carrboro to serve as members of the UNC Health Care System Board of Directors. The Board of Governors approved the Committee's recommendation to ratify each of these appointments.

UNC-Chapel Hill Athletics Update

In October 2010, the Committee received a report from Chancellor Holden Thorp on the UNC-Chapel Hill athletics update. Director of Athletics Richard Baddour, Leslie Strohm, Vice Chancellor and General Counsel, and Winston Crisp, Vice Chancellor for Student Affairs were available to respond to questions. The Athletics Update will be a standing Governance agenda item for the near future.

Naming Policy

In October the Committee heard a report from James Buckner, Chairman of the UNC Asheville Board of Trustees, and former Chairman Al Whitesides, regarding the initiative to name the North Carolina Center for Health & Wellness in honor of Wilma Sherrill, a former member of the General Assembly who ended her service in 2004.

The Committee concluded that the UNC Asheville plan abides by the Board of Governors policy on honorary degrees, awards, and distinctions, and the UNCA Board of Trustees naming policy.
