Authorization of Tuition for 2011-12

The following RESOLUTION for the 2011-12 academic year reflects the tuition increases that have been proposed by the campuses. Chancellors recommended tuition rate increases consistent with the tuition and fee guidelines established by the Board of Governors at the November 2010 meeting.

RESOLUTION AUTHORIZING TUITION

WHEREAS, G.S. 116-143 requires that the Board of Governors of the University of North Carolina shall fix the tuition and fees, not inconsistent with the actions of the General Assembly, at the constituent institutions of the University.

NOW, THEREFORE, BE IT RESOLVED, that, effective with the Fall Term, 2011 the constituent institutions are authorized to charge and collect the following tuition rates.

Item 1

I. 2011-12 Tuition Rates

The tuition and fee policy of the Board of Governors provides a framework for the Board to use in reviewing and approving increases in tuition and fees on an annual basis. Additionally, in November 2010, the Board adopted a second four-year tuition plan for campuses to follow in recommending **undergraduate resident tuition and general fees rate** increases.

A. Increases in Tuition for Professional Schools

Six campuses propose tuition increases for 2011-12 at their professional schools. The rates require Board of Governors' approval.

East Carolina University

School of Medicine

\$1.000 in 2011-12

ECU requests a \$1,000 tuition increase for resident and nonresident students in the medical school. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$40) and nonresident graduate students (\$147). The additional revenue will be used to support need-based financial aid and academic support infrastructure costs.

School of Dental Medicine (new)

establish a rate of \$21,000 for 2011-12

ECU's School of Dental Medicine is a new professional school and will accept its first class of students in the fall of 2011. A tuition rate of \$21,000 (\$7,000 per trimester) is requested for resident students. Use of tuition revenue to provide financial aid (40%) will allow the School to assist students now while developing additional future revenue streams such as federal support and endowments. The remaining 60% would be used for educational operations.

North Carolina State University

Institute for Advanced Analytics

Masters of Advanced Analytics

\$4,500 for 2011-12 and 2012-13

NCSU requests multi-year tuition rate increases for the Masters of Advanced Analytics in the Institute for Advanced Analytics. The proposed increases are in addition to the campus-initiated tuition increase proposed for resident and nonresident graduate students (\$600). The tuition revenue would support need-based financial aid, student services, direct instruction (EPA faculty and outside providers). Developing the MSA was made possible through the generosity of a matching gift. The end of the program's three-year curriculum development phase was in May 2010. With the curriculum gift coming to an end, it is time for the MSA program to move to a business model based solely on tuition to sustain itself.

North Carolina State University (continued)

School of Management

Masters of Accounting \$1,250 for 2011-12, 2012-13, and 2013-14

Masters of Business Administration \$800 for 2011-12 and 2012-13; \$900 for 2013-14 Masters of Global Innovation \$800 for 2011-12 and 2012-13; \$900 for 2013-14

Masters of Supply Chain Engineering and Management (new) establish a rate of \$14,883 (residents) and \$27,416 (nonresidents) for 2011-12

\$800 for 2012-13 and \$900 for 2013-14

NCSU requests multi-year tuition rate increases for programs in the School of Management. The proposed increases for the Masters of Accounting, Masters of Business Administration, Masters of Global Innovation Management, as well as the new degree program in Supply Chain Engineering and Management are in addition to the campus-initiated tuition increase proposed for resident and nonresident graduate students (\$600). The tuition revenue would fund new teaching and research faculty positions, enhance student advising and recruitment, and provide for need-based financial aid.

School of Veterinary Medicine

DVM Candidate \$750 for 2011-12, 2012-13, 2013-14, and 2014-15

NCSU requests a \$750 increase for 2011-12, 2012-13, 2013-14, and 2014-15. The proposed increase in the School of Veterinary Medicine for the Doctor of Veterinary Medicine (DVM) is in addition to the campus-initiated tuition increase proposed for resident and nonresident graduate students (\$600). The tuition revenue would fund need-based financial aid, costs for a computer tablet initiative in the DVM curriculum, additional faculty positions, and academic support of the Teaching Animal Unit.

UNC-Chapel Hill

School of Business

Masters of Accounting \$1,450 for residents &\$2,250 for nonresidents in 2011-12 Masters of Business Administration \$1,450 for residents &\$2,250 for nonresidents in 2011-12

The UNC-CH School of Business requests \$1,450 for residents and \$2,250 for nonresidents for the MBA and MAC programs in 2011-12. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The funds would be used for student fellowships, faculty salaries, and new initiatives in the MBA and MAC programs.

School of Education

Masters of Arts in Teaching (MAT) \$1,000 for 2011-12 Masters in School Admin. (MSA) \$1,000 for 2011-12

The UNC-CH School of Education requests \$1,000 for the MAT and MSA programs in 2011-12. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The funds would support need-based financial aid, a new faculty position in instructional technology, and to partially offset the cost of a more rigorous and scientifically sound process for determining the impact of preparation in the MSA & MAT programs on classroom and school performance.

UNC-Chapel Hill (cont.)

School of Government

Masters of Public Administration (MPA) \$450 for 2011-12

The UNC-CH School of Government requests \$450 for the MPA program in 2011-12. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The funds would support need-based financial aid, additional research assistantships, and funding for adjunct faculty stipends by replacing some of the program's state appropriations reversions.

School of Information and Library Science

Masters of Science in Information Science \$1,000 for 2011-12

Masters of Science in Library Science \$1,000 for 2011-12

Certificate of Advanced Study Degree \$1,000 for 2011-12

The UNC-CH School of Information and Library requests \$1,000 for the MSIS, MSLS, and the CAS programs in 2011-12. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The funds would support need-based financial aid, a new faculty position and a student placement coordinator, seed grants for faculty research, and student research and travel.

School of Law

Juris Doctor (J.D.)

\$1,500 for 2011-12 & 2012-13

The UNC-CH School of Law requests a \$1,500 increase for the J.D. program in 2011-12 and 2012-13. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The funds would support need-based financial aid, the addition of writing instructors to develop strong legal writing skills in first-year students, and the creation of more applied and simulation-based courses.

School of Social Work

Masters of Social Work

\$1,000 for 2011-12

The UNC-CH School of Social Work requests \$1,000 for the Masters of Social Work program in 2011-12. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The funds would support need-based financial aid, faculty and staff salaries to attract and retain a strong and diverse faculty, the addition of teaching faculty, and curricular and program innovations related to cutting edge research to practice initiatives.

School of Dentistry

DDS Candidate

\$2,000 for residents & \$4,000 for nonresidents in 2011-12

\$2,000 for all students in 2012-13

UNC-CH's School of Dentistry is requesting an increase of \$2,000 for residents and \$4,000 for nonresidents in 2011-12 and \$2,000 for all students in 2012-13. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The additional revenue would support financial aid, faculty recruitment and retention, and curriculum development and delivery (instructional technology).

UNC-Chapel Hill (cont.)

School of Medicine

M.D. Candidate

\$1,000 for 2011-12 and 2012-13

UNC-CH's School of Medicine is requesting an increase of \$1,000 for all students in 2011-12 and 2012-13. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The additional revenue would support need-based financial aid, the creation of a new Hispanic student pipeline, graduate student assistantships, curriculum innovations, infrastructure improvements, and AHEC housing. For decades, UNC-CH has delivered 40% of clinical education at AHEC sites, but changing accreditation standards require the addition of new student health services in Charlotte, Asheville, and Wilmington.

UNC-CH requests an increase of \$1,100 for residents for the programs in the Department of Allied Health Sciences. This increase is in addition to the proposed campus-based tuition increase of \$414 for resident graduate students. The additional revenue generated would support need-based financial aid, faculty salaries, equipment maintenance/upgrades/replacements, plus instructional supplies and clinic-related travel.

School of Nursing

Masters of Science in Nursing (MSN) \$1,100 for 2011-12 and 2012-13

UNC-CH's School of Nursing is requesting an increase of \$1,100 for all students in 2011-12 and 2012-13. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The additional revenue would support need-based financial aid, clinical site procurement, meeting clinical agency requirements for safety and legal compliance, offering simulated learning experiences, and recruitment and retention of faculty.

School of Pharmacy

Doctor of Pharmacy (PharmD) \$591 for residents & \$1,377 for nonresidents for 2011-12 \$615 for residents & \$1.432 for nonresidents for 2012-13

UNC-CH's School of Pharmacy is requesting an increase of \$591 for residents and \$1,377 for nonresidents in 2011-12 and \$615 for residents and \$1,432 for nonresidents in 2012-13. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The additional revenue would support need-based financial aid, the addition of an information technology system administrator and a video-teleconferencing instructional technologist staff position, and consolidation of experiential sites into three major HUBs – each HUB would have a regional coordinator who would assign student pharmacy practice experiences.

Doctor of Public Health (DrPH) \$1,200 in 2011-12 Masters of Environmental Engineering (MSEE) \$1,200 in 2011-12

Masters of Public Health (MPH) \$1,000 for 2011-12 & \$200 in 2012-13

Masters of Science in Public Health (MSPH), \$1,000 for 2011-12 & \$200 in 2012-13

Masters in Health Administration (MHA) \$1,000 for 2011-12 & \$200 in 2012-13

UNC-CH's School of Public Health is requesting an increase of \$1,200 for all students in 2011-12 for the DrPH and MSEE programs. An increase of \$1,000 for all students in 2011-12 and \$200 in 2012-13 is also requested for the MPH, MSPH, and MHA programs. This increase is in addition to the campus-initiated tuition increase proposed for resident graduate students (\$414) and nonresident graduate students (\$1,371). The additional revenue would support need-based financial aid, and reduction of faculty salary disparities with ASPH 50th benchmarks.

UNC Charlotte

Masters of Architecture \$815 for 2011-12 Masters of Urban Design \$815 for 2011-12

The School of Architecture at UNC Charlotte requests an \$815 tuition increase for all students in the Masters of Architecture and Masters of Urban Design programs. This increase is in addition to the proposed campus-based tuition increase of \$225 for resident graduate students and \$929 for nonresident graduate students. Funding would support need-based financial aid, expansion of student services, professional development support and resources for students, enhancement of faculty development, and would supplement wages of professionals serving as adjunct faculty.

Masters of Health Administration \$615 for 2011-12

The College of Health and Human Services at UNC Charlotte requests a \$615 increase for all students in the Masters of Health Administration for 2011-12. This increase is in addition to the proposed campus-based tuition increase of \$225 for resident graduate students and \$929 for nonresident graduate students. Funding would support need-based financial aid, expansion of student services, enhancement of program administrative support, professional development support and resources for students, and enhancement of course offerings currently available to students by professionals serving as adjunct faculty.

UNC Greensboro

Masters of Science in Accounting	\$1,200 in 2011-12

Masters of Science in Information

Technology and Management \$1,200 in 2011-12

UNC Greensboro requests a \$1,200 increase for all students in the Masters of Science in Accounting, Masters of Business Administration, and Masters of Science in Information Technology and Management programs. This increase is in addition to the proposed campus-based tuition increase of \$242 for resident graduate students and \$988 for nonresident graduate students. Funding would cover crucial academic support and staffing needs. Sustaining these services for students is increasingly expensive and time consuming.

Western Carolina University

College of Health & Human Sciences

Certified Registered Nurse Anesthetist \$1,256.20 for residents & \$826.20 for nonresidents in 2011-12

WCU's original request submitted in 2007-08 was to increase tuition by \$4,800 per year. The Board recommended the increase be implemented over three years and approved a \$1,500 increase in 2007-08. WCU submitted a \$1,500 increase request for 2008-09--the Board approved only a \$1,000 increase in tuition for 2008-09. In 2009-10, WCU submitted a \$1,000 increase request but withdrew the request during discussions with the Board of Governors. In 2010-11, WCU requested an increase of \$1,258 for residents and nonresidents. The Board approved GA's recommendation of a reduced increase of \$397 for residents. For 2011-12, WCU requests an increase of \$1,256.20 for residents and \$826.20 for nonresidents to move closer to the \$4,800 differential. The funds would support an additional faculty position, faculty salaries (currently WCU's nurse anesthesia faculty are \$10,000 to \$15,000 below the national mean), student and faculty travel, and operating costs associated with program delivery and equipment.

Doctor of Physical Therapy

\$670 for residents & \$2,587 for nonresidents in 2011-12

WCU requests a \$670 increase for resident students and \$2,587 for nonresident students in 2011-12 in the Doctor of Physical Therapy program. This increase is in addition to the proposed campus-based tuition increase of \$204.20. The tuition revenue generated would cover the cost of adjunct faculty to teach specialty content units within the curriculum (e.g., wound care, women's health, etc.), supplies, equipment maintenance, and clinical travel. Transitioning to a doctoral program will expand the total credit hours from 78 to 107, which will necessitate hiring three additional faculty members, including a cardiopulmonary specialist.

II. Special Tuition Rates

A. Nonresident Undergraduate Students

Consistent with the General Statutes and by authorization of the Board of Governors through a resolution passed by the Board in 1983, the campuses are authorized to charge special tuition rates for nonresident undergraduate students.

To qualify for the special rate, a student must have a special talent in academics and the performing arts. For these students, the nonresident tuition rate is reduced by either \$834 or \$950 depending on the Carnegie classification of the institution in 1983. At the time, these amounts approximated half of the nonresident tuition charged to students but do not nearly have the same impact today. Appropriations were made by the legislature to each campus to offset the cost of the tuition waiver.

Effective with the Fall Term of 2011, the special tuition rates for qualifying nonresident undergraduates are shown on the following page. The new rates reflect the tuition increases proposed in Section I.

B. Nonresident Graduate Students

Consistent with the General Statutes and by authorization of the Board of Governors through a resolution passed by the Board in 1983, the campuses are authorized to charge special tuition rates for nonresident graduate students.

For nonresident graduate students that are awarded a graduate teaching or research assistantship and who are paid a stipend of at least \$2,000 per academic year, the institution may award tuition remission to reduce the nonresident tuition rate to the in-state rate. For an example, the nonresident graduate student tuition rate is proposed to increase from \$14,518.74 to \$15,462.74 at ASU. ASU graduate nonresident students that are eligible to receive tuition remission will be charged the resident tuition rate, which is proposed to increase from \$3,427.74 to \$3,650.74 for the 2011-12 academic year.

Each campus has a state budget for graduate tuition remissions and some campuses supplement state funds from non-state sources. Institutions may not provide graduate tuition remissions to all students. The number of awards is limited to those that meet the criteria and the budget availability.

Effective with the Fall Term of 2011, the special tuition rates for qualifying nonresident graduates are shown on the following two pages. The new rates reflect the tuition increases proposed in Section I.

III. Tuition for Students Enrolled in Degree-Credit Distance Education Courses

Distance education students are charged on a per-credit-hour basis, rather than a "stair-step" methodology charged to regular-term students. The Distance Education per-credit-hour tuition rate is derived by dividing regular term tuition costs by 29.6 for undergraduates and 20.4 for graduate students. Since distance education students are not charged athletic, health, and student activity fees, the cost of education is considerably lower than students that are taking courses using face-to-face instruction.

It is proposed that, effective with the fall semester 2011, resident students and nonresident students taking courses within North Carolina that are enrolled in distance education courses be charged the regular-term tuition rates established in Section I. It is further proposed that tuition rates for these students be implemented on a per-credit-hour basis and that the charge per credit hour be calculated as follows:

- For undergraduate courses, the rate per student credit hour would be the annual rate divided by 29.6 hours.
- For graduate courses, the rate per student credit hour would be the annual rate divided by 20.4 hours.

It is further proposed that the Board delegate to the President the authority to set tuition rates for nonresident students taking courses outside North Carolina. These are students who primarily take courses via the Internet.
