THE DISTINGUISHED PROFESSORS ENDOWMENT TRUST FUND Report to the Board of Governors November 8, 2002

Narrative

The Distinguished Professors Endowment Trust Fund has provided significant resources for the University to strengthen its faculty over the past 17 years. The fund was established in 1985 by special legislation to enable each University to receive and match challenge grants to create endowments for selected distinguished professors. In October of that year the Board of Governors adopted rules and regulations for the operation of the fund.

The legislation provided for two levels of matching grants for endowed professorships: grants of \$167,000 to match private gifts in the amount of \$333,000 to establish \$500,000 endowments; and grants of \$334,000 to match private gifts of \$666,000 to establish \$1,000,000 endowments. The legislation also authorizes placing matching funds in escrow once certain conditions are met. Once state funds are placed in escrow, the full amounts of private funds must be collected within five years. Only the net income from established endowments can be expended in support of the professorships.

The initial appropriation was for \$2,000,000 for each year of the 1985-87 biennium. Subsequent biennial appropriations have varied. For the 2002-03 fiscal year, the continuation budget will provide \$2,000,000. Overall, appropriations and interest earnings have provided \$43,969,289 for the Trust Fund.

These state funds have been used to leverage substantial gifts from private individuals and foundations. The most generous response has been that of the C. D. Spangler Foundation, Inc. in Charlotte. Over the past decade, the Spangler Foundation has provided, alone or with private donors, the full endowment for at least one new professorship at each of the 16 UNC institutions and, combined with a five-year challenge grant program which the Foundation announced in 1997, partial funding for one or more distinguished professorships at 14 of the 16 campuses. That challenge grant program expired this year, but overall, the Foundation has contributed more than \$10 million toward the creation of 38 distinguished professorships within the University.

The extraordinary generosity of the Spangler family has been crucial in improving the quality of University faculty, in providing sufficient private funds to qualify for the state matching money, and in persuading the General Assembly to continue appropriations for the Distinguished Professors Endowment Trust Fund. Moreover, these professorships have honored notable North Carolinians who have given unselfishly of themselves and their means to the state and the University.

Other families and foundations have also responded to this initiative. As of September 20, 2002, \$41,917,000 from appropriations and interest has been paid to the institutions or placed in escrow to match private gifts and pledges of \$83,583,000 for the creation of 192 endowed professorships totaling \$125,500,000.

In 188 instances, the full private contribution has been received and matching grants have been paid from the Trust Fund to the institutions. Fifty-eight of the 188 were grants of \$334,000 for \$1,000,000 endowments, and 130 were grants of \$167,000 for \$500,000 endowments. In four other instances, the conditions were met for funds to be placed in

escrow. One of these was for a \$1,000,000 endowment and three were for \$500,000 endowments. That kind of return on the State's investment is truly significant.

The Distinguished Professors Endowment Trust Fund initiative has enabled the University to be far more competitive than it would otherwise be in the recruitment and retention of highly qualified faculty. The growing competition for faculty combined with the remarkable response from private donors in support of these distinguished professorships makes the need for additional appropriations more critical every year. Yet, in most recent years, appropriations have not been sufficient to meet the extraordinary private sector commitments.

There is a pressing need for additional state matching funds. As of September 20, 2002, an unprecedented number of professorships for which private gifts have been received were awaiting the promised state match. A total of 34 professorships were in the queue pending funding. Twenty-one of these were for \$334,000 for \$1,000,000 endowments, and 13 were for \$167,000 for \$500,000 endowments. The state match required for these 34 qualifying professorships in the queue is \$9,185,000. After deducting the available continuation appropriation of \$2,000,000 and accumulated interest of \$52,289, the current shortfall is \$7,132,711 – with three-quarters of the fiscal year remaining.

When the continuing appropriation for 2002-03 is allotted by the State Budget Office to the University, that money and accumulated interest will be used to provide the requisite State match for eight additional distinguished professorships, four for \$167,000 each for \$500,000 endowments, and four for \$334,000 each for \$1,000,000 endowments. This will reduce the number in the queue to 26 and will bring to 200 the number of endowed professorships created through the Distinguished Professors Endowment Trust Fund.

If the cumulative backlog of unmet needs continues to mount, however, and the University has to postpone indefinitely the creation of endowed chairs for which private donors have made good faith commitments, such giving will be discouraged and diminished. If the current continuing annual level of \$2,000,000 is not augmented with additional appropriations, the University will fall two, three, or more years behind in matching the generous gifts of individuals and organizations all over the state.

In order to keep faith with these citizens and to provide funding on a current basis, the Board of Governors will request an additional \$19,750,000 over the 2003-05 biennium beyond the current continuing level of \$2,000,000 to fund the backlog and meet projected matching needs.
