

Authorization of Tuition for 2012-13

The following RESOLUTION for the 2012-13 and 2013-14 academic years reflects the tuition increases recommended by the President after his careful review of campus tuition proposals. The Chancellors and their Boards of Trustees requested tuition rate increases consistent with the tuition and fee guidelines (Second Four-Year Tuition Plan) established by the Board of Governors at its November 2010 meeting and with the tuition and fee instructions memorandum mailed to the Chancellors in October 2011. The following recommendations are in keeping with the three broad parameters outlined by the President at the Board's January policy discussion: for in-state undergraduates, combined increases in tuition and required fees would be below 10% on every campus; the system-wide average increase in tuition and fees for 2012-13 would be less than the overall 9.3% increase approved last year; and the system-wide average increase in tuition and fees would be less than \$250/semester in 2012-13 and the tuition increases would average less than \$125/semester in 2013-14.

Several campuses submitted tuition increase proposals for the next five years. Given the uncertainty in our economy and state resources and our continuing focus on achieving increased efficiencies and cost savings in all University operations, this proposal recommends increases in certain fees and all undergraduate, graduate, and professional tuition rates for resident and nonresident students for 2012-13, and increases in undergraduate resident tuition rates only for 2013-14. Any fee increases, along with any tuition increases for nonresident undergraduates and resident and nonresident students in graduate and professional programs, for 2013-14 will be set by the Board of Governors in February 2013. Campuses that can demonstrate substantial need and a change in circumstances may also seek increases in resident tuition for 2013-14. Total increases in tuition and fees for 2013-14 would need to fully comply with the four-year tuition plan currently in effect.

RESOLUTION AUTHORIZING TUITION

WHEREAS, G.S. 116-143 requires that the Board of Governors of the University of North Carolina shall fix the tuition and fees, not inconsistent with the actions of the General Assembly, at the constituent institutions of the University.

NOW, THEREFORE, BE IT RESOLVED, that, effective with the Fall Term, 2012 the constituent institutions are authorized to charge and collect the following tuition rates.

2012-13 Tuition Rates

The tuition and fee policy of the Board of Governors provides a framework for the Board to use in reviewing and approving increases in tuition and fees on an annual basis. Additionally, in November 2010, the Board adopted a second four-year tuition plan for campuses to follow in recommending undergraduate resident and nonresident tuition and required fee rate increases. In applying the second four-year plan, the President based the peer analysis on “quartiles” rather than “quarters,” as agreed to by the Board at its policy discussion in January 2012.

In addition to the regular campus-initiated increases, many campuses proposed multi-year increases to allow for improved planning and budgeting and to help address academic quality, to partially remedy the cumulative negative impact of several years of state budget reductions, and to help the University protect the quality of a UNC education. Consistent with the Board of Governors “Second Four-Year Tuition Plan” and legislative budget provisions, each campus must “set aside at least 25% of the new tuition revenues to be used for need-based financial aid.”

In recommending the tuition increases contained in this resolution, the President recognizes the need to expand further upon the operational and academic efficiencies previously implemented and currently being implemented within the University. During the 2012 calendar year, the President commits to dedicate the resources needed to ensure that the University achieves greater operational and academic efficiencies and that the State’s investment in the University is maximized. Greater use of technology and increased use of online resources will be key strategies in ensuring academic efficiency.

Additionally, the President acknowledges the current discussion among members of the Board on the appropriate amount of tuition revenues to be set aside to provide financial aid for needy students and commits to lead a conversation with the Board on this topic. Recommendations regarding further operational and academic efficiencies, more effective and efficient uses of technology, and financial aid will be made to the Board within a time frame that will allow for any policy changes to be incorporated into the tuition and fee discussions for 2013-14.

The 2012-13 tuition amounts are shown on pages 11 through 13. The 2013-14 tuition recommendations are shown in the table below, and all require Board approval. Campuses will not be prohibited from submitting tuition increase requests based on substantial need and a change in circumstances for consideration by the BOG in February 2013, pursuant to the policies and procedures of the University.

B. Increases in Tuition for Professional Schools

Seven campuses proposed tuition increases for 2012-13 at their professional schools. The rates require Board of Governors' approval.

East Carolina University

School of Medicine \$1,500 in 2012-13

ECU requests a \$1,500 tuition increase for resident and nonresident students in the medical school. This increase is in addition to the tuition rate increase proposed for resident graduate students (\$452) and nonresident graduate students (\$1,489). The additional revenue will be used to support need-based financial aid, salary support for faculty and staff and increased educational costs.

School of Dental Medicine \$1,365 in 2012-13

ECU requests a \$1,365 tuition increase for resident students in the dental school. This increase is in addition to the tuition rate increase proposed for resident graduate students (\$452). The additional revenue will be used to support need-based financial aid, merit-based aid, salary support for faculty and staff and increased educational costs.

North Carolina Central University

School of Business
Masters of Business Administration \$800 in 2012-13

NCCU requests tuition increases for the Master of Business Administration in the School of Business. The proposed increase is in addition to the tuition rate increase proposed for all graduate students (\$342). The tuition revenue would support need-based financial aid, provide expanded course offerings, professional development support, improve marketing the program to recruit high quality students and enhance classroom technology.

The tuition revenue would be used for student fellowships, faculty support, and program and staff support.

This increase is in addition to the tuition rate increase proposed for resident graduate students (\$1,057) and nonresident graduate students (\$1,460). The funds would support need-based financial aid and student internship expenses.

UNC-CH requests tuition increases in the School of Information and Library Science. The MSIS and MSLS programs are requesting increases of \$500 in 2012-13. In addition, the CAS program is requesting an increase of \$3,000 for 2012-13. These increases are in addition to the tuition rate increases proposed for resident graduate students (\$1,057) and nonresident graduate students (\$1,460). Tuition revenues generated from the increase in the MSLS and MSIS programs would support need-based financial aid, add a new lecturer or adjunct position each year to reduce class size averages and support student and faculty research. Like the MSLS and MSIS programs, the CAS program will use tuition revenues to provide need-based financial aid. Additionally, adjunct-taught sessions will be added in specialized areas such as health informatics, financial analytics, and digital curation, and recruiting efforts will be enhanced to attract professionals in North Carolina and the region to the CAS program.

UNC-CH requests tuition increases in the School of Social Work. The Master of Social Work program requests a \$500 increase in 2012-13. This increase is in addition to the tuition rate increase proposed for resident graduate students (\$1,057) and nonresident graduate students (\$1,460). The funds would support need-based financial aid, improve faculty and staff salaries, hire additional teaching faculty, fund curricular innovations and provide faculty and field instructor development.

UNC-CH requests tuition increases in the School of Medicine/Allied Health Services. An increase of \$750 for residents and nonresidents is being requested for the programs listed above for 2012-13. This increase is in addition to the proposed tuition rate increase of \$1,057 for resident graduate students and \$1,460 for nonresident graduate students. The additional revenue generated would support need-based financial aid, hire additional faculty and bring current faculty salaries up to more competitive levels, provide new clinical equipment as well as equipment maintenance and calibration of diagnostic equipment and to purchase disposable clinical supplies.

UNC-CH's School of Nursing is requesting a tuition increase for all students. An increase of \$1,100 for all students is proposed for 2012-13. This increase is in addition to the tuition rate increase proposed for resident graduate students (\$1,057) and nonresident graduate students (\$1,460). The additional revenue would support need-based financial aid and recoup some of the costs of offering graduate clinical programs such as clinical site placements, meeting clinical agency requirements for safety and legal compliance, maintaining a high fidelity simulated learning laboratory, and recruiting and retaining faculty to teach in the graduate clinical programs.

UNC-CH's School of Pharmacy is requesting an increase of \$650 for residents and \$1,546 for nonresidents in 2012-13. This increase is in addition to the tuition rate increase proposed for resident graduate students (\$1,057) and nonresident graduate students (\$1,460). The additional revenue would support need-based financial aid and provide resources needed to offer quality pharmacy practice experiences (clerkships) for students in the experimental education program.

An increase of \$550 for all students in 2012-13 is also requested for the MPH, MSPH, and MHA programs. These increases are in addition to the tuition rate increases proposed for resident graduate students (\$1,057) and nonresident graduate students (\$1,460). The additional revenue would support need-based financial aid and provide for academic infrastructure and support to address faculty salary inequities. In addition, funds would be provided for classroom supplies and SPA support staff that directly aid in meeting the teaching mission.

UNC Charlotte requests the establishment of a tuition rate of \$8,929 for residents and \$21,216 for nonresidents in its new MS in Real Estate program for 2012-13. In addition, UNCC requests an increase in tuition of \$5,000 for all students in its Real Estate & Financial Development Certificate Program and the MBA Plus Certificate Program. This increase is in addition to the tuition rate increases proposed for resident graduate students (\$240) and nonresident graduate students (\$990). The rate establishment for the MS in Real Estate and tuition increase in the Certificate programs will bring tuition in line with current charges for Belk College Master's level programs. Funds provided by the tuition increase will be utilized to expand student services, strengthen student recruitment, enhance information technology, provide career and professional development support and resources, increase diversity, provide student financial assistance, enhance faculty development and supplement wages of adjunct faculty according to their qualifications.

UNC Greensboro requests increases as noted above for programs within the Bryan School of Business and Economics. These increases are in addition to the proposed tuition rate increases of \$397 for resident graduate students and \$1,620 for nonresident graduate students. For all programs, funding from new tuition revenues would be used to support need-based financial aid. Additionally, new revenues from the tuition increase in the Master of Arts in Applied Economics would be used to enhance recruitment efforts to create more awareness of the program at NC colleges and universities, offer career counseling and placement services and fund program development and support. The funding increase in the MSA program will provide enhanced student services and improve the quality of the program by sustaining and expanding the Graduate Accounting Office for professional relations and student affairs, offer courses to help students be successful on the CPA exam, and provide additional scholarships and graduate assistantships. The MBA program will use additional tuition revenues to provide support positions including a Program Director, MBA Career Services Office, and MBA Recruitment Office. Funding will also be used to support faculty development and on-line and specialized courses. The MSITM program will use additional tuition revenues to provide staff and technical support for administration of the

program which is completely on-line, offer electives for students during the summer to ensure continued technical competence and time to graduation and enhance recruiting efforts. To promote enhanced recruitment efforts, the CARS M.S. program will offer graduate assistantships with additional tuition revenue. In addition, funds will be provided to support faculty efforts to keep the program content up-to-date through course release time.

Proposed increases for professional schools may also include the requested campus-based increase for resident & nonresident grad students and any previously approved increases.

II. Special Tuition Rates

Nonresident Graduate Students

Consistent with the General Statutes and by authorization of the Board of Governors through a resolution passed by the Board in 1983, the campuses are authorized to charge special tuition rates for nonresident graduate students.

For nonresident graduate students that are awarded a graduate teaching or research assistantship and who are paid a stipend of at least \$2,000 per academic year, the institution may award tuition remission to reduce the nonresident tuition rate to the in-state rate. For an example, the nonresident graduate student tuition rate is proposed to increase from \$15,462.74 to \$15,852.00 at ASU. ASU graduate nonresident students that are eligible to receive tuition remission will be charged the resident tuition rate, which is proposed to increase from \$3,650.74 to \$4,040.00 for the 2012-13 academic year.

Each campus has a state budget for graduate tuition remissions and some campuses supplement state funds from non-state sources. Institutions may not provide graduate tuition remissions to all students. The number of awards is limited to those that meet the criteria and the budget availability.

Effective with the Fall Term of 2012, the special tuition rates for qualifying nonresident graduates are shown on the following two pages. The new rates reflect the tuition increases proposed in Section I.

Note: The 2011 General Assembly eliminated state appropriations for nonresident undergraduate tuition waivers that had been in place since 1983 [Sec. 9.13(b) of S.L. 2011-145].

III. Tuition for Students Enrolled in Degree-Credit Distance Education Courses

Distance education students are charged on a per-credit-hour basis, rather than a “stair-step” methodology charged to regular-term students. The Distance Education per-credit-hour tuition rate is derived by dividing regular term tuition costs by 29.6 for undergraduates and 20.4 for graduate students. Since distance education students are not charged athletic, health, and student activity fees, the cost of education is considerably lower than students that are taking courses using face-to-face instruction.

It is proposed that, effective with the fall semester 2012, resident students and nonresident students taking courses within North Carolina that are enrolled in distance education courses be charged the regular-term tuition rates established in Section I. It is further proposed that tuition rates for these students be implemented on a per-credit-hour basis and that the charge per credit hour be calculated as follows:

- For undergraduate courses, the rate per student credit hour would be the annual rate divided by 29.6 hours.
- For graduate courses, the rate per student credit hour would be the annual rate divided by 20.4 hours.

It is further proposed that the Board delegate to the President the authority to set tuition rates for nonresident students taking courses outside North Carolina. These are students who primarily take courses via the Internet.
