UNC Health Care System

In September 2007, the Committee received President Bowles' appointments of Don Curtis, Lillian Lee, D. Jordan Whichard III, and Richard Williams to serve on the UNC Health Care System Board of Directors. The Board of Governors approved the Committee's recommendation to ratify each of these appointments.

<u>Appeals</u>

In January 2007, the Committee received background information regarding the appeal of a student at North Carolina State University. The Board of Governors approved the Committee's recommendation to sustain the decision of the NCSU Board of Trustees for expulsion.

In March, the Committee received background information regarding the appeal of an employee at the North Carolina School of the Arts. The Board of Governors approved the Committee's recommendation to sustain the decision of Chancellor Mauceri for discharge.

<u>Litigation Requests / Settlements</u>

In May 2007, the Committee approved the request of North Carolina A&T State University to settle litigation titled *Googerdy v. NCA&T*.

In June, the Committee approved the request of East Carolina University to settle litigations titled *Swart v. ECU*.

Political Activities of University Employees

In November 2006, the Committee considered the petition of Visiting Professor Rick Glazier of Fayetteville State University requesting to continue to serve as a member of the North Carolina General Assembly during the Spring Semester 2007. Further, he requested a partial leave of absence with a corresponding reduction in pay during this period. The Committee approved the petition and recommended such action to the Board of Governors for approval. The Board of Governors approved the request.

North Carolina School of Science and Mathematics Code and Policy Changes

As a result of legislation enacted in 2006, the North Carolina School of Science and Mathematics became a constituent high school of the University effective July 1, 2007. This action prompted review of *The Code* and policies related to this change. In March 2007, the Committee approved numerous changes to *The Code* and applicable policies. The Board of Governors approved these changes at its May meeting.

Amendments to *The Code*

In May 2007, the Committee recommended adoption of proposed changes to *The Code* that move the responsibility for review of appeals from non-faculty employees who are exempt from the State Personnel Act from the Committee on University Governance to the Committee on Personnel and Tenure. The Board of Governors approved these amendments in June.

Policy Changes

In October 2007, the Committee recommended approval of proposed amendments to the policy regarding *Dual Memberships and Conflicts of Interest*. The effective change would be to eliminate the duplication between the Statement of Economic Interest required by the State Ethics Act and the Disclosure of Substantial Interests required by the policy. These amendments to Policy 200.1, *Dual Memberships and Conflicts of Interest*, will be considered by the Board of Governors at its November meeting.

Department of Defense Classified Research

The accreditation process for the University of North Carolina at Charlotte Closed Facility to meet the requirements of the National Industrial Security Program Operations Manual under which the campus will be conducting research involving Department of Defense classified information requires the Board of Governors to pass a resolution naming those members of the Board who will not have access to the information and will, therefore not be required to have personal security clearances. The Board of Governors approved the required resolution in September 2007.

Governance Issues

In November 2006, the Committee recommended approval of changes to the resolution that established the North Carolina Center for the Advancement and Teaching and its by-laws brought forward as a result of recent legislation that altered the Center's governance structure. The Board of Governors approved these changes at its November meeting.

Resolution of Potential Conflict of Interest

In June 2007, the Committee approved a request from the Kenan-Flagler Business School at the University of North Carolina at Chapel Hill to waive the \$10,000 compensation threshold of Policy 200.1, *Dual Memberships and Conflicts of Interest* for Tamara Barringer, an adjunct professor and spouse of a Board of Governors member.

Other Committee Action

At several meetings, the Committee encouraged members to visit the campuses and emphasized their attendance at meetings of the institutional boards of trustees. This initiative includes attendance at campus winter and spring commencements.
