COMMITTEE ON PERSONNEL AND TENURE

Annual Report
July 1, 2007- June 30, 2008

The major responsibilities of the Committee on Personnel and Tenure, as established by Section 301D of The Code of the Board of Governors are: (1) to make recommendations to the Board on all personnel actions under the jurisdiction of the Board, including conferral of permanent tenure, appointment of senior academic and administrative officers for those campuses without “*management flexibility to appoint and fix compensation,*” establishing and approving faculty and administrative salary ranges, and approving salary increases of 15% or greater AND \$10,000 or more; (2) to review The Code and institutional policies and regulations regarding tenure and dismissal; (3) to review appeals from faculty members that involve questions of tenure; and (4) to act on other personnel matters that involve significant policy considerations.

Pursuant to Policy 200.6, adopted on November 13, 2006 and effective as of January 1, 2007 and amended June 8, 2007, the Board of Governors has delegated the authority to the President of the University to:

- a) Appoint and set the salaries of Senior Academic and Administrative Officers (§300.1.1 and §600.3.4) and other employees exempt from the State Personnel Act (§300.2.1) serving within the UNC General Administration.
- b) Set salary ranges for Senior Academic and Administrative Officers of the constituent institutions of University (§600.3.4).
- c) Approve conferrals of tenure and to set salaries of faculty, Senior Academic and Administrative Officers, except the chancellors, and other

employees exempt from the State Personnel Act at campuses that do not have Management Flexibility to Appoint and Fix Compensation as long as those salaries are within the established salary ranges and are not raises in excess of 15% and \$10,000 higher than the salary in effect at the end of the last fiscal year. (§300.1.1 and 600.3.4; Code §602).

d) Approve all actions relating to the administration of the Optional Retirement Program (G.S. §135-5.1) and the Phased Retirement Program (§300.7.2).

e) Approve salary increases in excess of \$10,000 and 15% or more for faculty members who are receiving salary increases funded through the Faculty Recruitment and Retention Fund.

Board members who served on the Committee during the fiscal year July 1, 2007, through June 30, 2008 were: Ms. Hannah D. Gage, Mr. H. Frank Grainger, Mr. Peter D. Hans, Dr. Laura W. Buffaloe, Mrs. Clarice Goodyear, Mr. Fred G. Mills and Dr. Priscilla P. Taylor. In August 2007, the Committee elected as its officers, Ms. Hannah D. Gage as Chair, Mr. H. Frank Grainger as Vice Chair, and Mr. Peter D. Hans as Secretary.

In its designated role, the Committee on Personnel and Tenure reviews appointments of distinguished faculty for consideration and approval by the Board of Governors and salary increases in excess of \$10,000 and 15% or more, or salaries that exceed the established range. Included in the personnel actions were three appointments of distinguished faculty under the guidelines of the Board's Distinguished Professors Endowment Trust Fund recommended (a report of the fund is attached to this report.)

Annually, on recommendation of the President, the Committee considers and further recommends to the Board, salary ranges and specific salaries for chancellors of the constituent institutions. The structure and policy governing these ranges and levels embody three principal characteristics: (1) they are to be internally equitable and fair; (2) they are to be externally competitive; and (3) they are to be applied consistently. Actions by the 2008 Session of the North Carolina General Assembly included a pool of funds equal to annual salary increase 3% for EPA non-faculty. Remaining funds and campus-initiated tuition increases or other funds were used for salary increases for market, merit, and equity.

Salary recommendations for chancellors during 2007-2008 were in keeping with the goal adopted that chancellors' salaries and the salary of the president be at the 25th percentile at minimum, subject to availability of funds and performance reviews, chancellors received salary increases that brought some salaries closer to the 25th percentile, with those chancellors who were newly appointed at North Carolina Central University, North Carolina A&T State University, and Winston-Salem State University, receiving a mid-year salary adjustment of 4%.

Subcommittees convened for additional meetings to receive, review, and recommend seven faculty appeals from constituent institutions for Board consideration. In 2003, the Committee became responsible for coordinating the Board of Governors' Excellence in Teaching Awards program and the Committee's efforts for this year culminated in a very successful event in May of 2008, with a North Carolina School of Science and Mathematics faculty member receiving this award for the first time.

New chancellor appointments include: Dr. James A. Anderson as chancellor at Fayetteville State University, beginning on June 9, 2008, replacing T. J. Bryant who stepped down in November 2007. In addition, President Bowles reported on his recommendations for H. Holden Thorp as chancellor at the University of North Carolina at Chapel Hill, beginning on July 1, 2008, replacing James Moeser who retired in June 2008; and Linda P. Brady as chancellor at North Carolina University at Greensboro, beginning on August 1, 2008, replacing Patricia Sullivan who retired at the end of July 2008.

New Vice Chancellor positions were established in several campuses as follows: Vice Chancellor for Human Resources at Elizabeth City State University; Vice Chancellor for Information Technology at North Carolina State University; Vice President for Communications at UNC General Administration; Vice Chancellor for Human Resources at North Carolina A&T State University; Vice Chancellor and Chief of Staff at Fayetteville State University; Vice Chancellor for Strategic and Management Initiatives at Winston Salem State University; Vice Chancellor for Information Technology and Telecommunications (change in title from Chief Information Officer) at Fayetteville State University; Vice President for Human Resources at UNC General Administration; and Vice Chancellor and Chief of Staff at Fayetteville State University. Other Vice Chancellor positions were filled by campuses with management flexibility.

In March of 2007, the North Carolina School of the Arts was granted management flexibility to appoint and fix compensation. With the addition of NCSA, there are now twelve constituent institutions with management flexibility as of June 30, 2008 (Appalachian State University, East Carolina University, North Carolina State University, the University of North Carolina at Asheville, the

University of North Carolina at Chapel Hill, the University of North Carolina at Charlotte, the University of North Carolina at Greensboro, The University of North Carolina at Wilmington, The University of North Carolina at Pembroke, Western Carolina University, Winston-Salem State University, as well as the North Carolina School of Science and Mathematics.) During the year the Committee continued to examine the effects on current policies and practices with respect to the granting of management flexibility to the UNC constituent institutions to ensure that other policies, guidelines and regulations are in alignment with this practice.

Pursuant to the recommendations of the Code Review Committee, changes were made to *The Code* and relevant Policies that require campuses to revise their promotion and tenure policies and procedures. In September, the Committee requested that campus procedures and policies for post tenure review be examined and revised to strengthen and give more meaning to this process and that all campuses must revise such policies by March 2009 in keeping with the final recommendations of the Code Review Committee . These new procedures will take effect as of August 1, 2009. Additionally, recommendations by the Code Review Committee require that all campuses revise their phased retirement policies and procedures as well to reflect the recent changes in *the Code* and relevant policies. Campuses will submit their revised phased retirement policies/procedures by September 1, 2008 for final approval by the President.

The Committee reviewed a number of current policies and practices and recommended the adoption of new policies, amendments to existing policies and in some cases, the rescinding of outmoded or obsolete policies. The following

policies were amended: in October 2007, Policy 1100.3 "Head Coaches' and Athletic Directors' Contracts"; in November 2007, Policy 300.5.2, "Implementation Policy on Political Candidacy and Office-holding"; in January, 2008, Policy 101.3.1 "Appeals of Non-reappointment Decisions under Section 604 of *The Code*"; Policy 300.1.1 "Senior Academic and Administrative Officer;" and Policy 300.2.1 "Employees exempt from the State Personnel Act"; and in February 2008, Section 603 of *The Code*. In addition, in February the Committee recommended approval of the recommendations contained in the Human Resources Task Force Report which requested that the Office of State Personnel grant the University system greater flexibility to improve its ability to attract, reward, and retain high quality employees; to enable it to better meet the needs of its employees; and improve the efficiency of UNC personnel operations. The Committee also approved the Non-Tenure Track Faculty report and recommendations.

In October of 2007, the Committee distributed its "Annual Report – July 1, 2006 – June 30, 2007" and accepted the "Annual Report on the Distinguished Professors Endowment Trust Fund" in October of 2007, and the "Report on the Phased Retirement Program" and the "Report on Post-Tenure Review" in November of 2007. The Committee also recommended the approval of the "Resolution to Honor Retiring Faculty" in May of 2008.
