# **BOARD OF GOVERNORS MEETING**

March 15, 2007

The Board of Governors met in special session on March 15, 2007, in the

Multi-Purpose Room of the Mendenhall Student Center on the campus of East Carolina

University. Mr. Phillips, the chairman, called the meeting to order at 5:45 p.m.

# **INVOCATION**

Mrs. Sanders gave the invocation:

Father, Wonderful, Almighty, Triune God:

We thank you for the opportunity to come into your divine presence. We thank you for the opportunity to serve you and to glorify you through our work on this Board of Governors. We humbly ask forgiveness for our sins, especially the sin of ungratefulness...for in the midst of poverty, there is prosperity; in the midst of wars and rumors of wars, there is peace; in the midst of famine, we are fed. And Father, we have done nothing to merit such favor. Like David, we ask who is man that you are mindful of us? It is all by your grace and your mercy. Not one child in northeastern North Carolina should be denied access to a quality education. Every man or woman who wants to work ought to be able to earn a living wage. And every child ought to be able to bloom where he is planted.

Lord you promised in your word that if even two shall agree on earth as touching anything that we shall ask, it shall be done for them of our Father which is in heaven. Today we touch and agree that this University shall be the best in the nation. That every campus will be a blessing not only to the students who attend, but to the regions that they serve and to all the citizens of this great state. We ask a special blessing for the chancellor who will be appointed today to lead Elizabeth City State University. Let him never lean to his own understanding, but trust you for guidance and direction. Let the decisions of this board be grounded in your word, rather than our intellect, for the wisdom of men is foolishness to you. We ask these blessings in the matchless name of your son Jesus. Amen.

### **REPORT OF THE COMMITTEE ON PERSONNEL AND TENURE**

Mr. Mercer, chair of the Committee on Personnel and Tenure, presented the committee's report.

### Election of a Chancellor at Elizabeth City State University

Mr. Mercer stated that President Bowles reported to the committee on the search for a chancellor at Elizabeth City State University. President Bowles came forward and stated that he is delighted to make a recommendation for the appointment of a chancellor at Elizabeth City State University. He began by introducing Mr. Walter Davenport, chair of the Elizabeth City State University Board of Trustees and chair of the Chancellor Search Committee.

Chairman Davenport thanked President Bowles and the Board of Governors for the chance to report on behalf of the search committee. He stated that in September 2006, the committee accepted the President's charge to find the best candidate. The committee held public forums to gather input from students, faculty, alumni, and the community. With the assistance of the executive search consulting firm of Heidrick & Struggles, the committee did an outstanding job in recommending to the Board of Trustees an excellent slate of candidates. Chairman

Davenport added that the goal of the search committee was to select a strong, passionate leader and a community partner who would be the next visionary for Elizabeth City State University.

President Bowles stated that he was pleased to announce the recommendation of Dr. Willie J. Gilchrist as chancellor of Elizabeth City State University at an annual salary of \$200,000. He then reviewed the qualifications of Dr. Gilchrist who currently serves as the university's interim chancellor. President Bowles stated that the University is most fortunate to retain a leader with such determination, integrity, and commitment.

Dr. Buffaloe moved approval of the recommendation, and Mrs. Sanders seconded it. The motion carried. At the request of Chairman Phillips, Dr. Buffaloe, Mrs. Sanders, and Mr. Dixon escorted Dr. Gilchrist into the room.
