I. 2005-06 Tuition Rates

Board-Initiated Tuition Increases

The Board's tuition policy calls for the establishment of a special committee of representatives from all campuses to make a recommendation to the President regarding Board-initiated tuition increases. The recommendations of that special committee were reviewed with the Board at its November meeting and the decision was made not to approve a Board-initiated tuition increase for the 2005-06 academic year.

Previously Board-approved Tuition Increases in Professional Schools:

The following tuition increases for professional schools were approved by the Board of Governors during its March 2004 meeting. At that meeting, the Board approved tuition increases for professional schools for a multi-year period.

Campus-Initiated Tuition Increases

At the February 2005 Board of Governors meeting, the Board approved a motion presented by the Committee on Budget and Finance that tuition rates for resident undergraduate students remain at the 2004-05 level for 2005-06 academic year.

It is proposed that the following increases in nonresident undergraduate, graduate, and professional students be considered as requested by the campuses. The chancellors discussed the uses of the proposed receipts during their presentations to the Committee on Budget and Finance in February 2005. The chancellors discussed the need for funds to ensure competitiveness in faculty salaries, increase the pool of financial aid funding, expand student services, and continue to meet the Board's directives to reduce class size, increase section offerings, and hire more permanent and less part-time faculty.

Increases in Tuition for Professional Schools

It is proposed that the following tuition increases for professional schools be considered:

East Carolina University

Masters of Business Administration	\$60 per credit hour for 2005-06
Masters of Science in Accounting	\$60 per credit hour for 2005-06

The East Carolina University College of Business is seeking to charge additional tuition of \$60 per student credit hour for students enrolled in classes in the Master of Business Administration (MBA) and the Master of Science in Accounting (MSA) programs. The additional tuition revenue supports the establishment of a Career Office, which will assist students with job searches and internship opportunities. In addition, the funding would provide increased scholarships, enhance marketing efforts, and support additional student activities.

The Kenan-Flagler Business School requests a tuition increase in the Master of Business Administration and Masters of Accounting (MAC) programs for the academic years 2005-06 through 2007-08. The funds would be used to address disparities in faculty salaries and to increase the number of student fellowships. In addition, the funds would support curriculum development and improved program infrastructure in the areas of Admissions, Career Services, and Student Services.

In addition, the increased funding would support the acquisition of software required to facilitate the conversion of faculty curricular materials to a web-based, on-line format.

II. Special Tuition Rates for Nonresident Students, 2005-06

Each year, the Board of Governors establishes special tuition rates for two groups of nonresident students in accordance with a Board Resolution approved July 29, 1983. The two groups of students identified in the Resolution are as follows:

- Group 1. Undergraduate students deemed by the institution to have special talents and qualifications and who are thereby awarded by the institution a scholarship or fellowship at a rate of at least \$250 per academic year. The North Carolina School of the Arts may identify categories within this group in accordance with established institutional practice.

- Group 2. Graduate students who are awarded by the institution a graduate teaching or research assistantship and who are paid a stipend at a rate of at least \$2,000 per academic year.

Effective with the Fall Term of 2005, the special tuition rates for the specific groups of nonresident students identified above are proposed as shown on the following page. The new rates reflect the tuition increases proposed in Section 1.

III. Tuition for Students Enrolled in Degree-Credit Distance Education Courses

It is proposed that, effective with the fall semester 2005, resident students and nonresident students taking courses within North Carolina that are enrolled in distance education courses be charged the regular-term tuition rates established in Section I. It is further proposed that tuition rates for these students be implemented on a per-credit-hour basis and that the charge per credit hour be calculated as follows:

- For undergraduate courses, the rate per student credit hour would be the annual rate divided by 29.6 hours.
- For graduate courses, the rate per student credit hour would be the annual rate divided by 20.4 hours.

It is further proposed that the Board delegate to the President the authority to set tuition rates for nonresident students taking courses outside North Carolina. These are students who primarily take courses via the Internet.
