COMMITTEE ON PERSONNEL AND TENURE

Annual Report
July 1, 2008 - June 30, 2009

The major responsibilities of the Committee on Personnel and Tenure, as established by Section 301D of The Code of the Board of Governors are: (1) to make recommendations to the Board on all personnel actions under the jurisdiction of the Board, including establishment of senior academic and administrative officer positions and approving salary increases of 15% or greater AND \$10,000 or more; (2) to review The Code and institutional policies and regulations regarding tenure and dismissal; (3) to review appeals from faculty members that involve questions of tenure; and (4) to act on other personnel matters that involve significant policy considerations.

Pursuant to Policy 200.6, adopted on November 13, 2006 and amended June 8, 2007, the Board of Governors has delegated the authority to the President of the University to:

- a) Appoint and set the salaries of Senior Academic and Administrative Officers (§300.1.1 and §600.3.4) and other employees exempt from the State Personnel Act (§300.2.1) serving within the UNC General Administration.
- b) Set salary ranges for Senior Academic and Administrative Officers of the constituent institutions of University (§600.3.4).
- c) Approve conferrals of tenure and to set salaries of faculty, Senior Academic and Administrative Officers, except the chancellors, and other employees exempt from the State Personnel Act at campuses that do not have Management Flexibility to Appoint and Fix Compensation as long as those

salaries are within the established salary ranges and are not raises in excess of 15% and \$10,000 higher than the salary in effect at the end of the last fiscal year. (§300.1.1 and 600.3.4; Code §602).

- d) Approve all actions relating to the administration of the Optional Retirement Program (G.S. §135-5.1) and the Phased Retirement Program (§300.7.2).
- e) Approve salary increases in excess of \$10,000 and 15% or more for faculty members who are receiving salary increases funded through the Faculty Recruitment and Retention Fund.

Board members who served on the Committee during the fiscal year July 1, 2008, through June 30, 2009 were: Dr. Dudley E. Flood, Ms. Ann B. Goodnight, Mr. H. Frank Grainger, Dr. Gladys Ashe Robinson, Mr. William G. Smith, Dr. Priscilla P. Taylor and Mr. J. Bradley Wilson. The Committee elected as its officers, Dr. Dudley E. Flood as Chair, Dr. Priscilla P. Taylor as Vice Chair, and Ms. Ann B. Goodnight as Secretary.

In its designated role, the Committee on Personnel and Tenure reviews appointments of distinguished faculty for consideration and approval by the Board of Governors for campuses without *management flexibility*, salary increases in excess of \$10,000 and 15% or more, and salaries that exceed the established range. Included in the personnel actions were seven appointments of distinguished faculty under the guidelines of the Board's Distinguished Professors Endowment Trust Fund recommended (a report of the fund is attached to this report.)

Annually, on recommendation of the President, the Committee considers and further recommends to the Board, salary ranges and specific salaries for chancellors of the constituent institutions. The structure and policy governing these ranges and levels embody three principal characteristics: (1) they are to be internally equitable and fair; (2) they are to be externally competitive; and (3) they are to be applied consistently. Actions by the 2008 Session of the North Carolina General Assembly included a pool of funds equal to annual salary increase 3% for EPA non-faculty, with at least an annual increase of four hundred seventy dollars (\$470.00.) Remaining funds and campus-initiated tuition increases or other funds were used for salary increases for market, merit, and equity.

Salary recommendations for chancellors during 2008-2009 were in keeping with the goal adopted that chancellors' salaries and the salary of the president be at the minimum of the salary range, subject to availability of funds and performance reviews. In FY 2008-09 chancellors received salary increases that brought most salaries closer to the minimum of the salary range.

Subcommittees convened for additional meetings to receive, review, and recommend ten faculty appeals from constituent institutions for Board consideration. During the fall of 2008, Laura Luger, Vice President for Legal and General Counsel, presented the Committee with plans to streamline the process for the review of Faculty appeals. This new process has enhanced the Committee members' ability to effectively and efficiently review and determine decisions for faculty appeals.

In 2003, the Committee became responsible for coordinating the Board of Governors' Excellence in Teaching Awards program. Due to budget constraints the Committee decided to forego the usual May awards luncheon. To appropriately recognize each Board of Governors' Teaching Award recipient, an engraved medallion and stipend check was presented to each honoree during their campus' spring commencement by the Board of Governors member in attendance. This new process allowed for greater recognition of the recipient by their peers, students, administrators, families and friends, and was fiscally prudent as well.

New chancellor appointments include: Dr. Harold L. Martin, formerly the Senior Vice President for Academic Affairs at UNC General Administration, as chancellor at North Carolina A&T State University, beginning on June 8, 2009 replacing Stanley Battle who stepped down at the beginning of June 2009.

New Vice Chancellor positions were established in several campuses as follows: Dean of the College of Health Sciences and Allied Professions at Appalachian State University; Vice Chancellor for Graduate Education & Research at North Carolina Central University; Vice Chancellor for Research and Economic Development at the University of North Carolina at Greensboro; and Vice Chancellor for Information Technology at the University of North Carolina at Charlotte. Other Vice Chancellor positions were filled by campuses with management flexibility.

There are now twelve constituent institutions with management flexibility as of June 30, 2009 (Appalachian State University, East Carolina University, North Carolina State University, the University of North Carolina at Asheville, the

University of North Carolina at Chapel Hill, the University of North Carolina at Charlotte, the University of North Carolina at Greensboro, The University of North Carolina at Wilmington, The University of North Carolina at Pembroke, Western Carolina University, Winston-Salem State University, as well as the North Carolina School of Science and Mathematics.) All campuses without management flexibility are being encouraged to seek this authority and all are expected to complete the process during FY 2009-10.

Pursuant to the recommendations of the Code Review Committee, in October 2008 changes were made to *The Code* and relevant Policies that have required campuses to revise their promotion and tenure policies and procedures. Last year the Committee requested that campus procedures and policies for post tenure review be examined and revised to strengthen and give more meaning to this process, and that all campuses revise such policies by March 2009 in keeping with the final recommendations of the Code Review Committee . These new procedures will take effect as of October 1, 2009. Recommendations by the Code Review Committee also required all campuses to revise their phased retirement policies and procedures to reflect the recent changes in *the Code* and relevant policies. Campuses have submitted their revised phased retirement policies/procedures for final approval by the President.

The Committee reviewed a number of current policies and practices and recommended the adoption of new policies, amendments to existing policies and in some cases, the rescinding of outmoded or obsolete policies. A new policy was adopted in October 2008 - Policy 300.2.15 "UNC Pandemic and Communicable Disease Emergency"; in November 2008 amendments to the "Optional Retirement Plan" were adopted to comply with recent IRS

requirements; and a new policy in the Human Resources Policy manual, "Compensatory Time Off for Employees Subject to the Fair Labor Standards Act", was adopted in February 2009.

In October of 2008, the Committee distributed its "Annual Report – July 1, 2007 – June 30, 2008" and accepted the "Annual Report on the Distinguished Professors Endowment Trust Fund." The Committee accepted the "Report on the Phased Retirement Program" in November of 2008 and the "Report on Post-Tenure Review" in January 2009. In May 2009 the "*Resolution Authorizing President to Implement Emergency Measures*" was approved, granting the President authority to implement the Governor's order for mandatory employee furloughs and authority to implement any future furlough plans authorized by the General Assembly or mandated by the Governor. The Committee also recommended the approval of the "Resolution to Honor Retiring Faculty" in May of 2009.
