#### **Draft Minutes**

The Committee on University Governance met Thursday, June 10, 2010, at 3:00 p.m. in Conference Room C of the Spangler Center, Chapel Hill.

Committee members present included Chairman Blank, Mr. Bowden, Dr. Flood, Mr. Fulton, Dr. McCain, and Mrs. Sanders. Chairman Gage, Mr. Bhula, Mr. Blackburn, Mr. Deal, and Mr. Hans were in attendance. Chancellor Brady and George Burnette participated. Secretary Corgnati attended as staff.

### Approval of Minutes

Upon motion of Dr. McCain and seconded by Mr. Bowden, the committee voted to approve the minutes of the April 8, 2010, meeting of the committee.

### Discussion of Vacancies on Boards and Councils

The committee discussed vacancies on councils and boards of trustees.

There is a partial term ending June 30, 2011, on the University of North Carolina at Greensboro Board of Trustees. Upon motion of Mr. Bowden, and seconded by Dr. Flood, the Committee voted to recommend the election of Martin P. Weissburg of Greensboro to serve. See Appendix A.

There is a partial term ending June 30, 2013, on the University of North Carolina School of the Arts Board of Trustees. Upon motion of Mr. Fulton, and seconded by Dr. Flood, the Committee voted to recommend the election of Robert L. King III of Winston-Salem to serve. See Appendix B.
