Draft Minutes

The Committee on University Governance met Thursday, August 12, 2010, at 3:00 p.m. in Conference Room C of the Spangler Center, Chapel Hill.

Committee members present included Chairman Bowden, Ms. Blank Dr. Flood, Mrs. Goodyear, Mr. Hans, Dr. Key, and Dr. McCain. Chairman Gage, Mr. Barringer, Mr. Blackburn, Mr. Davis, Mr. Dixon, Mrs. Goodnight, and Dr. Locklear were in attendance. Chancellor Brady, Chancellor Carter, Chancellor DePaolo, Chancellor Dubois and Chancellor Woodson participated. Attorney Curry and Mr. Zarnstorff from North Carolina State University joined the meeting. Associate Vice President Harrison and Secretary Corgnati attended as staff.

Approval of Minutes

Upon motion of Dr. McCain and seconded by Dr. Flood, the committee voted to approve the minutes of the June 10, 2010, meeting of the committee.

Campus Liaison Assignments for 2010-2011

Chairman Bowden presented the campus liaison assignments for the upcoming year, 2010–2011. The Committee discussed their role as a campus liaison and agreed to review their responsibilities. The liaison assignments are presented as Appendix A.

Discussion of Vacancies on Boards and Councils

The committee discussed vacancies on councils and boards of trustees.

There is a partial term ending June 30, 2013, on the University of North Carolina School of the Arts Board of Trustees. Upon motion of Mrs. Goodyear, and seconded by Dr. McCain, the Committee voted to recommend the election of Michael A. Almond of Piney Creek to serve. See Appendix B.

There will be a partial term ending June 30, 2013, on the University of North Carolina at Charlotte Board of Trustees. This vacancy results from the resignation of Ruth G. Shaw of Davidson, effective September 24, 2010. This vacancy will be announced.

There is a term ending June 30, 2013, on the North Carolina School of Science and Mathematics Board of Trustees, representing Congressional District 2. This vacancy will be announced.

There is also a partial term ending June 30, 2011, on the North Carolina School of Science and Mathematics Board of Trustees, representing Congressional District 8. This vacancy will be announced.

There are six terms ending June 30, 2014, on the University of North Carolina Center for Public Television Board of Trustees. Upon motion of Dr. McCain, and seconded by Dr. Key, the Committee voted to recommend the reappointment of Phillip J. Kirk, Jr., of Raleigh, James O. Treadaway, Jr., of Hickory, and Gary York of Elkin to serve. Action on the remaining three vacancies was deferred.

There is a term ending June 30, 2014, on the State Advisory Council on Indian Education. Upon motion of Dr. McCain, and seconded by Mr. Hans, the Committee voted to recommend the appointment of Ms. Brandi Leigh Brooks of Chapel Hill to serve. See Appendix D.

There are three terms ending June 30, 2014, on the UNC Umstead Review Panel. Upon motion of Dr. Key, and seconded by Mrs. Goodyear, the Committee voted to recommend the reappointment of Robert F. Warwick of Wilmington to serve. Action on the remaining two vacancies was deferred.

Department of Defense Classified Research

The Committee was aware of the background regarding the accreditation process for the University of North Carolina at Charlotte Closed Facility to meet the requirements of the National Industrial Security Program Operations Manual under which the campus will be conducting research involving Department of Defense classified information. The Board of Governors must pass a resolution naming those members of the Board who will not have access to the classified information and will, therefore not be required to have personal security clearances.

Upon motion of Dr. Flood, and seconded by Mr. Hans, the committee voted to approve the draft resolution that excludes all members of the Board of Governors from this requirement and will recommend adoption of the resolution to the Board of Governors. See Appendix E.

Upon motion of Mr. Bowden, and seconded by Dr. Flood, the Committee voted to go into Closed Session to consult with our attorney to consider and give instructions concerning the judicial action involving NCSU and Wolfpack Auto Sales, pursuant to the North Carolina General Statutes Section 143-318.11(a) (3).

H. David Swain, a developer of commercial income producing properties in North and South Carolina, formed his development company, Swain & Associates, thirty-two years ago. Mr. Swain was one of six area leaders chosen to direct the University of North Carolina at Wilmington's efforts to select its current Chancellor. He actively serves as a member of the International Council of Shopping Center Developers and has been an active member of the North Carolina Apartment Builders, the Wilmington Chamber of Commerce and the Committee of 100.

Mr. Swain and his wife have given freely of their time and resources to numerous philanthropic causes including the March of Dimes and the Pink Ribbon Project. They are also benefactors of the Cape Fear Museum.

The son of a schoolteacher, Mr. Swain strongly supports initiatives that facilitate equal and affordable access to higher education. To that end, he and his wife have funded 17 college scholarships for children of New Hanover County civil servants. Additionally, in 2009 Mr. and Mrs. Swain donated \$1 million to the University of North Carolina at Wilmington.

Mr. Swain is a licensed real estate broker in the state of North Carolina and the state of South Carolina. He and his wife of 41 years have two children Jason David Swain and Meredith Sterling Swain. Jason, a graduate of the University of North Carolina at Chapel Hill, works with his father. Meredith, a graduate of Wake Forest University, is pursuing her doctorate of physical therapy at the University of St. Augustine.
