Request for Authorization to Establish a Master of Law (LL.M) at the University of North Carolina at Chapel Hill

UNC-Chapel Hill requests authorization to establish a Master of Law degree program (CIP 22.0202) effective January 2011.

Program Description

This is to be a master in law program for foreign lawyers who already have received a primary law degree from a university in their home country. The focus of the program will be United States law and procedures. It would allow foreign lawyers who practice internationally to gain a greater understanding of the American legal system. The program will typically be one calendar year.

Such programs are common among American law schools with more than 130 US law schools offering such programs. In North Carolina both Duke and Wake Forest have such programs.

UNC Tomorrow Relevance

This program is one way the UNC Chapel Hill law school can bring a greater international dimension to the preparation of lawyers. Since many classes will be shared by JD students and LL.M. students, there will be many opportunities for UNC Chapel Hill students to build friendships and learn more about the legal systems in other countries.

Highlights from UNC-GA Data Template

Duke and Wake Forest both have similar programs with Duke graduating 82 in the most recent year and Wake Forest graduating 10. UNC Chapel Hill envisions a program larger than Wake Forest's but much smaller than Duke's. Eventually their target is an enrollment of approximately 25. In the near term the program will start up on a smaller scale until the new law building at Carolina North is constructed.

Disciplinary Panel

Representatives of the UNC-CH law school and the General Administration participated, and the North Carolina Central University Law School was represented by their dean. Any issues raised were satisfactorily addressed. Dean Pierce of NCCU was very supportive of the program and expects the two schools can find additional ways to cooperate.

Student Demand

The widespread availability of similar programs at other law schools indicates that there is a large international appetite for this kind of program. Having an option at a public law school in North Carolina will be very attractive to lawyers who seek out such programs. Once lawyers come from a particular country and have a good experience that tends to drive greater demand from that country.

Opportunities for Graduates of the Program

The idea is that with greater knowledge of American law, opportunities will open up for them to do international legal work in their home countries. They will also likely form relations with JD candidates and alumni of the law school which will be a set of contacts they will reach out to for assistance by American law firms in their future practice.

Resource Implications

Resource needs: There will be the need for a slight increase in staff to support this program, but it is planned as an entirely self-supporting program. Tuition for the program will not only fully support all aspects of the program, but will also provide a revenue source for ongoing improvement in the program in legal education at the law school.

Resources allocated: The initial tuition has been proposed to be \$38,500 per year.

Estimated cost to the State: This program will not be on the State funding formula for the law school. The cost to the State will be zero in enrollment appropriations from the State.

Accreditation: The ABA does not technically accredit master's level programs, but it does require notification and "prior acquiescence" before a new master's level program can be started. Upon program approval by the Board, the Law School would initiate that process.

Recommendation

It is recommended that the Board of Governors approve UNC-Chapel Hill's request to establish a Master of Law (LL.M) degree program (CIP 22.0202) effective January 2011.
