University of North Carolina at Chapel Hill Athletics Update

The Committee received a report from Chancellor Holden Thorp on the UNC-Chapel Hill athletics update. Director of Athletics Richard Baddour and Leslie Strohm, Vice Chancellor and General Counsel, were available to respond to questions.

North Carolina A&T State University Athletics Update

There are two terms ending June 30, 2014, on the UNC Umstead Review Panel. Action on these vacancies was deferred.
