Dear Bart:

There are currently three open positions, to be appointed by the Board of Governors, on the board of directors of The North Carolina Arboretum. These consist of one existing position, formerly occupied by Dr. Charles Hamner, as well as two new positions added by the General Assembly effective July 1, 2011. The two new position openings, one for a normal four-year term and one for an initial two-year term, were announced publicly at the August meeting in anticipation of appointments at the September meeting.

Consequently, it is my recommendation, and that the Arboretum board, that the following individuals be appointed to these positions (bios are attached):

For the existing four-year term, we recommend Dumont Clarke of Charlotte. Mr. Clarke is an attorney with the Moore & Van Allen firm and a native of the Asheville area. Mr. Clarke's legal expertise in corporate governance and public finance, leadership in children's and health and wellness issues, familiarity with the Charlotte community and interest in landscape architecture will be relevant assets to the Arboretum's mission.

For the new four-year term, we recommend Lynne Scott Safrit of Kannapolis. Ms. Safrit is President of Atlantic American Properties and the North American Commercial Division of Castle and Cooke. Her familiarity with the Arboretum's research and commercialization associated with our Bent Creek Institute and our partnership with the David H. Murdock Research Institute will be instrumental in building success in these endeavors.

For the new two-year term, we recommend Perry Howard of Greensboro. Mr. Howard is Associate Professor and Coordinator of the Landscape Architecture Program in the Department of Natural Resources and Environmental Design at North Carolina A&T State University. A Fellow in the American Society of Landscape Architects (ASLA), Mr. Howard has also recently served as the 60th president of this professional association of 18,000 members.

We are pleased to have the opportunity of strengthening the Arboretum board with these three strategic appointments and appreciate the Governance Committee's consideration of these recommendations.

Prior to joining NCA&TSU Mr. Howard was a vice president at EDSA, a global firm in Fort Lauderdale, FL specializing in planning, landscape architecture, urban planning and graphic design. With emphasis on residential communities, his work spanned a wide variety projects such as: upgrading a public portion of the Miami airport; the governor's residence in El Morro, Venezuela; the PGA's New Home Site Community; and the Summer Palace for the Saudi Royal Family.
