Draft Minutes

The Committee on University Governance met Thursday, August 11, 2011, at 1:00 p.m. in the Board Room of the Spangler Center, Chapel Hill.

Committee members present included Chairman Daughtridge, Mr. Grainger, Mr. Harrelson, Dr. McCain, Mr. McMahan, Mr. Powers, and Dr. Roseman. Chairman Gage and many other members of the Board of Governors and Chancellors were in attendance. President Ross, Vice President Luger, Associate Vice President Harrison, and Secretary Corgnati attended as staff.

Approval of Minutes

Upon motion of Dr. Roseman and seconded by Dr. McCain, the committee voted to approve the minutes of the June 9, 2011 meeting of the committee.

Task Force on Athletics and Academics

Chairman Daughtridge welcomed President Ross who gave an overview of the origin of the UNC Task Force on Athletics and Academics. Chancellor Ballard, Chairman of the Task Force, then discussed the Report on the Task Force in detail. He and members of the Task Force were available to respond to questions.

University of North Carolina at Chapel Hill Athletics Update

The Committee received a report from Chancellor Holden Thorp on the UNC-Chapel Hill athletics update. Director of Athletics Richard Baddour and Leslie Strohm, Vice Chancellor and General Counsel, were available to respond to questions.

Chairman Daughtridge led a discussion of the campus liaison responsibilities, endorsed the utilization of the trustee nomination form, and asked each member to make him aware of their preference of which constituent and affiliated boards they wish to be assigned to as liaison.

Discussion of Vacancies on Boards and Councils

The committee discussed vacancies on councils and boards of trustees.

There is a partial term ending June 30, 2013, on the University of North Carolina at Asheville Board of Trustees. Upon motion of Dr. Roseman, and seconded by Mr. Powers, the Committee voted to recommend the election of Dr. Ronald Paulus of Asheville to serve. See Appendix A.

There is a partial term ending June 30, 2015, on the University of North Carolina at Pembroke Board of Trustees. Upon motion of Dr. McCain, and seconded by Dr. Roseman, the Committee voted to recommend the election of Robert Caton of Lumberton to serve. See Appendix B.

There is a term ending June 30, 2015, on the North Carolina School of Science and Mathematics Board of Trustees, representing Congressional District 13. Upon motion of Mr. Grainger, and seconded by Dr. McCain, the Committee voted to recommend the appointment of Dr. Thomas Williams of Raleigh to serve. See Appendix C. Upon motion Mr. Powers, seconded by Dr. McCain, the Committee voted to recommend the reappointment of John F.A.V. Cecil of Asheville and the appointment of Dr. David Belcher, Chancellor of Western Carolina University, to serve. Action on the remaining vacancy was deferred. See Appendix E.

Department of Defense Classified Research

The Committee was aware of the background regarding the accreditation process for the University of North Carolina at Charlotte Closed Facility to meet the requirements of the National Industrial Security Program Operations Manual under which the campus will be conducting research involving Department of Defense classified information. The Board of Governors must pass a resolution naming those members of the Board who will not have access to the classified information and will, therefore not be required to have personal security clearances.

Upon motion of Mr. Harrelson, and seconded by Mr. Grainger, the Committee voted to approve the draft resolution that excludes all members of the Board of Governors from this requirement and will recommend adoption of the resolution to the Board of Governors. Introduction

Prior to founding Strategic Educational Alliances, Inc. in late 2007, Tom Williams served the public schools of North Carolina for thirty-two years. Most recently, he served as superintendent of the Granville County Schools from 2000 until his retirement on June 30, 2007. In the summer of 2010, he was appointed the Interim Chancellor of the North Carolina School of Science and Mathematics. He served over six years as the Executive Director for the North Carolina Business Committee for Education (NCBCE) under Governor James B. Hunt, Jr. beginning in 1994 through 2000. Tom spent the previous 19 years in the public schools of North Carolina. Beginning as a teacher/coach in the Wake County Schools, he has been an elementary, middle, and high school principal in both Johnston and Granville Counties. From 1991-1994, he served as an assistant superintendent with the Johnston County Schools.
