SUBJECT:	Licensure of Daoist Traditions College of Chinese Medical Arts

The Board of Governors of the University of North Carolina is charged under North Carolina General Statute Section 116-15 with responsibility for licensing nonpublic educational institutions to conduct post-secondary degree activity in North Carolina. In November 2004, the Board of Governors approved revisions to the document, *Rules and Standards for Licensing Nonpublic Institutions to Conduct Post-Secondary Degree Activity in North Carolina*. This document provides the guidelines for interpreting the standards, and the rules, regulations, and procedures under which the Board issues licenses to institutions to conduct post-secondary degree activity in North Carolina.

Daoist Traditions College of Chinese Medical Arts has applied for licensure to offer the Master of Acupuncture and Oriental Medicine degree program at its campus in Asheville.

Dr. Frank Prochaska reviewed the application and appointed a team of examiners to determine if Daoist Traditions complied with the licensure standards outlined in the *Rules and Standards*. On April 26, 2011, the team of examiners visited the Daoist Traditions campus in Asheville. Following the visit, the team of examiners issued its report which contained recommendations. For more details on the degree program and report, please review the summary.

Thus, I recommend to the Committee on Educational Planning, Policies, and Programs of the UNC Board of Governors that a regular license be issued to Daoist Traditions College of Chinese Medical Arts to offer the above-named degree program in Asheville, subject to annual reports and review at any time. The program will be reviewed within two calendar years of its initiation in North Carolina to judge whether the institution continues to maintain standards for licensure.

# SUMMARY OF VISIT OF TEAM OF EXAMINERS FOR THE DAOIST TRADITIONS COLLEGE OF CHINESE MEDICAL ARTS

# **BACKGROUND INFORMATION**

Daoist Traditions College of Chinese Medical Arts, located in Asheville, North Carolina, provides education and training in acupuncture and oriental medicine. The institution, which has been in continuous operation since 2003, currently offers a diploma program and is licensed by the North Carolina Acupuncture Licensing Board.

Daoist Traditions College of Chinese Medical Arts is a private, for-profit institution incorporated in North Carolina as an S Corporation. The college is accredited by the Accreditation Commission for Acupuncture and Oriental Medicine (ACAOM), which is the national agency for accrediting Master's-level programs in the acupuncture and oriental medicine profession.

# THE APPLICATION AND SITE VISIT

Daoist Traditions College of Chinese Medical Arts has applied for licensure to offer the following degree program onsite at its campus in Asheville:

• Master of Acupuncture and Oriental Medicine

Pursuant to the *Rules and Standards: Licensing Nonpublic Institutions to Conduct Post-Secondary Degree Activity in North Carolina*, Dr. Frank Prochaska, Associate Vice President for Academic Affairs at UNC General Administration, appointed a team of examiners to visit the institution and evaluate its compliance with the licensure standards. On April 26, 2011, the team of examiners visited the Daoist Traditions College of Chinese Medical Arts campus in Asheville.

The team of examiners with expertise in the specific disciplines relating to the application was comprised of:

- Dr. Richard E. Neel (Chair), Dean Emeritus, Belk College of Business, and Professor of Economics Emeritus, University of North Carolina at Charlotte, Charlotte, North Carolina
- Dr. Gary Asher, Assistant Professor, Department of Family Medicine, UNC School of Medicine, Chapel Hill, North Carolina
- Dr. Henry C. Chang, Director of Library Services, Braille Institute Library Services, Los Angeles, California
- Dr. Steve Given, L.Ac., Associate Dean, School of Acupuncture and Oriental Medicine, and Program Director, Doctor of Acupuncture and Oriental Medicine Program, Bastyr University, Seattle, Washington
- Dr. Frank Prochaska, Associate Vice President for Academic Affairs, The University of North Carolina General Administration, Chapel Hill, North Carolina, *Ex Officio*

The team's task was to review the application and accompanying exhibits and to participate in the site visit to determine if the institution demonstrated compliance with licensure standards. Either prior to the visit or during the visit, many additional items of documentation were reviewed by the

team including the curriculum for the proposed degree program, course syllabi, faculty curriculum vitae, library and electronic resources, instructional resources, computer resources, educational facilities, audited financial statements, budget data, the Student Clinic, Daoist Traditions College of Chinese Medical Arts Academic Catalog 2010-2011, and the Daoist Traditions College of Chinese Medical Arts *Faculty Handbook 2009-2010*.

During the visit, the team of examiners met with numerous administrators, faculty, staff, and students of the Daoist Traditions College of Chinese Medical Arts.

# **PROPOSED DEGREE PROGRAM**

## Master of Acupuncture and Oriental Medicine

The curriculum provides students with a comprehensive understanding of the principles and techniques of Oriental Medicine as well as a fundamental understanding of Western medical theory and practice. The four-year program combines both classical and contemporary Chinese medical teachings. In addition to a solid foundation in the teachings and philosophies of Oriental Medicine, students gain practical knowledge through training with faculty who are currently practicing in the field. The program is designed to produce graduates with strong clinical skills. Categories of coursework include acupuncture and Chinese medicine; herbal medicine; Western medicine; clinical observation; and clinical internship.

#### RECOMMENDATIONS

After the site visit, the *Preliminary Report to the President of The University of North Carolina from the Team of Examiners for the Licensure Visit to Review the Daoist Traditions College of Chinese Medical Arts' Proposed Master's Degree Program in Asheville, North Carolina* was submitted. In the report, the team of examiners included three suggestions and seven recommendations. Suggestions, which are offered as suggested best practices by team members, do not indicate a lack of compliance with the *Rules and Standards*. A suggestion is written for the institution's benefit, and it does not need to be implemented; the recommendations, however, must be implemented by the institution. The recommendations addressed issues of library personnel, library resources, faculty credentials, and the tuition guaranty bond.

The team of examiners concludes its report by stating it would make its recommendation to the General Administration of The University of North Carolina regarding the licensure of the proposed degree program after it receives the response from Daoist Traditions College of Chinese Medical Arts to the recommendations and suggestions contained in the report.

After receiving the team of examiners' report, Daoist Traditions College of Chinese Medical Arts responded to the recommendations and suggestions. All of the recommendations have been implemented to the satisfaction of the team of examiners.

After reviewing the institution's response, the team of examiners recommends that Daoist Traditions College of Chinese Medical Arts be licensed to offer the Master of Acupuncture and Oriental Medicine degree program.

Dr. Frank Prochaska agrees with the team's review and recommendations. Thus, General Administration recommends licensure of the following new degree program, to be offered by Daoist Traditions College of Chinese Medical Arts in Asheville, North Carolina: Master of Acupuncture and Oriental Medicine.

A site visit to Daoist Traditions College of Chinese Medical Arts will be performed within two calendar years of the initiation of this new degree program, by a team of examiners with expertise in the field, to ascertain the college's compliance with the *Rules and Standards*, including the recommendations contained in the report.

# SUMMARY OF VISIT OF TEAM OF EXAMINERS FOR THE ART INSTITUTE OF CHARLOTTE

# **BACKGROUND INFORMATION**

The Art Institute of Charlotte, a private for-profit institution located in Charlotte, North Carolina, has applied for licensure to offer three additional degree programs. The Institute currently offers the following licensed degree programs:

- Associate of Applied Science (A.A.S.) degree in the following areas: Culinary Arts, Digital Filmmaking & Video Production, Fashion Marketing, Graphic Design, Interior Design, and Photography
- Bachelor of Arts (B.A.) degree in the following areas: Advertising, Culinary Arts Management, Digital Filmmaking & Video Production, Fashion Marketing & Management, Graphic Design, Industrial Design, Interior Design, and Photography

The Art Institute of Charlotte, which became a branch campus of South University in 2011, is accredited by the Commission on Colleges (COC) of the Southern Association of Colleges and Schools (SACS).

# THE APPLICATION AND SITE VISIT

The Art Institute of Charlotte has applied for licensure to offer the following three new degree programs on-site at its Charlotte campus:

- Bachelor of Fine Arts in Media Arts and Animation
- Associate of Applied Science in Restaurant and Catering Management
- Associate of Applied Science in Fashion Design

Pursuant to the *Rules and Standards: Licensing Nonpublic Institutions to Conduct Post-Secondary Degree Activity in North Carolina*, Dr. Frank Prochaska, Associate Vice President for Academic Affairs at UNC General Administration, appointed a team of examiners to visit the institution and evaluate its compliance with the licensure standards. The site visit occurred on May 11, 2011.

Either prior to the visit or during the visit, many additional items of documentation were reviewed by the team including curricula for the proposed degree programs, course syllabi, faculty curriculum vitae, library and electronic resources, computer resources, educational facilities, budget data, audited financial statements, enrollment information, The Art Institute of Charlotte Catalog, and the *Faculty Manual*.

During the visit, the team of examiners met with numerous administrators, faculty, staff, and students of the Art Institute of Charlotte.

# **PROPOSED DEGREE PROGRAMS**

## Bachelor of Fine Arts in Media Arts and Animation

The purpose of the Bachelor of Fine Arts program in Media Arts & Animation is to prepare students to work successfully in various areas of animation including game design. This highly focused program of study is taught by faculty composed of animation industry professionals with academic credentials in related design disciplines who guide students through the complexities of various types of animation software suites while assisting them in improving their drawing skills to high levels. The use of good design procedures will be continuously emphasized from initial concept and research through the completion of a high quality, on-time finished product. Upon completion of this course of study, students will be ready to seek entry-level employment in areas of animation, from conveying corporate messages to entertainment and gaming. The degree program requires 48 quarter credit hours in general education and a minimum of 180 quarter credit hours.

## Associate of Applied Science in Restaurant and Catering Management

The purpose of the Restaurant & Catering Management program is to provide students with the skills needed for success in the hospitality industry. While gaining practical knowledge of the essential business elements, students can also develop basic cooking techniques, which are utilized in commercial operations. The Associate of Applied Science degree program in Restaurant & Catering Management is designed to prepare students with the skills and technical background needed to seek entry-level positions such as management trainee, kitchen manager, banquet supervisor, or assistant food and beverage director. The degree program requires 24 quarter credit hours in general education and a minimum of 90 quarter credit hours.

# Associate of Applied Science in Fashion Design

The purpose of the Fashion Design Program at the associate's degree level is to prepare graduates with the skills in concept development, production and presentation techniques necessary to seek entry-level employment in the apparel industry. Emphasis is placed on the technical aspect of the Ready-to-Wear industry focusing on design and production while incorporating elements of computer-aided design. The Associate of Applied Arts degree program in Fashion Design is designed to prepare students with the creative skills required to seek entry-level employment in apparel design, patternmaking, production management, and computerized technology in the fashion industry. The degree program requires 24 quarter credit hours in general education and a minimum of 90 quarter credit hours.

## RECOMMENDATIONS

After the site visit, the *Preliminary Report to the President of The University of North Carolina from the Team of Examiners for the Licensure Visit to Review The Art Institute of Charlotte's Proposed Bachelor's and Associate Degree Programs and Licensed Bachelor's and Associate Degree Programs at Charlotte, North Carolina* was submitted. In the report, the team of examiners included nine suggestions and fourteen recommendations addressing the degree programs reviewed. Suggestions, which are offered as suggested best practices by team members, do not indicate a lack of compliance with the *Rules and Standards*. A suggestion is written for the institution's benefit, and it does not need to be implemented; the recommendations, however, must be implemented by the institution. The recommendations addressed issues of curriculum and facilities for the new programs, library resources, faculty credentials, and information to be included in the catalog.

The team of examiners concludes its report by stating it would make its recommendations to the General Administration of The University of North Carolina regarding licensure of the three proposed degree programs after it receives the response from The Art Institute of Charlotte to the recommendations and suggestions contained in the report.

After receiving the team of examiners' report, The Art Institute of Charlotte responded to the recommendations and suggestions. All of the recommendations have been implemented to the satisfaction of the team of examiners.

After reviewing the institution's response, the team of examiners recommends that The Art Institute of Charlotte be licensed to offer the three new degree programs requested.

Dr. Frank Prochaska agrees with the team's review and recommendations. Thus, General Administration recommends licensure of the following proposed degree programs, to be offered on-site by The Art Institute of Charlotte: Bachelor of Fine Arts (B.F.A) in Media Arts and Animation, Associate of Applied Science (A.A.S.) in Restaurant and Catering Management, Associate of Applied Science (A.A.S.) in Fashion Design.

A site visit to The Art Institute of Charlotte will be performed within two calendar years of the initiation of these new degree programs, by a team of examiners with expertise in the field, to ascertain The Art Institute of Charlotte's compliance with the *Rules and Standards*, including the recommendations contained in the report.
