

Sale of Special Obligation Bonds – North Carolina State University

The Board of Governors is authorized to issue special obligation bonds for capital improvements projects that have been approved by the General Assembly. Although a specific source of funding is used by a campus when retiring these bonds, special obligation bonds are generally payable from all campus revenues excluding tuition, State appropriations, and restricted reserves.

NC State requests that the Board issue special obligation bonds for the purpose of (1) refinancing of NCSU indebtedness and refunding all or a portion of prior revenue bonds or special obligation bonds issued for the benefit of NCSU that result in sufficient savings, and (2) paying the costs incurred in connection with the issuance of the 2012 Bonds. The 2012 Bonds may be issued in one or more series of bonds, including any combination of tax-exempt bonds and taxable bonds as the President of the University, or his designee, in consultation with the appropriate officers at NCSU, determine to be in the best interest of the University.

The issuance of bonds to refund all or a portion of prior revenue bonds or special obligation bonds issued on behalf of NCSU will not exceed \$70,000,000. It is possible that no bonds will be refunded with this transaction.

NCSU is currently rated Aa1 and AA by Moody's Investor Service and Standard & Poors, respectively. After issuance of these bonds, it is expected NCSU would maintain its Aa1/AA rating.

Parker Poe is bond counsel and Barclays Capital is the underwriter.

It is recommended that the President of the University, or his designee, be authorized to sell the special obligation bonds.
