Thursday, June 14, 2012

Draft Minutes

The Committee on University Governance met Thursday, June 14, 2012, at 3:00 p.m. in the Board Room of the Spangler Center.

Committee members present included Chairman Daughtridge, Mr. Grainger, Mr. Harrelson, Dr. McCain, Mr. McMahan, Mr. Powers, and Dr. Roseman. Chairman Gage and many other members of the Board of Governors attended. President Ross, General Counsel Fjeld, and Secretary Corgnati attended as staff.

Approval of Minutes

Upon motion of Dr. McCain, and seconded by Mr. Grainger, the committee voted to approve the minutes of the April 12, 2012, meeting of the committee.

Review of the Officer Election Process

Chairman Daughtridge called on General Counsel Fjeld who discussed the officer election process that would be followed at the June 15, 2012, meeting of the Board of Governors. Next, each candidate for office was invited to present a brief statement about themselves and their vision for the University.

Update on UNC-Chapel Hill Matters

President Ross provided a summary of recent steps taken to understand the details of academic irregularities at the University of North Carolina at Chapel Hill and to make certain that these occurrences do not happen again. President Ross announced that he and Chairman Gage will appoint Board of Governors members to an Academic Review Panel whose charter will be to assess the investigative efforts to date. Mr. Bissette will serve as the chairman and Mr. Davenport, Mrs. Goodnight and Mr. Nath were named to the Panel. Chancellor Thorp and members of his faculty and staff were available to respond to questions.

Committee on University Governance June 14, 2012 Minutes

Dr. McCain moved, and seconded by Mr. Powers, that the Committee go into closed session to consult with our attorney to protect the attorney-client privilege; to consider and give instruction concerning judicial actions involving Appalachian State University; and to consider the qualifications, competence, performance, condition of appointment of a public officer or employee, pursuant to N.C.G.S. 143-318.11 (a) (3) and (a) (6). The motion carried.

CLOSED SESSION

Mr. Grainger moved, and duly seconded, that the Committee reconvene in open session. The motion carried.

OPEN SESSION

Discussion of Vacancies on Boards and Councils

The committee discussed vacancies on councils and boards of trustees.

There is a partial term ending June 30, 2015, on the Elizabeth City State University Board of Trustees. This seat was vacated by Timothy Bellamy of Greensboro. This vacancy will be announced.

There is a partial term ending June 30, 2015, on the North Carolina State University Board of Trustees. Upon motion of Mr. Powers and duly seconded, the Committee voted to recommend the election of Ms. Gayle Lanier of Raleigh to serve. The resume of Ms. Lanier is presented as Appendix A.

There is a partial term ending June 30, 2013, on the University of North Carolina School of the Arts Board of Trustees. This seat was vacated by Michael Almond of Piney Creek. This vacancy will be announced.

There is a partial term ending June 30, 2013, on the Winston-Salem State University Board of Trustees. Upon motion of Mr. Grainger and seconded by Dr. McCain, the Committee voted to recommend the election of Dr. Steve Martin of Winston-Salem to serve. The profile of Dr. Martin is presented as Appendix B.

Committee on University Governance June 14, 2012 Minutes

There are two partial terms ending June 30, 2013, on the North Carolina School of Science and Mathematics Board of Trustees, representing Congressional Districts 3 and 11. Upon motion of Mr. Powers and seconded by Mr. Grainger, the Committee voted to recommend the appointment of Dr. Mini Mittal of Jacksonville to serve, representing Congressional District 3. The resume of Dr. Mittal is presented as Appendix C. Action on the Congressional District 11 vacancy was deferred.

There are three terms ending June 30, 2017, on the University of North Carolina Press Board of Governors. Upon motion of Mr. Harrelson and seconded by Mr. Grainger, the Committee voted to recommend the appointment of Dr. Inger Brody of UNC-Chapel Hill, Dr. Lee Craig of North Carolina State University, and Dr. Irene Owens of North Carolina Central University to serve. There are five terms ending June 30, 2016, on the University of North Carolina Center for Public Television Board of Trustees. The incumbents are William W. Mance, Jr., Betty R. McCain, Assad Meymandi, Robert D. Teer, Jr., and Carl V. Venters, Jr. All are eligible for reappointment except Mrs. McCain. These vacancies will be announced.

Upon motion by Mr. McMahan and duly seconded, the committee voted to recommend the ratification of the president's appointment to the Board of Governors. Inger S. B. Brodey

INGER S. B. BRODEY Associate Professor of Comparative Literature, Affiliate faculty in the Department of Asian Studies, Affiliate faculty in Global Studies, and Director of the Comparative Literature Program, UNC-Chapel Hill; Ph.D. University of Chicago (1993); M.A. University of Chicago (1991); B.A. Colorado College (1987).

Dr. Brodey was born in Kyoto, Japan, and studied at the Albert-Ludwigs Universität in Freiburg, Germany, as well as at Waseda University in Tokyo, before receiving her Ph.D. from the Committee on Social Thought at the University of Chicago. With a background in comparative literature and political philosophy, Dr. Brodey is a committed comparatist, both in terms of the cross-cultural comparison of literatures and in interdisciplinary approaches to the study of literature. Her primary interest is in the history of the novel in late eighteenth- and early nineteenth-century Europe and Meiji Japan. She works in German, Japanese, French, and Italian, as well as English and her native Danish.

Dr. Brodey's recent book Ruined by Design: Shaping Novels and Gardens in the Culture of Sensibility (Routledge, 2008) draws on fictional narratives, landscape architecture, discussions of 'natural' language, guides to rhetoric, philosophical writings, and other aspects of the culture of sensibility in England, France, and Germany, to offer a new synthesis of its literary and material culture: Ruined by Design reveals a widespread discomfort with authorship and authority in general, which led to innovative new structures in the fledging novel, as well as in landscape gardens and their architecture. Ruined by Design won the 2009 SAMLA Studies Book Award.

Her Rediscovering Natsume Sôseki (Global Press, 2000) includes the first English translation of Sôseki's Mankan Tokoro Dokoro (Travels through Manchuria and Korea), co-translated from Japanese with Sammy Tsunematsu.

Other publications include articles and book essays on Jane Austen, Laurence Sterne, Johann Wolfgang Goethe, and Natsume Sôseki. Her current research is on connections between Meiji Japan and post-Enlightenment Europe, particularly involving changes in the understanding of the novel as a genre and the connection between Natsume Sôseki and Jane Austen. She also is working on a book-length manuscript entitled *Cowboys and Samurai: Authority, Nation-Making, and Individualism*, as well as a separate project on the cultural currency of Jane Austen in Asia.

Dr. Brodey's awards include a Mellon Fellowship in the Humanities (1988-1993), a Jacob M. Javitz Fellowship, a Fulbright-DAAD Fellowship (1987-88), and Earhart Fellowships (1993, 1997, 2008).

Marcie Ferris

Marcie Ferris is associate professor and director of undergraduate studies in the Department of American Studies at the University of North Carolina at Chapel Hill. Since 2008, she has served as the department's coordinator of Southern Studies. She received her Ph.D. in American Studies from George Washington University (2003); her M.A. in History from the College of William and Mary (1985); and her B.A. in American Civilization from Brown University (1981). Prior to receiving her Ph.D., her work in public history focused on developing educational programs, exhibits, and teaching resources. While working at a living history farm museum in rural Maine, at Plimoth Plantation, at Elderhostel, and while serving as director of the Museum of the Southern Jewish Experience, she organized lectures, academic symposiums, study abroad programs, teacher workshops, curated exhibits, produced films and oral histories, developed classroom curriculum materials, and organized archival collections.

Her research interests include the history of the Jewish South, food in American culture, American Jewish women's history, and the foodways and material culture of the American South. In 2007, she received the University of North Carolina's Tanner Award for Excellence in Undergraduate Education. From 2006-2008, she served as President of the Southern Foodways Alliance at the University of Mississippi Center for the Study of Southern Culture.

Her publications include Matzoh Ball Gumbo: Culinary Tales of the Jewish South (UNC Press, 2005), a study of Jewish history, foodways, and culture in the American South. Matzoh Ball Gumbo was nominated for the 2006 James Beard Foundation Award in the category of "Writings on Food," and was also recognized by the International Association of Culinary Professionals with their 2006 Jane Grigson Award for distinguished scholarship in research and presentation. Dr. Ferris is co-editor of Jewish Roots in Southern Soil: A New History (University Press of New England, 2006), an anthology of contemporary scholarship on the Jewish South.

Her current work, "The Edible South: Food and History in an American Region," is a social history of southern foodways—the cultural, social and economic practices that relate to food in the American South. "The Edible South" documents both the mythic and the daily meaning of food in the lives of generations of southerners using rich archival collections on southern history and important publications on southern foodways. She is currently co-editing a related work on the foodways of North Carolina, a collection of essays by scholars, food writers, and journalists who examine the state's history and culture through its distinctive regional foodways.

She has published articles and chapters in numerous journals and anthologies, including Southern Crossroads: Perspectives on Religion and Culture, ed. Walter H. Conser Jr. and Rodger M. Payne (2008), Cornbread Nation 1, 2, 4, and 5. The Best of Southern Food Writing (2002, 2004, 2008, 2010), American Jewish Women: An Historical Reader from Colonial Times to the Present, ed. Pamela Nadell (2002), Shalom Y'all: Images of Southern Jewish Life in America, photographs by Bill Aron, edited by Vicki Reikes Fox with Bill Aron and Marcie Cohen Ferris (2002), Southern Jewish History (1998), and Southern Cultures (Guest editor, special issue on food, Winter 2009, Spring 2012).

REPORT OF THE COMMITTEE ON BUDGET AND FINANCE

Mr. Young, Chair of the Committee on Budget and Finance, thanked the members of the Board, President Ross, and Vice President Perusse and his staff for the efforts they put forth preparing materials and documents for the tuition and fees discussion. Mr. Young stated that President Ross had recognized the need to identify additional operational and academic efficiencies, to make better use of technology and online resources, and to thoroughly discuss need-based financial aid – all to ensure that the State's investment in the University was maximized. At its meeting yesterday, the Committee voted in support of the President's tuition and fees recommendations per the Authorization of Tuition for 2012-13 (see Appendix K) and the Authorization of Fees for 2012-13 (see Appendix L). Mr. Grainger put forth an amendment to cap the need-based financial aid requirement mandated by the General Assembly. The amendment did not pass.

On behalf of the Committee, Mr. Young moved that the President's recommendations on the Authorization of Tuition for 2012-13 and the Authorization of Fees for 2012-13 be approved. The motion carried. Mr. Mitchell, Dr. Roseman, and Mr. Taylor voted against the tuition and fee increases.
