

Conditional Authorization of School-Based Tuition for Doctor of Nursing Practice Programs for 2013-14

The following RESOLUTION for the 2013-14 academic year reflects the tuition increases recommended by the President after his review of tuition proposals for Doctor of Nursing Practice (DNP) programs pending their approval by the Board of Governors.

The authorization of school based tuition rates for the following DNP programs is conditional on each program's approval by the Board of Governors. The following rates are requested for all students enrolled in a Doctor of Nursing Practice at each listed campus for the 2013-14 academic year.

**RESOLUTION AUTHORIZING TUITION**

WHEREAS, G.S. 116-143 requires that the Board of Governors of the University of North Carolina shall fix the tuition and fees, not inconsistent with the actions of the General Assembly, at the constituent institutions of the University.

NOW, THEREFORE, BE IT RESOLVED, that effective with the Fall Term, 2013 the constituent institutions are authorized to charge and collect the following tuition rates.

Five campuses propose to establish school based tuition for the Doctor of Nursing Practice program pending each programs approval by the Board of Governors. The rates require Board of Governors' approval.

**East Carolina University**College of Nursing

Doctor of Nursing Practice

\$2,600 in 2013-14

ECU's College of Nursing requests to establish a school based tuition of \$2,600 for all students enrolled in its Doctor of Nursing Practice program for 2013-14 pending program approval by the Board of Governors. This increase is in addition to the tuition rate increase proposed for resident graduate students (\$214) and nonresident graduate students (\$700). The additional revenue would support financial aid, the competitive recruitment and retention of faculty members, clinical laboratory fees and equipment.

**UNC Chapel Hill**School of Nursing

Doctor of Nursing Practice

\$4,150 in 2013-14

UNC-CH's School of Nursing requests to establish a school based tuition of \$4,150 for all students enrolled in its Doctor of Nursing Practice program for 2013-14 pending program approval by the Board of Governors. This increase is in addition to the tuition rate increase proposed for resident graduate students (\$509) and nonresident graduate students (\$1,630). The additional revenue would support financial aid, a clinical site coordinator, instructional supplies and equipment.

**UNC Charlotte**School of Nursing

Doctor of Nursing Practice

\$4,800 in 2013-14

UNCC's School of Nursing requests to establish a school based tuition of \$4,800 for all students enrolled in its Doctor of Nursing Practice program for 2013-14 pending program approval by the Board of Governors. This increase is in addition to the tuition rate increase proposed for resident graduate students (\$79) and nonresident graduate students (\$79). The additional revenue would support financial aid, the competitive recruitment and retention of faculty members and student services.

**Western Carolina University**School of Nursing

Doctor of Nursing Practice

\$4,800 in 2013-14

WCU's School of Nursing requests to establish a school based tuition of \$4,800 for all students enrolled in its Doctor of Nursing Practice program for 2013-14 pending program approval by the Board of Governors. This increase is in addition to the tuition rate increase proposed for resident graduate students (\$304) and nonresident graduate students (\$305). The additional revenue would support student services and program administrative operations.

**Winston-Salem State University**School of Health Sciences

Doctor of Nursing Practice

\$2,000 in 2013-14

WSSU's School of Health Sciences requests to establish a school based tuition of \$2,000 for all students enrolled in its Doctor of Nursing Practice program for 2013-14 pending program approval by the Board of Governors. This increase is in addition to the tuition rate increase proposed for resident graduate students (\$337). WSSU does not propose an increase in 2013-14 for nonresident graduate students. The additional revenue would support instructional supplies, equipment and program operations.
