Draft Minutes

The Committee on University Governance met Thursday, April 11, 2013, at 1:30 p.m. in Room 107 of the Health Sciences Building on the University of North Carolina at Pembroke campus.

Committee members present included Chairman Powers, Mr. Blackburn, Ms. Blank, Mr. Grainger, Mr. Harrelson, Mr. McMahan, Dr. Roseman, Chancellor Becton, Chancellor Carter, and Chancellor Miller. Chairman Hans, several other Board of Governors members, and several Chancellors attended. President Ross, General Counsel Fjeld, and Secretary Corgnati attended as staff.

Approval of Minutes

Upon motion of Dr. Roseman, and seconded by Ms. Blank, the committee voted to approve the minutes of the February 7, 2013, and March 18, 2013, meetings of the committee.

2013 Trustee Selection Process

Chairman Powers invited each campus liaison to present the slate of nominations of trustees to serve on each of the sixteen constituent universities with terms beginning July 1, 2013. Each campus liaison then presented his or her nominations for the Committee to consider. See Appendix A for a recording of the vote for each campus.

Discussion of Vacancies on Boards and Councils

The committee discussed vacancies on councils and boards of trustees.

There is a partial term ending June 30, 2013, on the University of North Carolina at Pembroke Board of Trustees. This seat was vacated by Dr. Robin Cummings of Pinehurst and it will be filled by the provisional election of Michael L. Holmes of Orange Park, Florida, with a term beginning July 1, 2013.

There are nine terms ending June 30, 2013, on the North Carolina School of Science and Mathematics Board of Trustees. Action was deferred.

Chairman Hans asked the Committee to study the Board of Governors election procedures. Ms. Blank will lead a subcommittee, including Mr. McMahan and Dr. Roseman, that will review the policy and be prepared to report its findings at the committee's June meeting.

Michael D. Tanner

Deputy Director

NOAA's National Climatic Data Center

Mike is currently the Deputy Director at the National Climatic Data Center (NCDC). NCDC is the world's largest active archive of climate and weather data and provides access and stewardship to the Nation's resource of global climate and weather related data and information. NCDC monitors climate variation and change and provides this information to the United Nations World Meteorological Organization, the International Council for Science Union World Data Center System, the Global Climate Observing System, the Group on Earth Observations and other international scientific programs.

Prior to being named Deputy Director, Mike was involved in the US Global Change Research Program (USGCRP), which integrates federal research on changes in the global environment and their implications for society. Thirteen departments and agencies participate in the USGCRP and is steered by the Subcommittee on Global Change Research under the Committee on Environment and Natural Resources, overseen by the Executive Office of the President.

Before joining NCDC, Mike was the US representative at the Group on Earth Observations (GEO) Secretariat in Geneva, Switzerland serving as the Senior Scientific Expert. GEO coordinates international collaboration for Earth observations to support decision-making in an increasingly complex and environmentally stressed world. GEO provides a framework for governments and international organizations to develop new projects and coordinate their strategies and investments. GEO members include over 90 Governments, the European Commission and over 60 intergovernmental, international, and regional organizations.

Previously, Mike was the Director of the Technology, Planning and Integration Office which led the development of the NOAA integrated Earth Observation System Architecture and Data Management System Architecture. He provided recommendations to NOAA senior leadership on requirements, architectures, and acquisitions to meet national and international Earth observational needs. Mike regularly represented NOAA to Congress, the White House Office of Management and Budget, and the Executive Office of the President.

Mike also served as co-chair of the USGEO Strategic Assessment Group, providing the US strategic earth observation portfolio recommendation to the Executive Office of the President. Recently, Mike served on the Committee on Earth Observation Satellites Strategic Implementation Team, coordinating international satellite activities.

Prior to joining NOAA, Mike served at NASA Headquarters as the Associate Director of Program, Analysis and Evaluation and as the Program Executive of the Earth Observation System Program where he managed the development and launch of NASA's current climate satellites on orbit today.

During the Hurricane Katrina recovery effort, Mike volunteered for the Federal Emergency Management Administration (FEMA). He served as an authorized representative of FEMA in Texas, as the program manager for all Texas-based contracts valued over \$4.5 Billion; as well as point of contact with public officials, major media organizations and local relief organizations.

Mike earned a Bachelor of Science degree from the University of Notre Dame and a Masters Degree in Research and Development Engineering Management. Mike is a certified NASA Program Manager, a life member of the American Institute of Aeronautics and Astronautics, a member of the National Space Foundation, and is a 3rd degree black belt in Karate.

Mike is a veteran of the United States Air Force; his honors and awards include the NOAA Employee of the Month Award, NASA Office of Earth Science Outstanding Engineer Award, the National Space Club Award for Outstanding Aerospace Achievement, the Aviation Week and Space Technology Aerospace Laurel Award, the United States Air Force Defense Meritorious Service Medal, the Cold War Service Medal, and the Gulf War Service Medal.

W. Fitzhugh Brundage (reappointment)

W. Fitzhugh Brundage is the William B. Umstead Professor of History at the University of North Carolina at Chapel Hill. As of July 1, 2013, he will Chair of the Department of History. He joined the faculty in 2002. Prior to that he taught at the University of Florida and at Queens University in Kingston, Ontario. He was educated at the University of Chicago and Harvard University, and is the author of *Lynching in the New South* (1993), *A Socialist Utopia in the New South* (1997), and *The Southern Past* (2005). He is also the editor of four collections of essays, including *Beyond Blackface: African Americans and the Creation of American Popular Culture*, 1890-1930 (2011). Although Virginia is his home, he has lived in Mexico, Brazil, Costa Rica, and Canada. He has a thirteen-year-old son.

Sherman A. James (reappointment)

Sherman A. James is the Susan B. King Professor of Public Policy in the Sanford School of Public Policy, Duke University. Prior to joining Duke University, he taught at the University of North Carolina at Chapel Hill (1973–1989) and at the University of Michigan (1989–2003). At Michigan, he was the John P. Kirscht Collegiate Professor of Public Health with joint appointments in the Departments of Epidemiology and Health Behavior & Health Education in the School of Public Health. He was also a Senior Research Scientist in the Survey Research Center at the Institute for Social Research. Dr. James' research focuses on the social determinants of racial and ethnic health inequities and community and policy-level interventions designed to minimize these inequalities.

Dr. James was elected to the Institute of Medicine of the National Academy of Sciences in 2000. In 2001, he received the Abraham Lilienfeld Award from the Epidemiology section of the American Public Health Association for career excellence in the teaching of epidemiology. He is a fellow of the American Epidemiological Society, the American College of Epidemiology, the American Heart Association, and the Academy of Behavioral Medicine Research. He has served as Associate Editor of *Ethnicity & Disease, the American Journal of Public Health*, and was the Guest Editor of the 2009 edition of *Epidemiologic Reviews*. A Social Epidemiologist, Dr. James received his PhD (Social Psychology) from Washington University, in St. Louis (1973.) In 2008, he received a Health Policy Investigator Award from the Robert Wood Johnson Foundation, and was also named a Distinguished Alumnus by Washington University in St. Louis.

Lisa A. Levenstein (new appointment)

Lisa Levenstein is associate professor of U.S. women's history at the University of North Carolina at Greensboro. She received her Ph.D. in 2002 from the University of Wisconsin at Madison, home to the first doctoral program in women's history in the nation. Levenstein's book, *A Movement Without Marches: African American Women and the Politics of Poverty in Postwar Philadelphia* (UNC Press, 2009), was co-winner of the Kenneth Jackson Book Award from the Urban History Association and received an Honorable Mention for the Frederick Jackson Turner Award from the Organization of American Historians. She has published award-winning articles in Feminist Studies and the Journal of Women's History and recently co-authored, "The Big Tent of U.S. Women's and Gender History: A State of the Field," Journal of American History (December 2012). Levenstein has received many grants to support her forthcoming article on 1970s feminism in the Journal of American History and her current book project on the Beijing Women's Conference of 1995. She is a member of the board of contributing editors for *Labor: Studies in Working-Class History of the Americas* and of the editorial board of the *Pennsylvania Magazine of History and Biography*.
