focusing on total headcount and specific, strategic areas.


Assessment: Overall headcount enrollment decreased slightly over the prior year, total minority

# The University of North Carolina Fall 2013 Enrollment Report

#### **Executive Summary**

In accordance with the University of North Carolina General Administration's (UNC GA) responsibility to report to the Board of Governors (BoG), elected officials, and the general public, the Fall 2013 Enrollment Report presents the trends in enrollment across the system, focusing on total headcount and specific, strategic areas. The following areas are detailed throughout the report:

- Enrollment. The Fall 2013 total UNC headcount enrollment was 220,121 students, a decrease of 889 students or 0.4% from the previous fall.
  - Nine campuses saw their total student headcount decrease and seven saw headcount increases.
- Enrollment by Race. The total enrollment of minority students for Fall 2013 was 72,046, an increase of 931 students (+1.3%) from the previous year.
- Resident/Non-Resident First-Time, Full-Time Freshmen. Of new freshmen, 86.7% were from North Carolina and 13.3% were from out-of- state. This year, no UNC campus exceeded the 18 percent cap on the number of freshmen from out-of-state, as set forth in UNC Policy.
- Transfer Students. The number of transfer students entering UNC institutions grew to 14,955 in Fall 2013, an increase of 1.4%.

#### Fall 2013 Headcount Enrollment




Figure 1 - UNC Enrollment Trends, 2003 - 2013

UNC's Fall 2013 total headcount enrollment was 220,121 students, a decline of 889 students (-0.4%) from Fall 2012. This decrease approximates the previous year's increase (+0.3%) reflecting recent trends of flat enrollment seen in Figure 1. From 2003 to 2009 enrollment grew approximately 20%, but over the past four years remained relatively stable.

From Fall 2012 to Fall 2013, undergraduate enrollment declined from 175,760 to 175,328, a decrease of 432 students or -0.2% (compared to 0.5% increase the previous year). Recent North Carolina high school graduates continued to matriculate to UNC, comprising approximately 25% of new students in Fall 2013. High school enrollment at UNC constituent institutions was 949 (270 at UNCSA and 679 at NCSSM).

Master's level enrollment decreased for the fourth consecutive year, dropping to 31,268 (-2.1%). A large share was driven by decreases in Master's in Education programs, which was partially offset by increases in the fields of Business and Computer/Information Sciences.

In Fall 2013, nine campuses saw their total student headcount decrease and seven saw headcount increases from the previous year. Individual campus Fall 2013 enrollment figures may be found in Appendix A and Figures 2-4 present these numbers by broad Carnegie classification and degree-level.

Figure 2: Headcount Enrollment by Degree-level, Research Institutions (Fall, 2013)




Figure 4: Headcount Enrollment by Degree-level, Baccalaureate Institutions (Fall, 2013)





Figure 3: Headcount Enrollment by Degree-level, Master's Institutions (Fall, 2013)

#### **Enrollment by Race**

The total minority student enrollment in Fall 2013 was 72,046, an increase of 931 students (+1.3%) from the previous year. The total headcounts and percent changes are:

- White: 133,369 (- 1.0% or 1,431 students)
- Black/African American: 45,729 (- 2.2% or 994 students)
- American Indian: 2,036 (- 1.9% or 40 students)
- Asian: 7,716 (+ 3.5% or 258 students)
- Hispanic/Latino: 10,424 (+ 7.9% or 766 students)
- Other: 20,847 (+ 2.7% or 551 students)

System-wide, African American enrollment decreased for the fourth consecutive year while Latino students continued to enroll at UNC institutions at higher rates. System-wide, 53.4% of African Americans are enrolled historically black institutions and 46.6% are enrolled in predominantly white institutions.

Taken as a whole, Black/African American, American Indian, and Hispanic/Latino UNC students remain under-represented when compared to their representation in the North Carolina population (US Census 2010). Disaggregating these categories by age yields additional insight, notably:

- Compared to state-wide Census figures:
  - Asians make up a larger share of the UNC population, or are overrepresented. A pattern that persists across all age categories.
  - Hispanic/Latino students comprise a smaller share of the UNC population, or are underrepresented. A pattern persisting across all age categories, despite gains in headcount.
  - Black/African American and American Indians remain underrepresented in UNC's traditionally aged college-going population (ages 18-34).
    - » Black/African American and American Indian students comprise larger shares of the UNC population between the ages of 35 and 65.

Male student enrollment had a slight decline, decreasing by 207 students across the system. Reflecting national trends, female enrollment continued to be larger, comprising 56.6% of Fall 2013 enrollment.

Figures 5-7 show enrollment of racial minorities across the UNC institutions. Speaking broadly, these populations reflect the historical mission of institutions, geographical location, and changing population of the state.

The category "Other" includes non-resident Aliens, two or more reported races, race unknown, and asian/pacific islander.

Figure 5: Headcount Enrollment by Race, Research Institutions (Fall, 2013)




Figure 7: Headcount Enrollment by Race, Baccalaureate Institutions (Fall, 2013)





Figure 6: Headcount Enrollment by Race, Master's Institutions (Fall, 2013)

#### Resident/Non Resident First-Time, Full-Time Freshmen

Of new freshmen, 86.7% were from North Carolina and 13.3% were from out-of-state. In Fall 2013, no UNC institution exceed the 18% cap for out-of-state students (UNCSA has a special provision). The following table presents data for all Fall 2013 first-time, out-of-state, degree seeking undergraduate students at UNC campuses.

#### **Transfer Students**

Annually, UNC GA provides a detailed transfer report to the BoG. We will continue to produce this report, but given the importance of transfer students to UNC's strategic planning, we offer a brief snapshot using Fall Enrollment numbers. In general, most transfer students matriculate from the NCCCS, reflecting our long-standing and nationally recognized articulation agreement. The share of all transfer students originating from the community college sector has continued this steady growth as students transferring from elsewhere have declined. The following are some of the key transfer student headcount numbers for Fall 2013.

- The number of transfer students entering UNC institutions grew to 14,955 over the previous year (+1.4%).
  - The total number of transfer students new to the UNC system saw a slight increase from 12,471 in Fall 2012 to 12,722 in Fall 2013.
    - » 2,233 enrolled students are UNC to UNC transfers (-2.0%).
- NCCCS to UNC transfers increased to 8,383 (+6.0%).
- Transfers from NC Private institutions to UNC declined to 1,152 (-1.7%).
- Out-of-state student transfers declined to 3,187 (-6.1%).
