#### STRATEGIC DIRECTIONS DASHBOARD REPORTS

Report package comprises:

- Strategic Directions Dashboard Summary Report: Top level, one-page report summarizing overall status of the Strategic Plan project portfolio at the goal level.
- 2. Strategic Directions Dashboard Drill-Down Report: Detailed report providing implementation information for each Action Item in the Strategic Plan. Information is organized according to Implementation Category (Completed, Underway or in planning with existing resources, Funded by \$3M Strategic Plan budget, On-hold due to insufficient resources).
- Attachment Strategic Plan Action Items: Action Item verbiage in reports is condensed, and some Action Items have been consolidated. Attachment provides a full description of each Action Item, as reflected in the Strategic Directions Plan, and also specifies the Action Items that have been consolidated.



#### **IMPLEMENTATION CATEGORIES**

This color code corresponds with the Implementation Categories in the Strategic Plan Dashboard Reports (distributed separately):

- Complete
- Underway or in planning with existing resources

#### TRACKING OF CHANGES
