Situation: Presentation of the Fall 2014 Preliminary Enrollment Numbers.

Background:

Each fall, General Administration collects preliminary student counts from the campuses. These numbers often change between this preliminary collection and the final, reconciled numbers that campuses report later in the fall. However, the preliminary numbers serve as a good gauge of the direction and magnitude of growth in the student counts.

Assessment:

Enrollment system-wide continues to be relatively steady, with estimated growth of about 0.6% in fall 2014, or nearly 1,400 additional students (compared to fall 2013). By comparison, at this time last year, the estimated change over the prior year was a 0.6% decline in total enrollment.

- Undergraduate enrollment growth has increased, however. Overall undergraduate enrollment is up an estimated 1.3% (over 2,200 additional undergraduates), and new freshmen enrollment is up an estimated 2.6% (almost 800 additional new freshmen).
- Graduate student enrollment continues to drop slightly, nearly 1.8% estimated decline this year (a drop of over 800 students).

More comprehensive data, including detail about enrollment by degree program and demographic characteristics of the student body, will be available later in the fall.
