

5. UNC Degree Program Proposals Courtney Thornton

Situation: Appalachian State University requests authorization to discontinue four degree programs. East Carolina University and UNC-Chapel Hill each request authorization to discontinue one degree program. UNC Greensboro requests authorization to discontinue seven degree programs. These discontinuation requests were made outside of the current Low Productivity Review process.

Background: Appalachian State University recommends discontinuation of the following degree programs:

- BS in Health Education, Secondary Education
- BA in Appalachian Studies
- BS in Business Education
- BS in Child Development: Birth-Kindergarten

Students will be able to complete their course of study via another degree program or via a standard teach-out plan. With one exception, the BS in Health Education, Secondary Education at ASU, no faculty or staff will be reassigned or lost and no funding reallocated as a result of these discontinuations. In that one case, faculty will be reassigned across colleges as a result of the consolidation.

East Carolina University recommends discontinuation of the BS in Hispanic Studies in favor of a consolidated Foreign Languages and Literatures program (separate agenda item for approval).

UNC-Chapel Hill recommends discontinuation of the MS in Oral and Maxillofacial Surgery. No students are currently enrolled in the program.

UNC Greensboro recommends discontinuation of the following degree programs:

- MS in School Counseling
- MS in Student Development in Higher Education
- EdS in School Counseling
- EdS in Student Development in Higher Education
- EdD in School Counseling
- EdD in Student Development in Higher Education
- EdD in Community Counseling

UNCG will offer single MS and EdS programs in Counseling with various tracks. The EdD programs have no students enrolled, as students are served by the PhD in Counseling and Counselor Education.

Assessment: Discontinuation of the programs is recommended.

Action: This item requires a vote.

**Request for Authorization to Discontinue the
Bachelor of Arts in Appalachian Studies at
Appalachian State University**

Appalachian State University has requested that its BA in Appalachian Studies (CIP 05.0199) be discontinued.

The BA in Appalachian Studies did not draw sufficient student enrollments to continue. Students currently enrolled in the BA will be able to complete their program, as course offerings remain available and contribute to other majors and minors on campus.

Recommendation: It is recommended that the Board of Governors approve Appalachian State University's request to discontinue the BA in Appalachian Studies.

**Request for Authorization to Discontinue the
Bachelor of Science in Business Education at
Appalachian State University**

Appalachian State University has requested that its BS in Business Education (CIP 13.1303) be discontinued.

The BS in Business Education will become a track in a consolidated BS in Career and Technical Education degree program. Hence, students currently enrolled in the BS will be able to complete their program of study.

Recommendation: It is recommended that the Board of Governors approve Appalachian State University's request to discontinue the BS in Business Education.

**Request for Authorization to Discontinue the
Bachelor of Science in Child Development: Birth-Kindergarten at
Appalachian State University**

Appalachian State University has requested that its BS in Child Development: Birth-Kindergarten (CIP 13.1209) be discontinued.

The BS in Child Development: Birth-Kindergarten program exhibited consistent low enrollments. No students are currently enrolled in the program. A Birth-Kindergarten concentration is being made available within the existing BS in Child Development degree program.

Recommendation: It is recommended that the Board of Governors approve Appalachian State University's request to discontinue the BS in Child Development: Birth-Kindergarten.

**Request for Authorization to Discontinue the
Bachelor of Science in Health Education, Secondary Education at
Appalachian State University**

Appalachian State University has requested that its BS in Health Education, Secondary Education (CIP 13.1307) be discontinued.

The BS in Health Education, Secondary Education will combine with the BS in Physical Education, and the program will be renamed BS in Health and Physical Education, K-12. This will result in a single degree program with healthy enrollments and more marketable graduates.

Recommendation: It is recommended that the Board of Governors approve Appalachian State University's request to discontinue the BS in Health Education, Secondary Education.

**Request for Authorization to Discontinue the
Bachelor of Arts in Hispanic Studies at
East Carolina University**

East Carolina University has requested that its BA in Hispanic Studies (CIP 16.0905) be discontinued.

The BA in Hispanic Studies will become a track in a consolidated Foreign Languages and Literatures program. Hence, students currently enrolled in the BA will be able to complete their program of study.

Recommendation: It is recommended that the Board of Governors approve East Carolina University's request to discontinue the BA in Hispanic Studies.

**Request for Authorization to Discontinue the
Master of Science in Oral and Maxillofacial Surgery at
University of North Carolina at Chapel Hill**

University of North Carolina at Chapel Hill has requested that its MS in Oral and Maxillofacial Surgery (CIP 50.1501.123.907) be discontinued.

The master's level credential in surgery is not needed, as students instead enter a combined 6-year clinical certificate and M.D. program. No students are currently enrolled in the program.

Recommendation: It is recommended that the Board of Governors approve University of North Carolina at Chapel Hill's request to discontinue the MS in Oral and Maxillofacial Surgery.

University of North Carolina at Greensboro has requested that its MS in School Counseling (CIP 13.1101) be discontinued.
