- 1. Mrs. Cates moved, seconded by Dr. Flood, that the minutes of the meeting of May 14, 2004, be approved. The motion carried.
- 2. <u>State Legislative Update</u> Mark Fleming, Associate Vice President for State Governmental Affairs, provided an update regarding the current legislative session. The Conference Committee is close to reaching an agreement on the budget. Both the House and Senate budgets were favorable for the University. We have been told that the final budget will include a small cut to the campuses, while funding several important initiatives that were recommended in the Board's Supplemental Budget request. We also expect full funding for enrollment growth, increased recurring funds for the distinguished professorships program, and financial aid funding from the Escheats fund. The chancellors and Board members were thanked for contacting legislators regarding the University's position on key issues. Mr. Fleming stated that there were several other issues that remain unresolved including the capital projects bill.
- 3. Federal Update Kimrey Rhinehardt, Assistant Vice President for Federal Relations, gave a status report on where Congress is regarding the Appropriations process, and reauthorization of the Higher Education Act.
