## Amendments to the Budget Request of the Board of Governors

In a letter to Mr. David H. Murdock, Chairman and Chief Executive Officer of Dole Foods Company, Senate President Pro Tempore Marc Basnight and Speaker of the House of Representatives James B. Black stated the following in relation to the projects underway in Kannapolis.

We appreciate your offer to help supply our campuses with the research infrastructure they need to fulfill the research component of this project. Please know that we take very seriously our responsibility to fund higher education in our state, and we believe that the state also should play an active role in supporting our universities' role in this collaboration. To that end, we are prepared to work together and put forth our very best efforts during the 2006 legislative session to secure funding...to support our universities' participation in this partnership, with the understanding that the campuses also have an obligation to seek additional monies from federal, private, or other sources to complement the legislature's commitment and your commitment.

The funds requested referenced in the letter would provide for both recurring and nonrecurring expenses associated with the UNC Nutrition Institute and the N.C. State Institute for Advanced Horticultural Science, as well as competitive research grants for other institutions – see attached spreadsheet.

It is recommended that the Board's Budget Request to the General Assembly for the 2006 Session be amended to include the requests for funds for the UNC Nutrition Institute and the N.C. State Institute for Advanced Horticultural Science.
