(3) of The Code of the University of North Carolina, I am writing to inform you of a vacancy on the Board of Trustees of The University of North Carolina at Greensboro. Mr. Hudnall Christopher has tendered his resignation from the Board of Trustees effective October 1, 2006.

Mr. Christopher was elected by the Board of Governors on February 14, 1997 to fill an unexpired term through June 30, 1999. He was reelected by the Board of Governors for a full term, beginning July 1, 1999 and expiring June 30, 2003 and reelected for a second term beginning July 1, 2003 with a term to expire June 30, 2007. Mr. Christopher has been a valuable member of UNCG's Board of Trustees and his talents will be greatly missed.

While we do not have a candidate for recommendation at this time, we feel confident we will soon. Our office will notify you as soon as it is feasible.
