SUBJECT: Tuition Rates for 2011-12 and
Tuition Bill Statement

North Carolina General Statute 116-11(7) requires that the Board of Governors set tuition and required fees at the institutions, not inconsistent with actions of the General Assembly. As you plan for the 2011-12 fiscal year, please note that tuition and fees were approved by the BOG at their meeting on February 11, 2011. These BOG approved rates are not considered final until the legislature adjourns. Unless the legislature makes a change between now and when you have to bill your students for the Fall 2011 semester, you should use the BOG approved rates for billing purposes, unless otherwise notified.

In accordance with established practice, all tuition bills submitted by the institutions are required to have imprinted upon the bill our standardized statement of support. The following language is required:

(Institution) is a publicly supported institution. Tuition payments and other required student fees meet only a part of the total cost of the education of students enrolled. On average, for each full-time student enrolled in an institution of The University of North Carolina, the State of North Carolina appropriated \$12,868 per year in public funds to support the educational programs offered.

The University of North Carolina Board of Governors adopted a plan to make tuition and fee rates for undergraduate North Carolinians predictable and affordable. Pursuant to the Plan, the maximum rate of annual increase for campus-initiated tuition and general fees (Athletics, Health Services, Student Activities, and Educational and Technology Fees) for undergraduate resident students is 6.5%. Specific information, including maximum allowable increases in tuition and fees per academic year by UNC campuses is available at www.northcarolina.edu/finance.

Tuition and fee rates included in this bill are based on rates approved by the Board of Governors in February 2011. G.S. 116-11(7) requires that the Board of Governors set tuition and required fees at the institutions, not inconsistent with actions of the General Assembly.

This statement has been revised to reflect the latest State appropriations per budgeted full-time equivalent student. The revised amount for State support should be included in your next printing/billing cycle.
