**Request for Authorization to Establish the  
Bachelor of Arts in Theatre at  
North Carolina Central University**

North Carolina Central University has requested establishment of the BA in Theatre (CIP 50.0501).

The BA in Theatre degree program was first established at NC Central University in 1972. It was discontinued in error during the Academic Degree Program Productivity Review earlier this year. Board action is required to reinstate the program. NCCU has an ongoing effort to transition to a Department of Theatre and Dance and a corresponding degree program. Once reinstated, the BA in Theatre degree program will accept the Dance concentration from the physical education degree program.

**Recommendation:** It is recommended that the Board of Governors approve North Carolina Central University's request to establish the BA in Theatre.

The Board of Governors of the University of North Carolina is charged under North Carolina General Statute Section 116-15 with responsibility for licensing nonpublic educational institutions to conduct post-secondary degree activity in North Carolina. In November 2004, the Board of Governors approved revisions to the document, *Rules and Standards for Licensing Nonpublic Institutions to Conduct Post-Secondary Degree Activity in North Carolina*. This document provides the guidelines for interpreting the standards, and the rules, regulations, and procedures under which the Board issues licenses to institutions to conduct post-secondary degree activity in North Carolina.

Columbia College is proposing that the following degree programs be licensed in North Carolina:

- Bachelor of Arts in Criminal Justice
- Bachelor of Arts in Emergency Management
- Certificate in Criminal Justice
- Certificate in Emergency Management

Dr. Tim Gallimore reviewed the application and appointed a team of examiners to determine if Columbia College complied with the licensure standards outlined in the Rules and Standards. On February 4, 2015, the team of examiners visited the Columbia College campus in Columbia, SC. Following the site visit, the team of examiners issued its report which contained recommendations. For more details on the degree programs and report, please review the summary.

Thus, I recommend to the Committee on Educational Planning, Policies, and Programs of the UNC Board of Governors that a regular license be issued to Columbia College to offer the above-named degree programs in North Carolina subject to annual reports and review at any time. The programs will be reviewed within two calendar years of the initiation in North Carolina to judge whether the institution continues to maintain standards for licensure.

## SUMMARY OF VISIT OF TEAM OF EXAMINERS FOR COLUMBIA COLLEGE

### BACKGROUND INFORMATION

Columbia College, a private institution affiliated with the South Carolina Conference of the United Methodist Church, is a not-for-profit corporation chartered under the laws of the State of South Carolina. The college was founded in 1854 and is one of the South's oldest institutions devoted to higher education of women. Columbia College now encompasses the Women's College (featuring on-campus residential daytime degree programs offered exclusively for traditionally-aged female students), and the Evening College, Graduate School, and Online Programs serving both women and men. Columbia College is accredited by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC).

### THE APPLICATION AND SITE VISIT

Columbia College is proposing to offer the following online degree programs in North Carolina:

- Bachelor of Arts in Criminal Justice
- Bachelor of Arts in Emergency Management
- Certificate in Criminal Justice
- Certificate in Emergency Management

As stipulated by the Rules and Standards: Licensing Nonpublic Institutions to Conduct Post-Secondary Degree Activity in North Carolina, a team of examiners was appointed to review the application, visit the institution, and evaluate compliance with the licensure standards.

The team of examiners conducted a site visit at Columbia College, Columbia, South Carolina, on February 4, 2015. The Team evaluated the facilities and resources of the college during its site visit, and reports and documents before and during the visit, including the following: The licensure/compliance application and accompanying exhibits; course syllabi; faculty credentials; library resources; budget data; annual financial reports; various bulletins, including the *Columbia College Bulletin, Online Programs 2014-2015*; and the *Columbia College of South Carolina Faculty Manual 2014/2015*.

During the visit, the team of examiners met with numerous administrators, faculty and staff members, and students of Columbia College.

### **PROPOSED DEGREE PROGRAMS**

The Bachelor of Arts in Criminal Justice and the Bachelor of Arts in Emergency Management degree programs each consist of 127 semester credit hours, as follows: the 33 semester hour general education component, a 21 semester hour major core, one three hour course in leadership, 15 hours of major electives, and 55 hours of general electives.

### **RECOMMENDATIONS**

After the site visit, the team of examiners submitted its *Report to the President of The University of North Carolina from the Team of Examiners to Review Columbia College's Proposed Bachelor of Arts in Criminal Justice, Bachelor of Arts in Emergency Management, Certificate in Criminal Justice, and Certificate in Emergency Management Programs to Be Offered Online in North Carolina*. In the report, the team of examiners included 11 recommendations regarding the proposed degree programs. The recommendations addressed issues of faculty qualifications, student learning outcome assessment, remaining items of documentation to be submitted to UNC General Administration, and information to be provided in the college's catalog/materials for North Carolina students.

After receiving the team of examiners' report, Columbia College responded to the recommendations. Upon reviewing the college's response, the team and UNC General Administration agreed that all recommendations have been satisfactorily implemented, and the team recommends that Columbia College be licensed to offer above listed online degree programs.

Dr. Tim Gallimore, Associate Vice President for Academic Planning & State Authorization, agrees with the team's review and recommendations. Thus, General Administration recommends licensure of the proposed online degree programs listed above, to be offered by Columbia College to students in North Carolina.

An appropriate review will be performed within two calendar years of the initiation of the licensed degree programs, by a team of examiners with expertise in the field, to ascertain the college's compliance with the *Rules and Standards*, including the recommendations contained in the report.

During the visit, the team of examiners met with numerous administrators, faculty and staff members, and students of Kaplan University.

## **PROPOSED DEGREE PROGRAMS**

### **Master of Science in Nursing**

Each of the proposed Master of Science in Nursing (MSN) degree program has a 30 quarter credit hour core and a set of concentration specialty courses. The set of concentration specialty courses is the same set of courses that comprise the graduate certificate program in each specialty area. The quarter credit hours for the five MSN programs are as follows:

Family Nurse Practitioner MSN: 90; Certificate Program: 60  
 Adult Gerontology Nurse Practitioner MSN: 90; Certificate Program: 60  
 Nurse Educator MSN: 75; Certificate Program: 45  
 Executive Leader MSN: 60; Certificate Program: 30  
 Informatics MSN: 60 (No certificate program)

### **Master of Science in Psychology**

The Master of Science in Psychology requires 75 quarter credit hours for the thesis track and 70 for comprehensive exam track; 40 quarter credit hours are required for the Graduate Certificate in Addictions.

The Master of Science in Psychology curriculum includes 65 quarter credit hours, 35 quarter credit hours for the Postgraduate Certificate in Applied Behavior Analysis, and 30 quarter credit hours for the Graduate Certificate in Industrial/Organizational Psychology.

### **Master of Science in Higher Education**

The Master of Science in Higher Education-Student Affairs degree program consists of (a) 61 graduate quarter hours credit in student affairs-specific course work, plus 16 hours of field experience, (b) development of a portfolio, (c) completion of field experiences, and (d) exit evaluation activities.

### **RECOMMENDATIONS**

After the site visit, the team of examiners submitted its *Report to the President of The University of North Carolina from the Team of Examiners to Review Kaplan University's Proposed Associate of Applied Science in Health Information Technology; Associate of Applied Science, and Certificate, in Medical Assisting; Associate of Applied Science in Medical Office Management; Master of Public Health; Master of Science in Nursing in Informatics; Master of Science in Nursing, and Certificate, in: Family Nurse Practitioner, Adult Gerontology Nurse Practitioner, Nurse Educator, and Executive Leader; Master of Science in Nursing to Doctor of Nursing Practice; Doctor of Nursing Practice; Master of Science in Higher Education-Student Affairs; Master of Science in Psychology, and Graduate Certificate in: Addictions, and Industrial/Organizational Psychology, and Postgraduate Certificate in Applied Behavior Analysis Psychology Programs to Be Offered Online in North Carolina.*

In the report, the team of examiners included 47 recommendations and 8 suggestions regarding the proposed degree programs. The recommendations addressed issues of program curriculum, faculty qualifications, student services, tuition guaranty bond, pending litigation, financial stability, business practices, remaining items of documentation to be submitted to UNC General Administration, and information to be provided in the college's catalog/materials for North Carolina students.

After receiving the team of examiners' report, Kaplan University responded to the recommendations. Upon reviewing the university's response, the team and UNC General Administration agreed that all recommendations have been implemented, and the team recommends that Kaplan University be licensed to offer above listed degree programs.

Dr. Tim Gallimore, Associate Vice President for Academic Planning & State Authorization, agrees with the team's review and recommendations. The General Administration recommends licensure of the proposed degree programs listed above, to be offered by Kaplan University to students in North Carolina.

An appropriate review will be performed within two calendar years of the initiation of the licensed degree programs, by a team of examiners with expertise in the field, to ascertain the university's compliance with the *Rules and Standards*, including the recommendations contained in the report.

During the visit, the team of examiners met with numerous administrators, faculty and staff members, and students of the Medical University of South Carolina.

## **PROPOSED DEGREE PROGRAM**

### Registered Nurse to Bachelor of Science in Nursing

The Registered Nurse to Bachelor of Science in Nursing (RN-BSN) program requires three continuous semesters of online education (a total of 30 semester credit hours) for completion. The program only admits registered nurses who are graduates of an accredited associate degree or diploma program in nursing. The RN-BSN program is a "transfer-in" baccalaureate program, with the admitted students having already completed their general education requirements, as established by the program's entrance criteria.

## **RECOMMENDATIONS**

After the site visit, the team of examiners submitted its *Report to the President of the University of North Carolina from the Team of Examiners to Review the Medical University of South Carolina's Proposed Registered Nurse to Bachelor of Science in Nursing (RN-BSN) and Doctor of Nursing Practice (DNP) Programs, to Be Offered Online in North Carolina*. In the report, the team of examiners included 12 recommendations and six suggestions addressing the proposed degree programs. The recommendations addressed issues of faculty credentials and experience, audited financial statements, the tuition guaranty bond, remaining items of documentation to be submitted to UNC General Administration, and information to be provided in the university's catalog/materials for North Carolina students.

After receiving the team of examiners' report, the Medical University of South Carolina responded to the recommendations and suggestions. Upon reviewing the university's response, the team and UNC General Administration agreed that all recommendations have been satisfactorily implemented, and the team recommends that the Medical University of South Carolina be licensed to offer the RN-BSN online degree program.

Dr. Tim Gallimore, Associate Vice President for Academic Planning & State Authorization, agrees with the team's review and recommendations. Thus, General Administration recommends licensure of the proposed online degree program listed above, to be offered by the Medical University of South Carolina to students in North Carolina.

An appropriate review will be performed within two calendar years of the initiation of the licensed degree program, by a team of examiners with expertise in the field, to ascertain the Medical University of South Carolina's compliance with the *Rules and Standards*, including the recommendations contained in the report.

The Board of Governors of the University of North Carolina is charged under North Carolina General Statute Section 116-15 with responsibility for licensing nonpublic educational institutions to conduct post-secondary degree activity in North Carolina. In November 2004, the Board of Governors approved revisions to the document, *Rules and Standards for Licensing Nonpublic Institutions to Conduct Post-Secondary Degree Activity in North Carolina*. This document provides the guidelines for interpreting the standards, and the rules, regulations, and procedures under which the Board issues licenses to institutions to conduct post-secondary degree activity in North Carolina.

South College-Asheville is proposing that the following degree programs be licensed in North Carolina:

- Bachelor of Science in Health Sciences (Post Physical Therapist Assistant), and
- Associate of Applied Science in Diagnostic Medical Sonography

Dr. Tim Gallimore reviewed the application and appointed a team of examiners to determine if South College-Asheville complied with the licensure standards outlined in the Rules and Standards. On March 26, 2015, the team of examiners visited the South College-Asheville campus in Asheville, NC. Following the site visit, the team of examiners issued its report which contained recommendations. For more details on the degree programs and report, please review the summary.

Thus, I recommend to the Committee on Educational Planning, Policies, and Programs of the UNC Board of Governors that a regular license be issued to South College-Asheville to offer the above-named degree programs in North Carolina subject to annual reports and review at any time. ### **BACKGROUND INFORMATION**

South College-Asheville is a private, for-profit, coeducational, nonsectarian academic institution, founded in Asheville, North Carolina in 1905 as Cecils Business College. It was renamed Cecils Junior College in 1975, after receiving degree-granting authority from the University of North Carolina Board of Governors. In 1998, South College of North Carolina, Inc. purchased Cecils College, and in 2002, the college was renamed South College-Asheville. The college offers three certificate programs, ten associate's degrees, and four bachelor's degrees. The college is accredited by the Accrediting Council for Independent Colleges and Schools.

### **THE APPLICATION AND SITE VISIT**

faculty credentials; library resources; budget data; annual financial reports; various bulletins, including the *South College-Asheville Faculty Handbook, Revised January 2014*; and *South College-Asheville 2013-2015 Catalog, Volume 43*.

During the visit, the team of examiners met with numerous administrators, faculty and staff members, and students of South College-Asheville.

## **PROPOSED DEGREE PROGRAMS**

### **Bachelor of Science in Health Sciences (Post Physical Therapist Assistant)**

The core curriculum of the proposed BSHS (Post PTA) program includes 78 quarter hours of general education courses: math and statistics (12 quarter credit hours), English Composition (8 hours), Anatomy & Physiology (12 hours), other Science (30), Humanities (8 hours), and Psychology (8 hours). Students take an additional 48 quarter hours in the curriculum (in addition to the 81 credits earned in the PTA major), for a total of 207 quarter credit hours for the degree.

### **AAS in Medical Sonography**

The proposed AAS degree meets North Carolina state requirements regarding the number of credits, with 46 general education credits and 79 core/major education credits. The variety of courses offered is also in compliance with North Carolina state requirements. This program also meets national program accreditation standards.

## **RECOMMENDATIONS**

After the site visit, the team of examiners submitted its *Report to the President of The University of North Carolina from the Team of Examiners to Review South College-Asheville's Proposed Programs to be Offered in North Carolina: Bachelor of Science in Health Sciences (Post Physical Therapist Assistant) and Associate of Applied Science in Diagnostic Medical Sonography*. In the report, the team of examiners included 19 recommendations and 4 suggestions regarding the proposed degree programs. The recommendations addressed issues of program curriculum, faculty qualifications, insurance and tuition guaranty bond, remaining items of documentation to be submitted to UNC General Administration, and information to be provided in the college's catalog/materials for North Carolina students.

After receiving the team of examiners' report, South College responded to the recommendations. Upon reviewing the college's response, the team and UNC General Administration agreed that all recommendations have been implemented, and the team recommends that South College-Asheville be licensed to offer above listed degree programs.

Dr. Tim Gallimore, Associate Vice President for Academic Planning & State Authorization, agrees with the team's review and recommendations. The General Administration recommends licensure of the proposed degree programs listed above, to be offered by South College-Asheville to students in North Carolina.
