AGENDA ITEM

Situation: The Committee will review proposed revisions to Section 200.7 of the UNC Policy

Manual (Duties, Responsibilities, and Expectations of Board Members). The proposed changes seek to improve the effectiveness and clarity of the policy. The Committee reviewed proposed revisions to the policy during its May 2020 meeting and suggested

additional revisions, which are included in the new proposal.

Background: Section 200.7 of the UNC Policy Manual details the duties and responsibilities of

members of the Board of Governors, boards of trustees of constituent institutions, and the boards of University-affiliated organizations. The policy also establishes the bases and procedures for board member sanctions, including removal or recommendation for

removal.

Assessment: The draft revisions to Section 200.7 of the UNC Policy Manual expand and clarify the

duties and responsibilities of board members. The changes would also establish a more detailed process for receipt, review, and consideration of complaints against board members. The revisions clarify the Board's authority to impose sanctions, including interim sanctions, removal, or recommendation for removal, within the Board's

discretion.

Action: This item requires a vote by the committee and a vote by the full Board of Governors at

the next meeting.

Policy on Duties, Responsibilities, and Expectations of Board Members

- I. Applicability and Purpose. This policy sets forth the duties, responsibilities, expectations, and standards of conduct for members of the Board of Governors of the University of North Carolina (UNC) System, the boards of trustees of the constituent institutions, and the boards of University-affiliated organizations where membership includes individuals appointed by the Board of Governors.
- II. Definitions. For purposes of this policy:
 - A. "Board" means the Board of Governors, a board of trustees of a constituent institution of the <u>University of North Carolina UNC System</u>, or a board of a University-affiliated organization with members appointed by the Board of Governors.
 - B. "Board member" means any member of the Board of Governors, a board of trustees of a constituent institution of the <u>University of North CarolinaUNC System</u>, or the board of a University-affiliated organization.
 - C. "Institution" means the <u>University of North CarolinaUNC System</u> or a constituent institution of the <u>University of North CarolinaUNC System</u>.
 - D. "University-affiliated organization" means an institution or organization that the Board of Governors is authorized to establish or to which it is authorized to appoint board members pursuant to statute, but does not include <u>Associated Entities associated entities</u> covered by Section 600.2.5.2[R] of the UNC Policy Manual or <u>Centers centers</u> or <u>Institutes institutes</u> covered by Section 400.5[R] of the UNC Policy Manual.

III. — Duties and Responsibilities. Board members are responsible for performing essential functions that are central to the governance of the University, as described in Chapter 116 of the North Carolina General Statutes, *The Code* of the University of North Carolina, the UNC Policy Manual of the University, and the policies and by-laws of the constituent institutions. Board members shall adhere to the standards of conduct and fulfill duties and expectations set forth in this policy.

A. Attendance. Board members shall attend board meetings. If a member of the Board of Governors is, for any reason other than ill health or service in the interest of the State or nation, absent for four (4) successive regular meetings of the Board, his or her place as a board member shall be deemed vacant. If a member of a board of trustees of a constituent institution is, for any reason other than ill health or service in the interest of the State or nation, absent for three (3) successive regular meetings of a board of trustees, his or her place as a board member shall be deemed vacant.

1. Exercise authority honestly and fairly, free from impropriety, threats, favoritism, and undue influence, as required by the State Ethics Act.⁴

- A. Removal of a Member of a Board of Trustees or University-affiliated Organization. The Board of Governors may remove from the board of trustees of a constituent institution or from the board of a University-affiliated organization a board member who was elected by the Board of Governors. With respect to a member of a board of trustees who was appointed by the Governora different appointing authority, the Board of Governors may vote to recommend to the Governorappointing authority that the member be removed.
- B. Removal of a Member of the Board of Governors. The Board of Governors may recommend to the State House of Representatives or State Senate, whichever chamber elected the member, that a member of the Board of Governors be removed.
- C. Other Sanctions. A board member, regardless of their appointing authority, may be subject to other sanctions lesser than removal (ex: public censure, suspension of voting rights, removal of committee assignments).

D. Complaints

- 1. Complaints against a board member may be made to the chair of the Committee on University Governance.
- 2. Upon receipt of a complaint, the chair of the Committee on University Governance shall determine whether, assuming all of the facts alleged are true, the complaint alleges a material violation of the duties, responsibilities, and expectations of board members. If the complaint does not meet this threshold, the chair of the

Committee on University Governance may dismiss the complaint and shall report the dismissal to the Committee on University Governance.

- 3. If the complaint is against a member of a board of trustees or University-affiliated organization, then the Committee on University Governance may retain the complaint for review and adjudication by the Governance Committee under section F. E, or it may direct the complaint to the board of trustees with directions for appropriate action. The committee's determination should be based on the allegations of the complaint, the board of trustee's capacity to review the complaint, and all other relevant circumstances.
- 4. The chair of the committee may, after consultation with the membership of the Committee, refer the complaint to the State Ethics Commission.

E. Interim Sanctions

- 1. A board member may be subject to an interim sanction(s) for an alleged material violation of the duties, responsibilities, and expectations of board members prior to review and adjudication of a complaint. Interim sanctions should be temporary in duration, and should balance the severity of the interim sanction against the severity of the alleged violation. Removal of a board member shall not be issued as an interim sanction.
- 2. The Committee on University Governance may recommend to the Board of Governors an interim sanction against a member of the Board of Governors that the committee deems appropriate. The Committee on University Governance may recommend interim sanction(s) against a member of a board of trustees or University-affiliated organization as part of the committee's referral of a complaint to a board of trustees with directions for appropriate action.
- 3. Any interim sanction shall require an affirmative vote of two-thirds (2/3) of the voting membership of the Board of Governors or board of trustees then in office.
- C.F. Procedure for RemovalSanctions; Specification of Cause; Notice and Opportunity to Respond
 - 1. The chair of the Committee on University Governance shall send the board memberrespondent a written specification of reasons to considerthe complaint(s) against the board member's removalmember. In the event that the chair of the Committee on University Governance is the subject of the board's consideration of a recommendation of removal, the vice chair of the Committee on University Governance will temporarily serve in the chair's role. The notice shall state that the board member may submit a written response to the chair of the Committee on University Governance and the complaining board member within five (5 five XXX (5X)) business days of receipt of the written notice.

- 2. The Committee on University Governance shall consider the written response of the board member and recommend to the Board of Governors action that the committee deems appropriate. If the board member submits no written response to the chair of the Committee on University Governance within the specified timeframe, the Committee on University Governance may continue with its consideration of removal of the board member, or a recommendation that the appropriate appointing or electing authority remove the board memberproceed to consider the complaint.
- 3. In its consideration of each matter, the Committee on University Governance shall ensure that all material facts are presented to the committee. The committee may select one or more committee members or another qualified individual to investigate the allegations and provide the committee with factual findings and a recommendation. The committee may review any documents or establish any procedures it considers necessary based on the particular circumstances involved.
- 4. Following the deadline for the respondent's written response and the conclusion of any investigation, the Committee on University Governance shall conduct a hearing to consider the complaint against the board member. The chair of the Committee on University Governance shall preside over the hearing, which shall include a full and accurate presentation of all relevant facts. During this hearing, the respondent member shall be permitted to be heard.
- 3.5. At the conclusion of the hearing, the Committee on University Governance shall assess the evidence presented using a preponderance of the evidence standard and recommend to the Board of Governors findings and action that the committee deems appropriate.

¥.VI. Other Matters

- A. Effective Date. The requirements of this policy shall be effective on the date of adoption by the Board of Governors.
- B. Relation to State Laws. The foregoing policies as adopted by the Board of Governors are meant to supplement, and do not purport to supplant or modify, those statutory enactments which may govern the activities of public officials.
- C. Regulations and Guidelines. These policies shall be implemented and applied in accordance with such regulations and guidelines as may be adopted from time to time by the president.

If the complaint is against a member of a board of trustees or University-affiliated organization, then the Committee on University Governance may retain the complaint for review and adjudication by the Governance Committee under section F., or it may direct the complaint to the board of trustees with directions for appropriate action. The committee's determination should be based on the allegations of the complaint, the board of trustee's capacity to review the complaint, and all other relevant circumstances.
- 4. The chair of the committee may, after consultation with the membership of the Committee, refer the complaint to the State Ethics Commission.

E. Interim Sanctions

- 1. A board member may be subject to an interim sanction(s) for an alleged material violation of the duties, responsibilities, and expectations of board members prior to review and adjudication of a complaint. Interim sanctions should be temporary in duration, and should balance the severity of the interim sanction against the severity of the alleged violation. Removal of a board member shall not be issued as an interim sanction.
- 2. The Committee on University Governance may recommend to the Board of Governors an interim sanction against a member of the Board of Governors that the committee deems appropriate. The Committee on University Governance may recommend interim sanction(s) against a member of a board of trustees or University-affiliated organization as part of the committee's referral of a complaint to a board of trustees with directions for appropriate action.
- 3. Any interim sanction shall require an affirmative vote of two-thirds (2/3) of the voting membership of the Board of Governors or board of trustees then in office.
- F. Procedure for Sanctions; Specification of Cause; Notice and Opportunity to Respond
 - 1. The chair of the Committee on University Governance shall send the respondent a written specification of the complaint(s) against the board member. In the event that the chair of the Committee on University Governance is the subject of the board's consideration, the vice chair of the Committee on University Governance will temporarily serve in the chair's role. The notice shall state that the board member may submit a written response to the chair of the Committee on University Governance and the complaining board member within five (5) business days of receipt of the written notice.

- 2. If the board member submits no written response to the chair of the Committee on University Governance within the specified timeframe, the Committee on University Governance may proceed to consider the complaint.
- 3. In its consideration of each matter, the Committee on University Governance shall ensure that all material facts are presented to the committee. The committee may select one or more committee members or another qualified individual to investigate the allegations and provide the committee with factual findings and a recommendation. The committee may review any documents it considers necessary based on the particular circumstances involved.
- 4. Following the deadline for the respondent's written response and the conclusion of any investigation, the Committee on University Governance shall conduct a hearing to consider the complaint against the board member. The chair of the Committee on University Governance shall preside over the hearing, which shall include a full and accurate presentation of all relevant facts. During this hearing, the respondent member shall be permitted to be heard.
- 5. At the conclusion of the hearing, the Committee on University Governance shall assess the evidence presented using a preponderance of the evidence standard and recommend to the Board of Governors findings and action that the committee deems appropriate.

VI. Other Matters

- A. Effective Date. The requirements of this policy shall be effective on the date of adoption by the Board of Governors.
- B. Relation to State Laws. The foregoing policies as adopted by the Board of Governors are meant to supplement, and do not purport to supplant or modify, those statutory enactments which may govern the activities of public officials.
- C. Regulations and Guidelines. These policies shall be implemented and applied in accordance with such regulations and guidelines as may be adopted from time to time by the president.

REPORT: STUDENT ELECTION WORKING GROUP

I. Working Group Purpose and Activities

On April 17, 2020, the University of North Carolina Board of Governors Committee on University Governance created the Student Elections Working Group. The working group was composed of student body presidents, chancellors, and members of boards of trustees and the Board of Governors. Its mission is to ensure that adequate anti-tampering procedures are in place to preserve the integrity of student elections at each constituent institution.

The working group reviewed each constituent institution's policies and practices regarding its student government election process. Based on the information collected, the working group determined that student government election policies across the UNC System could be improved by incorporating several common elements or additional provisions regarding elections oversight.

The working group's goal in publishing this report is to provide several policy recommendations for each constituent institution's student government organization. The non-binding policy recommendations are not intended to create a uniform student election process, but are meant to create awareness of the best practices on student government elections found within the System.

III. Working Group Recommendations

A. Student Election Policy Recommendations

The working group offers several recommendations for the student government organizations at the constitution institutions to consider. The recommendations are aimed at ensuring each student government is consistent in its approach to election protocols and student election financial transparency:

 The working group recommends each constituent institution student government create a financial reporting system that requires detailed documentation of donations and other contributions to candidates for student government elected office.

- The working group recommends that each student government adopt an election policy that
 prohibits contributions made by any University official, employee, or any individual directly
 affiliated with the respective constituent institution, the University of North Carolina System, or
 a political party who is not a registered student.
- 3. The working group recommends that each student government establish rules regarding maximum allowable campaign contributions and/or expense limits for each candidate for student government elected office. Contribution and expense limits may vary from institution to institution, but the working group recommends that student governments adopt limits that are appropriate for their own academic community.
- 4. The working group recommends that each student government create an independent body within the institution's student government organization to oversee student election administration. This body would govern student election protocols and adjudicate potential election policy violations. The working group recommends that this independent body be comprised of individuals who are free from conflict regarding any student government election activity that they oversee.

B. UNC Policy Manual Section 700.3.2

In addition to considering recommendations regarding constituent institution student government election policies, the working group also discussed University policy changes regarding improper influence in student government elections by University employees and officials. The working group reviewed and considered a proposal for a new section of the UNC Policy Manual, Section 700.3.2, "Policy on Student Government Elections." The proposed policy would prohibit University board members and employees from contributing to or influencing constituent institution student government elections. The working group voted unanimously in favor to recommend draft Section 700.3.2 to the UNC Board of Governors for consideration. A copy of this draft policy accompanies this report as Attachment 1.

Policy on Student Government Elections

I. Purpose. The University of North Carolina (UNC) Board of Governors has, through Section 700.3.1 of the UNC Policy Manual, recognized the role of student government within the University's constituent institutions. Section 700.3.1 establishes that neither the Board of Governors nor the president shall assert control over the substantive positions of the University of North Carolina Association of Student Governments. This policy is intended to insulate student government elections at UNC constituent institutions from influence of University employees, administrators, and trustees.

II. Definitions

- A. "Board member" means any member of the Board of Governors, a board of trustees of a constituent institution of the University of North Carolina, or the board of a University-affiliated organization.
- B. "Campaign contribution" means any advance, conveyance, deposit, distribution, transfer of funds, loan, payment, gift, pledge or subscription of money or anything of value whatsoever including but not limited to signs, printed items, or other professional services offered or provided to support or oppose the election of a student government candidate or a student considering filing for a student government election.
- C. "Employee" means an individual who is employed by the University of North Carolina, but shall not include "student-employees" as described in Section 300.3.3[G] of the UNC Policy Manual.
- D. "Influence activity" means endorsing, campaigning for, expressing or otherwise seeking to secure support for or opposition to any student government candidate or a student considering filing for a student government election.
- III. Prohibition on Campaign Contributions and Influence. University of North Carolina board members and employees shall not undertake, incent, solicit, or encourage any campaign contribution or influence activity related to any University of North Carolina constituent institution student government election.

IV. Other Matters

- A. Effective Date. The requirements of this policy shall be effective on the date of adoption by the Board of Governors.
- B. Relation to Federal and State Laws. The foregoing policy as adopted by the Board of Governors is meant to supplement, and does not purport to supplant or modify, those statutory enactments which may govern or relate to the subject matter of this policy.

C. Regulations and Guidelines. This policy shall be implemented and applied in accordance with such regulations and guidelines as may be adopted from time to time by the president.

Situation: The North Carolina Arboretum has one vacancy on its Board of Directors for a

term ending June 30, 2023.

Background: The North Carolina Arboretum Board of Directors has 17 members, with eight

appointed by the Board of Governors. Terms are for four years and a person may be reelected for successive terms with a service limit of two full terms. Dr. Alison Morrison-Shetlar was appointed by the Board of Governors to serve a term on the NC Arboretum Board of Directors beginning on July 1, 2019, and ending on June 30, 2023. Due to relocation, Dr. Morrison-Shetlar submitted her resignation

effective April 30, 2020.

Assessment: Western Carolina University Chancellor Kelli Brown is recommended for the

appointment. Biographical information is included in the materials.

Chancellor Kelli Brown

Western Carolina University's Chancellor, Dr. Kelli R. Brown, previously served as provost and senior vice president for academic affairs at Georgia College & State University, Georgia's public liberal arts institution.

At Georgia College, she led faculty and student success initiatives, including revitalizing a Center for Student Success, centralizing academic advising and increasing the four-year graduation rate by 25 percent. She supported numerous leadership development programs for faculty and departmental chairs and increased faculty recognition (including awards, and tenure and promotion).

In July 2016, Dr. Brown was appointed interim president of Valdosta State University, a regional comprehensive university in southern Georgia. She served in that capacity until a permanent president took office in January 2017, and she then returned to her position at Georgia College. She joined the faculty at Georgia College as a professor in the School of Health and Human Performance in June 2013.

Dr. Brown was interim dean and professor in the College of Health and Human Performance at the University of Florida from 2012 until 2013 and was associate dean for academic affairs there from 2007 until 2012. She was a Fellow of the American Council on Education in 2011-12. From July 2003 through June 2006, she was interim dean of the Graduate School at the University of South Florida.

Prior to that appointment, she was an active faculty member in the College of Public Health. Before joining the faculty at USF in 1996, she was chair of the Department of Health Sciences at Illinois State University for two years. During her seven years at Western Illinois University from 1987 until 1994, she rose through the ranks to become the graduate program coordinator in the Department of Health Sciences and, ultimately, assistant to the dean in the College of Health, Physical Education and Recreation.

She holds a doctorate in education from Southern Illinois University at Carbondale; a master of science and education in public health degree and bachelor of science degree, both from the University of Toledo; and an associate in applied sciences degree in dental hygiene from Michael J. Owens Technical College in Toledo, Ohio.
