

# **MINUTES**

October 17, 2024 Via Videoconference and PBS North Carolina Livestream The UNC System Office 223 S. West Street, Board Room (17<sup>th</sup> Floor) Raleigh, North Carolina

### Call to Order

The University of North Carolina Board of Governors met on October 17, 2024, at the UNC System Office in Raleigh, North Carolina. Chair Wendy Murphy called the meeting to order at 11 a.m. She welcomed everyone to the meeting and asked for a moment of silence to remember those who were impacted by Hurricane Helene, and to remember those who lost their lives due to the storm. She said that we send our support, thoughts, and prayers to the families and towns that face the long road to recovery. The worst has brought out the best in people across the state. She is heartened to see that the "spirit of public service" is being lived out by students, faculty, staff, and administrators alike. She thanked everyone who has contributed to the recovery efforts. She then called on President Peter Hans for his remarks.

President Hans reported he had just returned from a visit to the mountains and thanked our colleagues for their storm response. He thanked the chancellors for their steady resolve during this time of upheaval. He stated that everyone from the landscaping teams, food services, and facilities at the western universities all provided resources and help to the wider communities. He thanked UNC Healthcare for their days of nonstop work and help. He said it was heartwarming to see how our students care for one another and for their communities. He also thanked the law enforcement officers for their work and thanked the "tough and inspiring public servants who are the heart of this university." (APPENDIX A)

# Report of the Committee on Budget and Finance

Mr. Bradley, chair of the committee, stated the committee received reports on the 2024-25 NC Promise Tuition Program, Five-Year Actual General Fund Expenditures and Revenues, and the Quarterly Capital Project Report for October 1, 2024. These items were available on BoardEffect. The committee also reviewed and approved several transactional items and recommended them for a vote by the full Board of Governors through the consent agenda:

- Authorization for the East Carolina University Educational Foundation, Inc., to construct a multipurpose indoor practice facility on state property;
- Authorization for UNC-Chapel Hill to finance, under its existing commercial paper program, all or a
  portion of the costs of the capital improvement projects previously approved by the Board and
  authorized by the North Carolina General Assembly under S.L. 2024-24 (HB 912);
- Authorization of three new capital projects at two institutions and three increased authorizations at three institutions;
- Authorization to revise a previously approved 2021-23 Engineering NC's Future capital project for NC State University;
- Authorization for NC State University to acquire property by lease of approximately 20,037 square feet in the Venture III building, on the Centennial Campus in Raleigh, North Carolina; and
- Authorization for NC State University to dispose of property by ground lease at the Central Crops Research Station, Clayton, North Carolina.

Chief Financial Officer Jennifer Haygood reported on three categories of impact from Hurricane Helene on the System. They included \$18 million in capital impacts and \$14 million in debris cleanup and mutual aid, as well as \$19 million in revenue losses from canceled events. Ms. Haygood noted it is an evolving situation, and the amount of cooperation is commendable. The System is exploring emergency student aid, and \$7 million will be put toward the next round of Next NC Scholarships. President Hans stated he appreciated and commends those

who have stepped up, and the cooperation shows the value of the University System. Chair Murphy thanked the campuses that have reached out to offer their help and noted that we will all continue to work together.

Chair Murphy called on Mrs. Coward to deliver the report on behalf of the Committee on University Personnel.

# **Report of the Committee on University Personnel**

Mrs. Coward stated the committee received a presentation on recent improvements in the administration of human resources throughout the University of North Carolina System, including the simplification of employee classification, the streamlining of salary ranges, the elimination of longtime vacant positions, and updated delegated approval authority for human resources actions. These administrative improvements are creating improved efficiency and consistency in the administration of positions, salaries, and employee classifications across our constituent institutions. Chair Murphy thanked her and asked if there were any questions.
