A-1. 2024-25 Operating Budget AllocationsJennifer Haygood

Situation: During the Short Session, the North Carolina General Assembly approved adjustments

to the FY 2024-25 State budget already enacted through the 2023 Appropriations Act

(S.L. 2023-134).

Background: One of the principal responsibilities of the University of North Carolina Board of

Governors is to "develop, prepare, and present to the Governor and the General Assembly a single, unified recommended budget for the constituent institutions of the University of North Carolina" [G.S. 116-11(9)a]. In odd numbered years, the governor recommends and the General Assembly enacts a biennial (two-year) budget. In even-numbered years, adjustments are made to the budget for the second fiscal year of the biennium. Unless funds are appropriated directly to institutional budgets, the Board of Governors is responsible for allocating appropriated funds among the institutions,

consistent with applicable legislation.

Assessment: The General Assembly approved adjustments to the 2024-25 State budget through

Session Law 2024-55 on November 20, 2024, and Session Law 2024-57 on December 11, 2024. Many of the budget adjustments appropriated funds to the Board of Governors for allocation and require Board action. The recommended allocations meet all the General Assembly directives as enacted. In addition, changes were made

directly to institutional budgets.

Action: This item requires a vote by the committee as delegated by the full Board of Governors.

2024-25 Operating Budget Allocations

This document includes actions taken by the North Carolina General Assembly for the University of North Carolina System on December 11, 2024, in Session Law 2024-57, *Disaster Relief-3/Budget/Various Law Changes* and on November 20, 2024, in Session Law 2024-55, *Require ICE Cooperation and Budget Adjustments*. A comparison of the short session 2024-25 budget adjustments to the University of North Carolina Board of Governors budget priorities can be found in Appendix A. A summary of UNC-related provisions is provided in Appendix B.

It is recommended that the following proposed allocations for FY 2024-25 be approved, and that the president be authorized to make refinements in the interest of accuracy and completeness. It is also recommended that the president be authorized to seek such concurrence as may be required of the director of the budget in the allocation of budget priorities.

A. Recommended Allocations for Items Requiring Board Approval

1. UNC Performance Funding

The General Assembly appropriated \$13,068,267 in nonrecurring funds for performance funding. Funding allocations are based on each institution's performance according to metrics related to student success, affordability, and productivity. As presented and discussed during the meeting of the Committee on Budget and Finance in September 2024, institutions will receive a pro rata share of the combined two-year total performance funding allocated by the General Assembly. The calculation accounts for nonrecurring allocations campuses received in FY24. This funding method ensures that performance outcomes are funded on an equal basis across the two funding years. It is recommended the funding be allocated as shown in Table 1.

2. UNC Enrollment Loss Mitigation

The General Assembly appropriated \$7,837,646 in nonrecurring funds for enrollment loss mitigation funding. The funding ensures that no institution experiences more than a 4.5 percent decline in its student credit hour enrollment funding over the past two years. Consistent with Section 2A.4 of Session Law 2024-57 it is recommended the Board approve the allocations as shown in Table 2 below.

3. UNC Building Reserves

The General Assembly appropriated \$2,786,673 in recurring funds and \$470,404 in nonrecurring funds to operate and maintain Randall Library at the University of North Carolina Wilmington and Joiner Hall and other buildings at the Morganton Campus of North Carolina School of Science and Mathematics. The allocation is based on the UNC System building reserve model. Consistent with Section 2A.5.(b) of Session Law 2024-57 it is recommended the funds be allocated as shown in Table 3.

4. North Carolina Collaboratory to Establish and Operate the Office of Learning Research

The General Assembly appropriated \$1,500,000 in recurring funds for the 2024-25 fiscal year for the North Carolina Collaboratory to establish and operate the Office of Learning Research. Consistent with Section 2A.8.(a) of Session Law 2024-57 the Board is requested to approve the allocation as shown in Table 4 below.

5. UNC Student Credit Hour Enrollment Changes

The General Assembly appropriated \$574,578 in recurring funds due to higher enrollments at the University of North Carolina System institutions. At its July 2024 meeting in item A-3, "FY 2024-25 Enrollment Change Budget Adjustments," the Board approved the allocations of the \$574,578 as shown in Table 5 below contingent upon the passage of legislation appropriating the \$574,578. This item is included for information only.

B. Appropriated Directly to Campuses and Other Entities

The General Assembly increased appropriations directly to the North Carolina State Education Assistance Authority budgets, which do not require Board allocation. These are described below, for information only.

1. State Education Assistance Authority

The General Assembly made several appropriations to the North Carolina State Education Assistance Authority in Session Law 2024-55. S.L. 2024-55 appropriated \$248,000,000 nonrecurring in additional program awards for the Opportunity Scholarship program, \$215,460,000 recurring for the Opportunity Scholarship Grant Fund reserve, and \$24,700,000 recurring for Personal Education Student Accounts for Children with Disabilities program.
