

# MEETING OF THE BOARD OF GOVERNORS Committee on Budget and Finance

#### **AGENDA ITEM**

Situation: A recommendation of the Board of Governors' Working Group on Financial Aid

and Tuition required UNC institutions to report annually on tuition set-aside for

need-based financial aid.

Background: In October 2014, the Board of Governors received a report from the Board's

Working Group on Financial Aid and Tuition. The working group's final report made several recommendations including the implementation of a limit on need-based aid funded by tuition to a 15% maximum percentage of total base tuition revenue of an institution, and a requirement that institutions report annually to the Budget and Finance Committee of the Board of Governors on

tuition used for need-based aid.

The tuition bill statements were revised in 2014, at the request of the Board, to increase transparency regarding use of tuition and fees. The information required to meet the reporting requirements of the Working Group's report has

been incorporated into the tuition bill statements.

This item includes both a summary sheet of aid funded from set aside tuition

and institutions' tuition bill statements.

**Assessment:** All institutions are in compliance with the Freeze and Cap policy. Five are above

15% and are frozen, 11 are not frozen. Since implementation, four have increased the amount of need-based aid from tuition, two have decreased, and

10 have not changed.

**Action:** This item is for information only.










