## **Authorization of Capital Improvement Projects**

## **ISSUE OVERVIEW**

UNC institutions are required to request authority from the Board of Governors to proceed with nonappropriated capital projects using available funds (non-general funds). Non-appropriated capital projects are funded by the institution, and include the construction, repair, or renovation of facilities like residence halls, dining facilities, research buildings, athletic facilities, and student health buildings.

Five UNC institutions have requested a total of thirteen capital improvement projects: two projects for advance planning, two projects for increased authorization, and nine new projects for authority.
