# **DUTIES AND MEMBERSHIP**

The Committee on University Governance is responsible for reviewing and making recommendations for proposed changes to *The Code* and the Delegations of Duty and Authority involving University governance; for nominating individuals for election to the seventeen institutional boards of trustees and other University-related boards; for authorizing the initiation and settlement of litigation and pending litigation in circumstances where that authority has not otherwise been delegated; and for appellate review of certain campus actions and decisions involving students. This report summarizes the work of the committee from July 2016 through June 2017.

The committee was composed of the following Board members: Philip Byers, Frank Grainger, Henry Hinton, Rodney Hood (7/1/16-9/30/16), Ann Maxwell, Joan MacNeill (10/1/16-6/30/17), Champ Mitchell, and Robert Rippy. Mr. Hinton served as Chair, Ms. Maxwell served as Vice-Chair, and Mr. Grainger served as Secretary.

Chancellor David Belcher (WCU), Chancellor Thomas Conway (ECSU), Chancellor Robin Cummings (UNCP), and Chancellor Carol Folt (UNC-CH) also served on the committee.

# Review of The Code, UNC Policy Manual (Policies, Regulations and Guidelines)

Throughout the year, the committee held ongoing discussion in the areas of the UNC Policy Manual that needed to be updated, amended or reviewed. The committee voted to adopt the following revisions.

- UNC Policy 200.5 Initiating and Settling Lawsuits and UNC Policy 200.6 Delegation of Authority to the president. The previous policies did not explicitly address whether approvals that are required to settle lawsuits that have already been filed also applied to unfiled or potential litigation. The revisions clarified that the same requirements apply to pending litigation and potential litigation.
- 2. Sections 200, 300, and 400 of *The Code* which were changed in response to 2017 legislative action:
  - a. Section 200 B(1)(a). This section of *The Code* describes the requirements for electing members of the Board of Governors. The language includes the number to be elected every two years and the term limits for board members. The changes to this section were needed to conform to legislation passed in 2017 and 2016 that reduced the size of the Board of Governors and provided for a lifetime limitation of three full four-year terms.

- b. Section 300. This section of *The Code* contains the substantive and procedural rules that establish the Board's standing committees, provide for the selection of members for standing committees, set limits for serving as a member or chair of a standing committee, and describe the Board chair's (and vice chair's) authority and voting rights on committees. The proposed changes to this section are designed to: (a) allow for a reduction in the required membership of the committees given the upcoming reduction in the size of the board; and (b) adjust certain limitations on how long individuals may serve as voting members or chairs of committees.
- c. Section 300 B. This provision has long been interpreted by board chairs and members to *limit* voting members to serving on only one of the four main committees: Ed Planning; Governance; Budget and Finance; Personnel and Tenure. The Board desired the limitation to continue, it specified this limitation by saying that each voting member will serve on "no more than" one of those committees.
- d. **Section 301 A.** The amendment to this provision established a single minimum number of voting members for each committee (5), subject to the chair's determination, unless otherwise specified in *The Code*. The chair is a voting member of all committees. The vice chair is additionally assigned to one of the four committees by the chair.

The amendment established a single minimum number of voting members (5) allowing the chair to continue the same approach as the Board of Governors reduces to 24 voting members, while allowing the chair the discretion to adjust the membership of one or more of those committees above five.

- e. **Sections 301 B through G**. These sections described the jurisdiction of each committee. The amendments removed the language that specified the membership of each committee, in light of the proposed change to 301 A. Section 301 F (Public Affairs) provided that Public Affairs will consist of no fewer than three and no more than five members.
- f. Section 302 A. This section addresses the appointment of members to the committees, which is a significant responsibility of the chair of the Board. The amendment removed the four-year term limit that applied to the service of any voting member on a single committee. In its place, nonbinding language encourages the chair to assign members in a way that takes advantage of members' talents and experience, while also providing an opportunity to gain experience in multiple areas. These two goals are sometimes in conflict. Given that Section 300 B limits members to serving on no more than one of the four main standing committees (Budget, Ed Planning, Governance, or Personnel and Tenure), adjustments to the language clarified that in the event of a vacancy in the membership of the Board, the chair may appoint a member to more than one of the four committees to fill the vacancy.
- g. Section 302 B. The amendment to this section provided that an individual may serve up to four consecutive one-year terms as committee chair, rather than two years.

- h. **Section 400.** The amendments to this section of *The Code* brought it into alignment with recent legislation that shifted trustee appointments from the governor to the General Assembly.
- i. Section 402 C. The amendment to this section deleted a requirement that campuses send the University secretary copies of their board of trustees' minutes, since those materials can now be maintained and accessed online.

### **Boards of Trustees Workshop Planning**

The committee, along with staff from UNC General Administration, began planning the proposed agenda for the workshop to take place in early November.

### **Litigation Requests/Settlements**

The committee considered and approved a range of requests to initiate or settle legal matters and heard updates on pending disputes from its counsel.

### **Department of Defense Classified Research**

The committee passed two Resolutions on Clearance Requirements, which are an annual requirement related to Department of Defense contracts. The Department of Defense requires both UNC General Administration and UNC Charlotte to maintain Facility Security Clearances. Department of Defense regulations permit the exclusion from the personnel clearance requirements of certain members of the Board of Governors and other officers, provided that this action is recorded in the corporate minutes. These two resolutions were included in the Friday, July 29, 2016 Consent Agenda.



A-3. Resolution on Cle	arance Requirements Andrea Poole
Situation:	A resolution is required annually of the Board of Governors by the United States Department of Defense.
Background:	The Department of Defense requires UNC General Administration to maintain a Facility Security Clearance in the performance of classified contracts. In connection with this Facility Clearance, certain senior management officials must obtain an individual security clearance. This resolution is required to exempt members of the Board of Governors and senior officers of UNC General Administration from the requirement to obtain individual security clearances.
Assessment:	This is an annual resolution to be adopted by the Board of Governors.
Action:	This item requires a vote by the Committee, with a full Board vote through the consent agenda.



# RESOLUTION OF THE BOARD OF GOVERNORS OF THE UNIVERSITY OF NORTH CAROLINA AUTHORIZING SECURITY CLEARANCE

WHEREAS, current Department of Defense Regulations contain a provision making it mandatory that the Chairman of the Board and principal officers meet the personnel clearance requirements established for a contractor's facility clearance; and

WHEREAS, said Department of Defense Regulations permit the exclusion from the personnel clearance requirements of certain members of the Board of Governors and other officers, provided that this action is recorded in the corporate minutes.

**NOW THEREFORE BE IT DECLARED** that the Chairman of the Board, the President of the University of North Carolina, Associate Vice President for Safety & Emergency Operations (Insider Threat Program Senior Official), and the University's Facility Security Officer and Assistant Facility Security Officer at the present time do possess, or will be processed for, the required security clearance; and

**BE IT RESOLVED** that in the future, when any individual enters upon any duties as Chairman of the Board, the President of the University of North Carolina, Associate Vice President for Safety & Emergency Operations, or as the University's Facility Security Officer or Assistant Facility Security Officer, such individual shall immediately make application for the required security clearance; and

**BE IT RESOLVED FURTHER** that the following members of the Board of Governors and other officers shall not require, shall not have, and can be effectively excluded from access to **CLASSIFIED** information in the possession of the corporation and do not occupy positions that would enable them to affect adversely corporate policies or practices in the performance of classified contracts for the Department of Defense or the User Agencies of its Industrial Security Program.

Situation:	In August, the Committee on University Governance made seven recommendations to the Board of Governors for appointments to the NC Teaching Fellows Commission. One of the appointees is not able to serve, and the committee needs to make an additional recommendation.
Background:	Section 10A.3 of the Appropriations Act of 2017 re-established the North Carolina Teaching Fellows program and established the North Carolina Teaching Fellows Commission. Assessment:	It is recommended that Melba Spooner, Dean of the Reich School of Education at Appalachian State University be nominated to one of the two deans of schools of education appointments, in place of Ellen McIntyre UNC Charlotte. If approved, the recommended appointees would be as follows:

A-8.	Background on Report Deregulation	ı Tom Shanahan

- Situation: The UNC Policy Manual contains significant reporting and data collection requirements in the Board of Governors policies, as well as regulations and guidelines. The Board of Governors and the president have determined that it is appropriate to update reporting and other requirements in the UNC Policy Manual to support the following goals:
  - Ensure that authority and accountability for administrative actions are aligned and assigned to the appropriate executive officer or board (i.e., president, chancellor, Board of Governors, board of trustees);
  - Streamline reporting and eliminate low-value reporting; and
  - Eliminate outdated or incorrect provisions of existing policy.
- **Background:** The Committee on Audit, Risk Management, and Compliance (CARMC) conducted a review of the reporting and data collection requirements in the UNC Policy Manual during 2017 and identified approximately 140 separate requirements, which are listed in the attached chart. Staff to each of the Board's committees then provided recommendations for the disposition of the reporting requirements, which are reflected in the documents attached. CARMC received an update and summary of the project at the May 2017 meeting. CARMC also recommended, and the board adopted, revisions to UNC Policy 100.2, to direct that future reporting requirements should not be imposed in specific policies, but instead maintained by the president on a list of required reports. Over the next several meetings, each of the Board's committees will be considering revisions to policies to remove and streamline reporting requirements.
- Assessment: An update on the Report Deregulation portion of the Policy Review Project will be provided to the Committee on University Governance.

- Regular revision of Policy Manual
- Evaluate existing requirements with consistent criteria
- Gradually reduce reporting requirements in Policy Manual as policies are revised



# **Amendment of Policy 100.2**

- No new reporting requirements in Policy Manual
- Instead, requirements created, maintained, and updated by the president
- New requirements must meet consistent criteria

A-9. Report Deregulation – Updates to the UNC Policy Manual...... Tom Shanahan

- Situation: The UNC Policy Manual imposes reporting and data collection requirements on the University and its constituent institutions. While some of the reporting requirements are essential, many others have accumulated over a period of years, and no longer provide information that is necessary for business and performance analysis. In addition, the reporting and data collection requirements are scattered throughout the policy manual, making it difficult for institutions to comply with the requirements in an effective and efficient manner.
- **Background:** The president's staff has undertaken a thorough review of the UNC Policy Manual as part of a project overseen by the Committee on Audit, Risk Management, and Compliance (CAMRC). Some of the reporting requirements are outdated, have a compliance and regulatory focus, or are not designed to as opposed to assist the Board with performance analysis. The Board recently revised its policy on reporting (UNC Policy 100.2) to provide that future data collection and reporting to the Board, University leadership, and the public, should: (1) inform decision-making; (2) be relevant to strategic priorities/goals; (3) be cost effective compared to the reporting burden; (4) support risk management and risk mitigation; and (5) go to the appropriate level (president, chancellor, board of trustees, Board of Governors, or committee). Reporting requirements should also be centrally maintained by the president and easily accessible.
- Assessment: The proposed policy revisions and updates to select UNC policies presented to the committee for review are designed to eliminate or streamline reporting requirements consistent with the Board's policy. A description of each policy or regulation that has been revised or is being presented to the committee for action is attached. Policies require action by the committee. Regulations and guidelines are presented for information only.
- Action: This item requires a vote by the committee, with a full Board vote through the consent agenda at the next meeting.

#### Summary of Draft Amendments to The Code and Policy Manual

**Code Section 502 B(1).** This section of *The Code* describes the responsibilities of a constituent institution's chancellor to the Board of Governors and the president. Among these responsibilities, is the creation and delivery of an annual statutorily required report on the operation of the institution for the preceding year. This section does not provide detail about the content of the report. The proposed changes to this section removes the reporting requirement. The requirement to create this report would be maintained within a list of reports required by the president. The report's contents could be modified to deliver operationally useful information to evaluate implementation of the University's strategic plan.

<u>Code Section 502 C(2)</u>. This section of *The Code* describes the responsibilities of a constituent institution's chancellor to the board of trustees. Among these responsibilities is the creation and delivery of an annual statutorily required report on the operation of the institution for the preceding year. This section does not provide detail about the content of the report. The proposed changes to this section removes the reporting requirement. The requirement to create this report would be maintained within a list of reports required by the president. The report's contents could be modified to deliver operationally useful information to evaluate implementation of the University's strategic plan.

**Policy Manual Section 1300.6.** This section of the Policy Manual establishes the University's commitment to identify and implement efficiencies within its core mission of teaching, research, and public service. The section mandates a report by the president to the Board of Governors at least annually on the progress of efficiency initiatives and associated metrics. The proposed change would eliminate the requirement to produce an annual report. The University's reporting of efficiencies could be part of the strategic plan implementation.

#### CHAPTER V - OFFICERS OF THE UNIVERSITY SECTION 502. CHANCELLORS OF CONSTITUENT INSTITUTIONS.

. . . .

502 B. Relation of the Chancellor to the Board of Governors and the President.

(1) It shall be the duty of the chancellor to keep the president, and through the president the Board of Governors, fully informed concerning the operations and needs of the institution. Upon request, the chancellor shall be available to confer with <u>and make</u> <u>reports to</u> the president or with the Board of Governors concerning matters that pertain to the institution. [See G.S. 116-34(c)] As of June 30 of each year, the chancellor shall prepare for the Board of Governors a detailed report on the operation of the institution for the preceding year. [See G.S. 116-34(a)] The chancellor shall make such additional reports to the president or the Board of Governors as the president or the Board of Governors may require.

(2) The chancellor shall make recommendations for development of the educational programs of the institution [See G.S. 116-34(d)] and shall serve as general adviser to the president, and through the president the Board of Governors, with respect to all programs and activities of the institution.

(3) The chancellor shall be responsible to the president for the administration of the institution, including the enforcement of the decisions, actions, policies, and regulations of the Board of Governors applicable to the institution.

(4) Subject to policies prescribed by the Board of Governors and by the institutional board of trustees, the chancellor shall make recommendations for the appointment of personnel within the institution. [See G.S. 116-34(d)] With respect to all personnel matters, including appointments, promotions, removals, and compensation for the institution's academic, administrative, and other staffs, which are required to be acted upon by the Board of Governors, the chancellor shall make recommendations to the president.

(5) The chancellor shall present to the president all matters concerning the institution which are to be considered by the Board of Governors or any of its committees. In accordance with prescribed administrative procedures uniformly applicable to all institutions, the chancellor shall participate in the development of the proposed budget of the University of North Carolina.

(6) The chancellor shall be the official medium of communication between the president and all deans, heads or chairs of departments, directors, and all other administrative officers, faculty members, students, and employees.

502 C. Relation of the Chancellor to the Board of Trustees.

(1) It shall be the duty of the chancellor to attend all meetings of the board of trustees and to be responsible for keeping the board of trustees fully informed on the operation of the institution and its needs. [See G.S. 116-34(b)]

(2) As of June 30 of each year, the chancellor shall prepare for the board of trustees a detailed report on the operation of the institution for the preceding year. [G.S. 116 34(a)] The chancellor shall also-submit such additional reports to the board of trustees as the chancellor may deem wise or as the board may require. The chancellor shall seek the

counsel of the board of trustees concerning the affairs of the institution.

(3) The chancellor shall be responsible to the board of trustees for enforcing all policies, rules, and regulations of the board of trustees.

(4) The chancellor shall be the official medium of communication between the board of trustees and all individuals, officials, agencies, and organizations, both within and without the institution.

#### **Policy on Efficiency and Effectiveness**

The Board of Governors, consistent with its responsibility for the general direction and control of the University of North Carolina, is committed to ensuring continuous improvement in the consistency, efficiency and effectiveness of the operations of the University of North Carolina system, including the constituent institutions. It shall be the policy of the Board of Governors, the University's General Administration and the constituent institutions to identify and implement efficiencies that strengthen processes and productivity, that compete favorably with our peers and that generate cost or resource savings that may be reinvested to support key initiatives, approved by the Board of Governors, within the University's core mission of teaching, research, and public service.

The Board of Governors delegates to the president authority and responsibility to lead the University in the identification, implementation, and realization of academic and non-academic efficiencies in any area including, but not limited to, expanded shared services, strategic sourcing, non-instructional or instructional positioning, credit hour production, information technology infrastructure, utilization of facilities, energy consumption and such other areas as recommended by the Board of Governors. The Board of Governors shall, on recommendation of the president or on its own initiative, adopt metrics to track operational performance and shall use its best efforts to ensure that the University has the resources and expertise necessary to identify and implement efficiencies. The president shall report to the Board of Governors at least annually starting with calendar year 2014 on the progress of these initiatives and identified metrics. This policy shall be implemented and applied in accordance with such regulations and guidelines as may be adopted by the president consistent with this policy.

A-10. Policy on Free Expression — Discussion ......Steve Long

Situation: The North Carolina General Assembly has passed Campus Free Speech legislation, which became law (S.L. 2017-96) on July 31, 2017. The legislation requires the Board of Governors to develop and adopt a policy on free expression that meets the requirements of the statute. **Background:** The campus free speech legislation applies to the University of North Carolina and its constituent institutions. The Board of Governors must adopt a policy on free expression that includes certain elements, including the following: Recognition of the primary educational mission of the constituent • institutions and the commitment to the fullest degree of intellectual freedom and free expression; The role of the institution with respect to free expression; The First Amendment protections of the freedom of students and faculty • to discuss issues on campus; Access to campuses for purposes of free speech and expression; • Disciplinary considerations for interfering with the right to free expression; and • Identification of the officer, office, or department with responsibilities for ensuring compliance with the act and for answering any related questions or concerns; and shall require that any officer with those responsibilities receive training on ensuring compliance with the act. The committee will consider what should be included in a policy on free Assessment: expression and provide drafting instructions to staff. Action: This item is for discussion only.

A-11. Intercollegiate Athletics Matters – Discussion of Reporting......Steve Long

- Situation: Members of the committee would like to review the Board's existing policies and delegations of authority concerning intercollegiate athletics programs of the constituent institutions.
- **Background:** During the July 2017 meeting of the Committee on University Governance, committee members expressed interest in ensuring that the president and the Board receive timely notice from chancellors concerning issues or matters that could lead to allegations of Level I violations by the National Collegiate Athletics Association (NCAA).

The Board of Governors has delegated the responsibility for intercollegiate athletics to the chancellors under *The Code's Delegation of Duty and Authority* (Appendix I of *The Code*). That delegation is subject to the requirements and mandates that the Board of Governors may adopt, including <u>UNC Policy 1100.1</u>, which provides in relevant part that the chancellors shall ensure that the institutions conform with NCAA standards (copy attached). The Board has also established in <u>Section 502 B(1)</u> of *The Code* that it is the duty of the chancellor to keep the president, and through the president, the Board of Governors, fully informed concerning the operations and needs of the institution, and that the chancellor shall make such reports to the president or the Board of Governors as the president or the Board may require.

Assessment: The committee will review and discuss existing policies concerning governance of intercollegiate athletics.
