#### **DRAFT MINUTES**

May 22, 2019 University of North Carolina System Office Center for School Leadership Development, Room 276 Chapel Hill, North Carolina

This meeting of the Committee on Public Affairs was presided over by Chair C. Philip Byers. The following committee members, constituting a quorum, were also present: Joe Knott, N. Leo Daughtry, and R. Doyle Parrish.

#### 1. Approval of the Minutes of March 21, 2019 (Item A-1)

#### 2. State Relations Update (Item A-2)

Drew Moretz provided the committee with updates on the budget approved by the House, including its impact on university priorities and capital projects. Other policy bills impacting the university were also discussed briefly.

#### 3. Federal Priorities for FY 2020 (Item A-3)

At its meeting on March 21, 2019, the Committee on Public Affairs reviewed the Federal Priorities for FY 2020. After a brief explanation by Elizabeth Morra about how it is used to support legislative efforts, the committee elected to vote on this document.

#### 4. Military and Veterans Affairs Update (Item A-4)

a. Military Credit Database Update (Item A-4a.)

Kathie Sidner and Siobhan Norris, on behalf of the Committee on Military and Veterans Affairs, provided the Committee on Public Affairs with an overview of survey information gathered over the past year and the advantages – both moral and practical – of enrolling military-affiliated students, who academically outperform almost every peer group. Surveys conducted this year also captured the number of military-affiliated students at each institution, along with the resources available at each institution specifically dedicated to military-affiliated students.

Lastly, Kathie Sidner and Siobhan Norris previewed the database that will soon be available for military-affiliated students to check which university credits they are eligible for because of courses taken during their military service.

#### **AGENDA ITEM**

Situation: The Committee will receive an update on the current legislative session and status of

the state budget.

Background: On January 9<sup>th</sup>, the legislature returned for the "Long Session." The legislature has

passed numerous bills impacting the University, including H. 966, the 2019 Appropriations Act. H. 966 included a number of UNC Board of Governor-approved priorities, including a sizeable investments in new capital projects, major renovations,

and significant funding for repair and renovations.

On June 28<sup>th</sup>, the Governor vetoed H. 966 and the legislature is continuing to work to pass a spending bill, but has not held a veto override (as of this writing). Until a new budget is passed, the University is operating under the FY18-19 budget spending levels

(excluding non-recurring funding).

In the meantime, the legislature remains in session and the University continues to

engage on bills that impact our universities.

**Assessment:** The legislative session will end upon the passage of budget.

Situation: Elizabeth Morra will give an update on the federal budget, as well as several recent UNC

System activities on Capitol Hill.

**Background:** Prior to the congressional recess in August, the Congress and White House reached

agreement on a path forward for annual appropriations bills impacting federal accounts of importance to the UNC System, including Department of Education funding, as well as critical health and research funding. Elizabeth will provide an update on the negotiated agreement, as well as state of play and potential for a continuing resolution (CR) to keep the federal government open and running, if the annual spending bills cannot be completed prior to the October 1 deadline. Additionally, during the months of July and September two UNC System luncheon briefings were held on Capitol Hill to educate key congressional staff on the efforts and initiatives of the BOG's two special committees – Military Affairs and HMSIs. Elizabeth will give a brief update on those

briefings and associated activities.

Assessment: This briefing will summarize the current state of play on the FY 2020 federal budget and

challenges.
