1. Call to Order and Approval of OPEN Session Minutes (Item A-1)

2. Review of the UNC Policy Manual, Section 200.2 of the UNC Policy Manual (Election Procedures) (Item A-2)

The chair reviewed the UNC Policy Manual, Section 200.2 of the UNC Policy Manual (Election Procedures).

3. Proposed Revisions to Residence Classification, Chapter 900 of the UNC Policy Manual (Item A-3).

The chair called on Mr. Shanahan to provide the committee with an overview of the proposed revisions to residence classification, Chapter 900 of the UNC Policy Manual. Mr. Shanahan provided an overview of the proposed revisions and explained that, in light of the full implementation of Residency Determination System, which is administered by the North Carolina State Education Assistance Authority, Section 900.1 of the UNC Policy Manual must be

amended to reflect the transfer of authority for the residency function to SEAA. Section 900.2, which established the State Residence Committee, must be repealed, as the functions of the committee have been transferred to SEAA and will dissolve the State Residence Committee.

MOTION: Resolved, that the Committee on University Governance approves the revisions to Residence Classification, Chapter 900 of the UNC Policy Manual.

A-2. University of North Carolina at Chapel Hill Board of Trustees AppointmentJames L. Holmes, Jr.

Situation:	The University of North Carolina at Chapel Hill (UNC-CH) Board of Trustees has one partial-term vacancy effective November 22, 2019 and ending on June 30, 2021.
Background:	Mr. Dwight D. Stone served on the UNC-CH Board of Trustees since July 1, 2013, and served as chair of the board of trustees from 2015-2017. Mr. Stone was appointed by the North Carolina Senate to serve on the UNC Board of Governors effective November 22, 2019.
Assessment:	Mr. Munroe Cobey is recommended for appointment to fill this vacancy. This appointment is subject to the evaluation of Mr. Cobey's 2019 Statement of Economic Interest by the North Carolina State Ethics Commission.
Action:	This item requires a vote by the committee and a vote by the full Board of Governors.

Munroe Cobey

Munroe Cobey is an active Chapel Hill community member and a longstanding resident of North Carolina. He is a graduate of UNC-Chapel Hill, where he earned a Bachelor of Arts in Communications. He earned his master's in business administration from Wake Forest University in 1978.
