#### 2. State Relations Update (Item A-2)

Mr. Drew Moretz, vice president for State Government Relations, gave a presentation and update on the draft policy agenda. The draft policy agenda is comprised of policy items submitted from the universities and internal divisions at System Office. During the presentation, Mr. Moretz reiterated the successes included in last year's budget and emphasized the importance of seeing that the items included in the budget make it across the finish line.

The President's budget for FY 2021 proposes \$4.4 trillion in spending cuts over ten years. The budget proposes a number of changes and cuts, but Ms. Morra mentioned that Congress will have the last word on what changes ultimately move forward.

**Situation:** The committee will receive an update on recent legislative efforts.

Background: On January 14, 2020, the legislature adjourned the 2019 legislative session without a

budget resolution. Without a state budget, multiple institutions have been unable to pursue critical capital projects and infrastructure repairs and renovations. Interim President Roper, senior staff, and legislators traveled to multiple institutions to discuss how the lack of a budget will impact each respective campus. The legislature will return

on Tuesday, April 28, 2020, for the legislative "short session".
