## **DRAFT MINUTES**

November 18, 2020 Via Videoconference and UNC-TV Live Stream

This meeting of the Committee on Personnel and Tenure was presided over by Chair Kellie Hunt Blue. The following committee members, constituting a quorum, also attended: Reginald Ronald Holley, R. Doyle Parrish, W. Louis Bissette, Jr., Carolyn Coward, Art Pope, and Dwight D. Stone.

Staff members present included Matthew Brody, Kimberly van Noort, Carolyn Pratt, and others from the UNC System Office.

### 1. Call to Order and Reading of Conflict of Interest Statement

The chair called the meeting to order at 11:47 a.m. and read the Conflict of Interest Statement.

#### 2. Approval of the Minutes of October 21, 2020 (Item A-1)

The chair called for a motion to approve the open session minutes of October 21, 2020.

#### 3. Informational Report (Item A-2)

The committee received an informational report on new UNC System Office SAAO-I appointments under delegated authority to the president.

#### 4. General Updates (Item A-3)

Matthew Brody shared a brief update on human resources matters related to COVID-19.

#### 5. Workforce Metrics Including Employee Turnover (Item A-4)

Matthew Brody and Christopher Chiron, associate vice president for employee relations and University equal opportunity officer, presented more results from the 2020 Employee Engagement Survey, focusing on employee turnover and the comparison between internal and external hiring activity. The presentation showed that voluntary turnover has reduced or held steady at most of the System constituent institutions. It was noted that the overwhelming majority of System institutions had overall voluntary turnover rates at or below nationwide benchmarks for public institutions. The presentation also provided information on System-wide hiring activity and the degree to which new hires came from within the hiring institution, from other UNC System institutions, or were external to the University as a whole.

#### 6. Salary Increase Metrics (Item A-5)

The committee reviewed an informational report on recent salary increase request activity. The report reflects a substantive decrease in recent salary increase requests, largely due to the president's direction in response to System-wide concerns over the budget and the COVID-19 pandemic.

#### 7. Closed Session

The chair called for a motion to move into closed session.
