This meeting of the Committee on Budget and Finance was presided over by Chair James L. Holmes, Jr. The following committee members, constituting a quorum, were present in person, by video, or phone: W. Marty Kotis, III, J. Alex Mitchell, and Wendy Floyd Murphy. The following committee member was absent: Michael Williford.

Chancellors participating via videoconference were Sheri Everts, Kevin Guskiewicz, and Randy Woodson. Staff members present included Jennifer Haygood, Katherine Lynn, and others from the UNC System Office.

1. Call to Order and Approval of OPEN Session Minutes (Item A-1)

Chair James L. Holmes, Jr. called the meeting to order at 10:00 a.m., on January 20, 2021, and called for a motion to approve the open session minutes of December 17, 2020, for the regular meeting of the Committee on Budget and Finance.

2. Council of Student Body Presidents Discussion on Student Activities Fee (Item A-2)

The committee had a robust discussion on the Student Activities Fee with Board member Isaiah Green, Ms. Melanie Flowers (NC State University), Mr. Ryan Collins (UNC-Chapel Hill) and other members of the Council of Student Body Presidents within the UNC System.

3. Discussion: 2021-22 Tuition and Fee Proposals (A-3)

Senior Vice President for Finance and Administration Jennifer Haygood previewed the 2021-22 tuition and fee proposals submitted by the UNC System institutions. Chair Holmes asked committee members and other Board members to review the proposals in great detail and send any questions to him directly. He asked the System Office staff to coordinate with the campuses to obtain answers to any questions prior to the February meeting.

4. Discussion: Campus Security Fee (Item A-4)

Chair Holmes reminded the committee of why the Campus Security Fee was first implemented. Ms. Haygood stated that the \$30 Campus Security Fee was established at the end of a 2015-16 task force study. She outlined the uses of the fee revenue but clarified it is not the expectation that all expenditure categories are fully supported by this fee. The committee discussed needs surrounding law enforcement salaries, training, and protective equipment. After much discussion, the committee approved a motion to increase the current \$30 fee to \$60, subject to the three-percent mandatory fee increase cap and directed staff to include this increase in the materials to be voted on in February.

MOTION: Resolved, that the Committee on Budget and Finance approve an increase of \$30 to the campus security fee, subject to the three-percent cap, and directed staff to incorporate the increase in the 2021-22 fee authorization item to be voted on in February.

5. General Fund Update (Item A-5)

Ms. Haygood explained to the committee that the Office of the State Controller's General Fund report ending December 30, 2020, had not been released. As a result, she presented the November 30, 2020 information, which showed that General Fund revenues were \$60.7 million through November 2020, or 3.6 percent above November 2019 levels, and tax revenue growth was up over prior year levels. General Fund revenues exceeded appropriation expenditures through the end of November 2020.

6. Federal Stimulus Update (Item A-6)

Ms. Haygood shared with the committee an update of the federal stimulus. The 2021 Consolidated Appropriations Act [H.R. 133], signed into law on December 27, 2020, provided over \$287 million to the UNC

System institutions, not including previous CARES Act or new funding for HBCU/HMSIs. Institutions will receive approximately \$198 million in flexible institutional aid and \$90 million for emergency student financial aid.

7. 2021-23 Budget Priorities Update (Item A-7)

Ms. Haygood reminded the committee that the Board approved the UNC System 2021-23 Budget Priorities in November 2020. She presented the final details of the request, including enrollment funding amounts for individual institutions not available in November, revised building reserve numbers, and additional information on the four budget priorities.

8. Non-Appropriated Capital Improvement Project – University of North Carolina Wilmington

Senior Associate Vice President for Finance and Capital Planning Katherine Lynn presented a request by the University of North Carolina Wilmington for a non-appropriated (self-liquidating) capital improvement project. UNC Wilmington requested approval of a \$9.75 million project for Walton Drive Student Village Recreation Fields and Facilities. The funding would be from debt service fees. Upon approval by the Board, the project would be submitted for legislative approval.

MOTION: Resolved, that the Committee on Budget and Finance approve the request for UNC Wilmington's non-appropriated capital improvement project and recommend it to the full Board of Governors for a vote through the consent agenda.

This meeting of the Committee on Budget and Finance was presided over by Chair James L. J. Alex Mitchell joined the meeting at 3:05 p.m.

Chancellors participating via videoconference were Sheri Everts, Kevin Guskiewicz, and Randy Woodson. Staff members present included Jennifer Haygood, Katherine Lynn, and others from the UNC System Office.

1. Discussion: 2021-22 Tuition and Fee Proposals (A-1)

Chair James L. Holmes, Jr. called the meeting to order at 3:00 p.m., on February 9, 2021.

Chair Holmes reminded all members of the committee that the meeting would be conducted pursuant to the provisions of the Open Meetings Act. The law requires that all votes be taken by a roll-call vote. The chair also reminded committee members of their duty under the State Government Ethics Act to avoid conflicts of interest and appearances of conflict of interest. The chair asked if there were any conflicts or appearances of a conflict with respect to any matter coming before the committee. No members identified any conflicts at the time.

At the last meeting, the chair requested from members to send feedback, questions, or concerns about the tuition and fee proposals.

Senior Vice President for Finance and Administration Jennifer Haygood briefly reviewed the 2021-23 tuition and fee proposals and addressed the concerns of the members. After a robust conversation, the committee indicated that all questions had been answered.

2. Other Business (A-2)

Chair Holmes recapped the last meeting by noting the discussion and the committee approved a motion to increase the current \$30 campus security fee to \$60, subject to any adjustments needed due to the three percent statutory cap on fee increases and directed staff to incorporate the increase in the 2021-22 fee authorization item that would be considered by the full Board at its next meeting.

Due to feedback from chancellors, and given the current economic climate, the chair suggested that the committee delay action on the proposal to increase the campus security fee until additional information was available.

Mr. Kotis made a motion to move forward with the proposal.

MOTION: Resolved, that the Committee on Budget and Finance approve to move forward to increase the current \$30 campus security fee to \$60, subject to any adjustments needed due to the three percent statutory cap on fee increases and directed staff to incorporate the increase in the 2021-22 fee and recommend it to the full Board of Governors for a vote.

A-2. Authorization of Tuition for 2021-22......Jennifer Haygood

Situation: Tuition rates for undergraduate and graduate students, including professional

schools, are recommended for approval.

Background: G.S. 116-143 requires that the Board of Governors of the University of North

Carolina System fix the tuition and fees, not inconsistent with the actions of the General Assembly, at the constituent institutions of the UNC System. The 2016 General Assembly enacted a new guaranteed tuition program that fixes tuition rates for those first-time, full-time resident undergraduates and new transfer students who remain continuously enrolled for eight consecutive semesters or the equivalent number of remaining semesters for transfer students. Resident undergraduate tuition rates for 2021-22 will only apply to the cohort of students

who enroll in the fall of 2021.

Assessment: The universities have submitted 2021-22 tuition proposals in accordance with

legislative and UNC System Office guidelines for consideration by the Board.

Action: This item requires a vote by the committee and a vote by the full Board of

Governors.

A-2. Authorization of Tuition for 2021-22

The following RESOLUTION for the 2021-22 academic year reflects the tuition increases proposed by the institutions. The Board of Governors recommended no increases for resident students due to the COVID-19 pandemic. Several institutions are requesting increases to nonresident rates.

The 2016 General Assembly enacted a guaranteed tuition program that fixes tuition rates for first-time full-time resident undergraduates and transfer students that remain continuously enrolled for eight consecutive semesters or the equivalent number of remaining semesters for transfer students. Resident undergraduate tuition rates for 2021-22 will only apply to the cohort of students that enroll in the fall of 2021. The chancellors and their boards of trustees requested tuition rate increases for students consistent with legislative and UNC System Office guidelines.

RESOLUTION AUTHORIZING TUITION

WHEREAS, G.S. 116-143 requires that the Board of Governors of the University of North Carolina System shall fix the tuition and fees, not inconsistent with the actions of the General Assembly, at the UNC System constituent institutions.

NOW, THEREFORE, BE IT RESOLVED, that, effective with the Fall Term of 2021, the constituent institutions are authorized to charge and collect the following tuition rates.

I. 2021-22 Tuition Rates

In accordance with legislative and UNC System Office guidelines, institutions submitted tuition and fee proposals for 2021-22. The tuition amounts for all programs are shown on pages 3 through 9.

A. Increases in Tuition for Professional Schools

Three universities are proposing graduate professional school tuition increases for 2021-22. The rates require Board of Governors approval.

North Carolina A & T State University

Master of Accountancy – \$2,000 for nonresidents

N.C. A&T requests a tuition increase of \$2,000 for nonresidents for the Master of Accountancy program. The revenue generated would support marketing/recruitment initiatives and graduate assistantships.

<u>Joint Master of Social Work</u> (with UNCG) – reduction of \$374.13 for nonresidents Joint Ph.D. of Social Work (with UNCG) – reduction of \$374.13 for nonresidents

N.C. A&T requests a tuition decrease of \$374.13 for nonresidents in the Joint Master and Joint Ph.D. in Social Work programs in order to match the rate at UNCG and maintain a competitive position in recruitment. Students will have access to activities and services regardless of university home base. A reduction in operating expenses will be necessary to absorb the decreased revenue.

UNC-Chapel Hill

School of Law: Juris Doctor (J.D.) – \$2,500 for nonresidents (new students only)

UNC-Chapel Hill requests an increase of \$2,500 for graduate nonresident students in the J.D. program. This increase is in addition to the \$566 proposed for all graduate nonresidents. The revenue generated would fund faculty recruitment and retention, student support services, and scholarships.

UNC Greensboro

MS-Sustainability and Environment – new established rates – \$7,019, residents/\$20,737, nonresidents

UNC Greensboro is requesting to establish tuition rates as shown above for the new Master of Science in Sustainability and Environment program approved by the Board of Governors in the spring of 2020. The tuition revenue generated would support program administration costs, professional development, advertising, and graduate assistant stipends.

Proposed increases for professional schools may also include the requested campus-based increase for resident and nonresident graduate students.

II. 2021-22 Special Tuition Rates

Nonresident Graduate Students

Consistent with the General Statutes and by authorization of the Board of Governors through a resolution passed by the Board in 1983, the institutions are authorized to charge special tuition rates for nonresident graduate students.

For nonresident graduate students who are awarded a graduate teaching or research assistantship and who are paid a stipend of at least \$2,000 per academic year, the institution may award tuition remission to reduce the nonresident tuition rate to the in-state rate. For example, the nonresident graduate student tuition rate is proposed to increase from \$26,421 to \$27,082 at North Carolina State University for 2021-22. NC State's graduate nonresident students who are eligible to receive tuition remission will be charged the resident tuition rate, which will remain at \$9,095 for the 2021-22 academic year.

Each university receives a state appropriation for graduate tuition remissions and some universities supplement this appropriation from other non-state sources. Institutions may not provide graduate tuition remissions to all students. The number of awards is limited to those that meet the criteria and the budget availability.

Note: The 2011 General Assembly eliminated state appropriations for nonresident undergraduate tuition waivers that had been in place since 1983 [Sec. 9.13(b) of S.L. 2011-145].

III. Tuition for Students Enrolled in Degree-Credit Courses

It is proposed that, effective with the fall term of 2021, resident students and nonresident students taking courses within North Carolina be charged the regular-term tuition rates established by the Board and that tuition rates for these students be implemented on a percredit-hour basis to be calculated as follows:

- Undergraduate students shall be charged tuition per credit hour, at a rate equal to the
 annual undergraduate tuition rate at their institution divided by 24. The per-credit rate
 shall be capped at 12 credits per semester for fall and spring semesters, meaning
 undergraduate students shall not be charged for additional credits beyond 12 in a fall or
 spring semester.
- Graduate students shall be charged tuition per credit hour, at a rate equal to the annual
 graduate tuition rate divided by 18. The per-credit rate shall be capped at nine credits for
 fall and spring semesters, meaning graduate students shall not be charged for additional
 credits beyond nine per semester in a fall or spring semester.

It is further proposed that the Board continue to delegate to the president the authority to set tuition rates for nonresident students taking courses outside North Carolina and to approve tuition rates for self-supported summer enrollment.

Background: G.S. 116-143 requires that the Board of Governors of the UNC System fix the

tuition and fees, not inconsistent with the actions of the General Assembly, at the constituent institutions of the UNC System. The 2016 General Assembly enacted a provision that caps mandatory student fee increases (including debt service

fees) to three percent per year.

Assessment: The universities have submitted 2021-22 fee proposals in accordance with

legislative and UNC System Office guidelines for consideration by the Board.

Action: This item requires a vote by the committee and a vote by the full Board of

Governors.

A-3. Authorization of Fees for 2021-22

The following RESOLUTION for the 2021-22 academic year reflects fee increase proposals by each university. Chancellors requested fee increases consistent with the tuition and fee instructions, including a three percent cap on mandatory student fee increases enacted by the 2016 General Assembly.

RESOLUTION AUTHORIZING FEES

WHEREAS, G.S. 116-143 requires that the Board of Governors of the University of North Carolina System shall fix the tuition and fees, not inconsistent with the actions of the General Assembly, at the UNC System constituent institutions.

NOW, THEREFORE, BE IT RESOLVED, that, effective with Fall Term 2021, the constituent institutions are authorized to charge and collect the following fees.

Athletics Fees

Athletics fee revenues provide funds for intercollegiate athletic programs and for the maintenance and operation of athletic facilities.

For 2021-22, the tuition and fee instructions allowed institutions to propose an increase in one fee if it was offset by a commensurate decrease to another fee, resulting in no net increase in the total of all mandatory fees, excluding health services. UNC Pembroke is requesting a \$10 increase (with a decrease to the Educational and Technology fee) to cover athletics training and increases in health insurance costs. Elizabeth City State University is requesting a reduction to round its fee to the nearest whole dollar.

Health Services Fees

Health Services fees finance health and medical services for students, including the maintenance and operation of student health centers. The demand for counseling services has increased during the past few years and especially during the COVID-19 pandemic. Increases are requested in Health Services fees at 14 institutions for 2021-22.

ECSU's proposed increase of \$67.77 would support the hiring of a new mental health counselor and extended operating hours for health services. UNCC's proposed increase of \$88.00 would support new positions (8.0 FTE), including two for the counseling and psychological services team and operating and renovation expenses to accommodate the additional staff, counseling rooms, and offices. WSSU's proposed increase of \$73.00 would fund three new positions (Certified Health Education Specialist, Licensed Practical Nurse, and a Counselor-in-Residence), eCheckup software, and an online assessment tool.

Campus Security Fee

The 2013-14 UNC Campus Security Initiatives Report included high priority recommendations for new initiatives, staffing, and security measures designed to benefit the UNC System institutions. The Board approved this fee in 2015.

The fee assessed to students by each institution provides the UNC System with approximately \$6 million annually to support implementation of priority needs, while incenting shared services, collaboration, group purchasing and efficiency on a system level, where most appropriate.

At a special meeting on February 9, 2021, the Committee on Budget and Finance approved a motion to increase the Campus Security fee by \$30 at all institutions, except those that would result in a total mandatory fee increase over three percent. Therefore, the increases for five institutions are reduced this year, with the understanding that the fees will increase to \$60 in 2022-23.

Indebtedness Fees

Under the policy for the establishment of fees adopted by the Board of Governors in 1993 and revised in 2003, fees for the retirement of indebtedness are approved at the time a project is approved and established at the time that debt is incurred. Indebtedness fees, once established, remain in effect until the debt is retired.

NC State is reducing its debt service fee by \$38 due to the retirement of debt for Thompson Hall. UNC Wilmington is reducing the debt service fee for the Campus Rec Center Expansion Services Fund project by \$52 due to savings achieved following the refunding of 2010 revenue bonds. A new debt service project for Walton Drive Student Village Rec Fields and Facilities (approved by the Board in January 2021) with an associated \$52 debt service fee results in a \$0 net change to students.

Special Fees

Special fees provide funds for specific needs that are not financed from other revenue sources. Special fees are charged *only* to students who participate in programs or activities financed from those fees. These are programs that have specialized instructional needs, e.g., programs in health affairs, law, business, engineering, and architecture. These programs are expensive and occur in curricula where students must obtain a "competitive edge" to acquire highly desirable jobs upon graduation. Increases to Special fees were not allowed for 2021-22; however, UNC-Chapel Hill is requesting a name change to two fees to better reflect the projected expenditures. In addition to the Special fees listed below, all UNC System students are charged \$1.00 per year for the Association of Student Governments fee.

A-4. General Fund UpdateJennifer Haygood

Situation: General Fund appropriations support approximately 25 percent of the University of

North Carolina System budget. Given the economic uncertainty caused by COVID-19, the committee will monitor State General Fund revenues on an ongoing basis to identify

potential impacts on University operations and inform future decisions.

Background: The Fiscal Research Division (FRD) of the General Assembly and the Office of State

Budget and Management (OSBM) routinely collaborate to develop General Fund revenue forecasts used to inform the development of the State budget. To maintain necessary situational awareness, the System Office monitors these forecasts, as well as information provided through monthly General Fund financial reports issued by the

Office of State Controller.

Assessment: On February 11, 2021, FRD and OSBM issued a revised consensus revenue forecast,

which projects FY21 collections will be \$4.1 billion higher than previously forecast. The current year's anticipated revenue surplus is driven by sales tax collections, which have increased despite the pandemic, and the delayed tax payments that shifted

approximately \$1.1 billion out of FY20 and into FY21.

The forecast further projects moderate growth sustained throughout the 2021-23 biennium, with revenues reaching \$28.5 billion by the end of FY23. The economy is expected to remain stable throughout the forecast period but to grow at a pace below the long-term historical average due to a small segment of the workforce that will likely remain un- or underemployed as long as COVID-19 is prevalent. The forecast assumes there is at least another round of federal relief by spring. The size and timing of this

relief adds uncertainty to the overall forecast.

Additionally, the Office of State Controller has released updated General Fund data through January 31, 2021. General Fund revenues for January 2021 exceeded January 2020 revenues by \$270.9 million, or 11.4%. This growth continues the trend of year-over-year revenue growth that we have seen each month in FY21. General Fund revenues have exceeded appropriation expenditures through January 31, 2021,

resulting in an unreserved credit balance of \$5.2 billion.

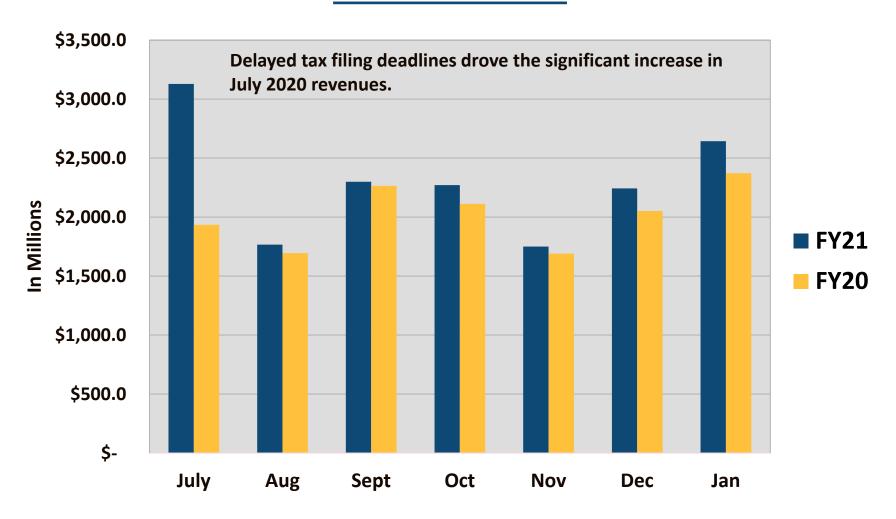

A-5. 2021-23 Base Budget......Jennifer Haygood

Situation:

One of the principal responsibilities of the UNC Board of Governors is to "develop, prepare, and present to the Governor and the General Assembly a single, unified recommended budget for the constituent institutions of The University of North Carolina System" [G.S. 116-11(9)a]. In odd-numbered years, the governor recommends, and the General Assembly enacts, a biennial (two-year) budget. In even-numbered years, adjustments are made to the budget for the second fiscal year of the biennium.

Background:

The base budget is the part of the recommended state budget that sets the baseline for the next biennium. The base budget was established by S.L. 2014-100, which amended the State Budget Act and replaced the continuation budget. Beginning with the 2015-17 biennial budget process, a number of items, including enrollment funding and building reserves, were removed from the base budget and are now requested as part of the expansion budget. As a result of this change, the base budget now largely reflects the prior fiscal year's authorized budget.

Allowable adjustments to the base budget include annualization of programs and positions, adjustments for nonrecurring funding, adjustments for federal payroll tax, rate increases for existing leases, adjustments to receipt projections, reconciliation of governmental transfers, and adjustments for statutory appropriations.

Assessment:

The 2021-23 base budget reflects limited adjustments to the current year authorized budget as identified by UNC System institutions. The adjustments that impact appropriation are a \$16.8 million reversal of nonrecurring funds appropriated for enrollment funding and building reserves as well as increases to existing leases at five campuses, totaling just over \$232,000.

The expansion budget priorities were approved by the Board at the November meeting and the full details of the request were presented for information at the January meeting. Since the availability of recurring State revenues remains uncertain, a specific amount for faculty and staff salary increases was purposefully not proposed; — rather, equity with state agencies is requested.

The sum of the 2021-23 base budget and expansion budget priorities constitutes the University's total request for General Fund appropriations for current operations: \$3,076,812,420 for 2021-22 and \$3,132,778,497 for 2022-23, excluding any additional appropriation for faculty and staff salaries.

Action:

A-6. 2021-23 Capital Priorities......Jennifer Haygood

Situation:

One of the principal responsibilities of the Board of Governors is to "develop, prepare, and present to the Governor and the General Assembly a single, unified recommended budget for the constituent institutions of the University of North Carolina" [G.S. 116-11(9)a]. This budget includes recommended funding for capital improvements supported by appropriated sources.

With Board approval, the appropriated capital projects will be included in the budget request for the 2021-23 biennium.

Background:

Every biennium, the University reviews its capital needs and prepares six-year capital improvement plans, which include prioritized plans for: 1) general fund capital improvement projects, 2) capital improvement projects supported by non-general fund sources such as housing, dining, parking, and other receipts, and 3) general fund repairs and renovations. Because of the University's significant backlog of deferred maintenance, campuses were directed to focus their 2021-27 Six-Year Capital Improvement Plans on extending the use of existing buildings through rehabilitation and renovation, rather than on new construction or expansion. These plans were used to develop recommended priorities for the 2021-23 biennium.

Assessment:

Given an environment where resources are constrained and demands for funding are significant, capital needs are prioritized with full acknowledgement that difficult funding decisions must be made for the state as a whole. Funding the projects recommended will significantly extend the useful life of the identified buildings and improve the ability of the universities to provide suitable academic space in a cost-effective manner.

Action: This item requires a vote by the committee and a vote by the full Board of Governors.

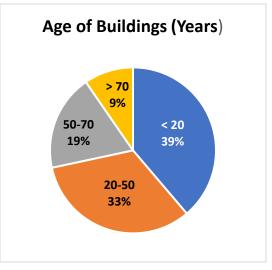


2021-23 Capital Improvement Priorities

The University of North Carolina System is one of the largest property managers in the state. The System is entrusted with over 3,000 buildings, more than \$27 billion in public assets that support the System's mission of teaching, research, and public service. From the humblest maintenance shed to the grandest auditorium, these buildings belong to the people of North Carolina. The System's campuses and research facilities were built with generations of public investment, and it the System's duty to preserve that investment for generations to come.

Meeting that responsibility has been a challenge. The facilities are aging, with almost 30 percent of buildings more than 50 years old. Of the System's 84 million total gross square feet (GSF), 45 million GSF is made up of appropriated buildings. Facility assessments, called FCAP reports, conducted periodically by the State Construction Office have identified \$3.42 billion in building deficiencies in appropriated buildings, including some critical life safety and code compliance issues.

Yet repair and renovation funding has varied widely over the System's recent history, averaging only \$32 million per year over the last decade. As a result, the buildings in the UNC System are suffering from the many years of deferred



maintenance. Left unaddressed, the cost of deferred maintenance escalates rapidly over time and increases the risk of critical system failures, resulting in unexpected disruption of services and costly emergency repairs. Further, as the System responds to changing student, programmatic, and research needs, how we utilize our space must change accordingly.

That is why we are focusing our efforts in the years ahead on caring for the University's existing space. These priorities lay out the most crucial needs across the state and our plan for a more cost-effective approach to maintenance and renovation. It is clear the System's role is not just as the trustee of valuable public infrastructure, but as a steward of North Carolina's culture and history. From Elizabeth City to Cullowhee, our campuses host architectural landmarks and centers of community life. This plan protects and preserves some of our state's most valuable places.

1. Repair, Renovation, and Rehabilitation: \$491,175,000

The System's top priority is working through the significant backlog of critical maintenance needed to preserve our existing facilities. Timely and consistent investment in facilities can reduce deferred maintenance costs for the System and the state, extend the life and efficiency of existing buildings, and reduce costly repairs due to critical system failures, unexpected disruption of services, increased urgency to restore operations, and the compounding impact of neglected maintenance and deterioration on other areas of the building or infrastructure.

Attachment A provides a list of recommended projects focused on the following priorities:

- Roof replacement, water intrusion mitigation, or building envelope repairs that allow buildings to remain in use and prevent further deterioration;
- System replacements (such as HVAC, electrical, fire alarms, elevators, etc.) of failing or obsolete systems that directly impact the continued occupancy of the building;
- Repair or replacement of critical plant operations or infrastructure that directly supports
 operation of critical core-mission buildings; this should not include the expansion or upgrade of
 any infrastructure to support new construction; and
- Demolition of vacant buildings.

In addition, the System requests the General Assembly appropriate funds to support smaller, but equally important, maintenance repairs and renovation (R&R) projects. Maintenance R&R funds would be allocated among campuses using the formula approved by the Board of Governors on September 20, 2019. This formula considers each campuses' gross square footage, total number of buildings, building condition, full-time student enrollment, and the ability to pay (based on the availability of carry-forward funds, F&A fund balances, infrastructure fees, and other funding for R&R earmarked projects). Funding would be used for the maintenance R&R priorities listed in **Attachment B** or other urgent maintenance needs that arise, subject to System Office approval.

2. Comprehensive Renovation and Facility Modernization: \$468,050,000

While the FCAP methodology provides an estimate of necessary repairs, it *does not* address improvements needed to improve functionality or update outdated space. Many aging facilities are simply inadequate to support current academic and research needs. For example, as institutions expand their focus on Science, Technology, Engineering, and Math (STEM) disciplines, the demand for lab space increases. Science labs require specialized ventilation, plumbing, and mechanical systems to protect building occupants and the integrity of the testing environment. Likewise, modern classrooms require technology and electrical capabilities beyond what many aging buildings can provide. Increased student enrollment and demand for more collaborative learning space require space to be repurposed and reconfigured.

Rather than spending limited resources on costly new construction, the state should invest in comprehensive renovations of existing facilities to extend their useful life, improve space utilization, and align with programmatic priorities. **Attachment C** provides a list of recommended priorities for comprehensive renovation and modernization projects.

3. Advanced Planning Funds for New Construction Projects Previously Authorized by the General Assembly: \$35,500,000

S.L. 2020-81

In addition to the priorities identified above, the General Assembly is expected to appropriate additional funding for two new construction projects authorized in S.L. 2020-81. This legislation enacted total project authorizations and appropriated \$7 million in advanced planning funds for each project. It also required both institutions to provide funding equal to half of the total project authorization by June 30, 2022, as a match for the intended state allocations.

S.L. 2020-81 also planned to allocate an additional \$7 million for advanced planning from the Coronavirus Relief Fund (CRF), but S.L. 2020-97 subsequently repealed this language due to federal

limitations on the allowable uses of CRF funds. The General Assembly is expected to appropriate these additional advanced planning funds for FY 2021-22 and further funding for construction once the required non-state match has been confirmed.

Health Science Facilities included in H.B. 966

During the 2019 Session, the General Assembly passed H.B. 966, which included a number of capital projects for the UNC System, including two new construction projects for health sciences facilities: 1) Brody School of Medicine at East Carolina University and 2) Health Science Center at UNC Pembroke. H.B. 966 was ratified, but later vetoed by the Governor and therefore, was never enacted into law. Given the state's healthcare workforce needs, the General Assembly may consider appropriating advanced planning funds for these two projects.

Non-appropriated capital projects are funded by the institution and include the construction, repair, or renovation of facilities such as residence halls, dining facilities, research buildings, athletic facilities, and student health buildings.

One UNC System institution has requested one project for increased authorization.
