February 17, 2021 University of North Carolina System Office Center for School Leadership Development, Board Room Chapel Hill, North Carolina

#### 2. State Government Relations Update (Item A-2)

Chair Byers called on Mr. Bart Goodson to present the update on the 2021 Legislative Session. Mr. Goodson highlighted the meetings that have been recently held at the North Carolina General Assembly. The meetings have

been very productive and the legislative members have been very responsive. System Office staff is assisting to draft bills and have identified sponsors for the System's legislative priorities. The relevant bills will be filed in the coming weeks. Mr. Goodson also updated the committee on Governor Cooper's Emergency Budget Supplement and the recent General Fund Revenue Consensus Forecast.

#### 3. Federal Government Relations Update (Item A-3)

Chair Byers called upon Ms. Elizabeth Morra to provide a federal government relations update to the committee. Ms. Morra gave an update on the latest stimulus package and highlighted funding relief included in the legislation for higher education and, more specifically, funds designated for UNC System institutions, as well as the timeline for passage. Ms. Morra also reviewed the UNC System Federal Priorities for the 117th Congress document, which she presented to the committee in January.

**Situation:** Committee members will receive an update on the Patriot Star Scholarship Program.

**Background:** Representative Dean Arp sponsored House Bill 475, and Senator Harry Brown sponsored

Senate Bill 376. The bills were rolled into HB 1105, Coronavirus Relief Act 3.0. HB 1105 became law on 9/4/20 and includes a \$1 million state appropriated scholarship program for eligible military children and spouses, known as the Patriot Star Scholarship Program. The funding is being administered through the UNC System to two North Carolina non-profit organizations: The Marine Corps Scholarship Foundation and the Patriot Foundation. All funds must be used by July 1, 2021. Any unused funds will be routed

back to the State.

Assessment: To date, \$480,000 has been distributed by the Patriot Foundation and \$379,504 has

been distributed by the Marine Corps Scholarship Foundation. The majority of recipients are military-affiliated students attending an institution in the UNC System. The Marine Corps Scholarship Foundation anticipates exhausting all funds, and the Patriot

Foundation anticipates routing approximately \$100,000 back to the UNC System.

## **Update on UNC System Priorities:**

#### Filed: All BOG approved UNC System priorities have been filed except:

- Exempt finance, business, and auditor officers from most of the NC HR Act
- Report consolidation or eliminations
- In-state tuition requirement for all Veterans
  - A technical change in state statue to comply with new federal law

HB 429: UNC Law Enforcement Ed. Incentive/SB 390: UNC Law Enforcement Recruitment

SB 367: UNC Wilmington Self-Liquidating Capital Project

SB 653: UNC/CC Financial Aid Program Consolidation



### Priorities that have passed one chamber:

### **HB 142/SB 130: UNC Building Reserves/Certain Projects**

 This bill will appropriate money for FY 2020-21 building reserves for four buildings coming online at ECSU, UNCC, UNCSA, and WCU.

### **HB 243: UNC Legislative Priorities/COVID-19 Impacts**

This includes our BOG approved "COVID-19" legislative HR agenda items.



# Other bills filed/tracking:

We are currently tracking over 150 bills this session.

(Senate filing deadline passed. House: May 4, non money bills/May 11, for Approps and Finance)

#### **HB 260: Fees for Advanced Courses/UNC**

This bill passed the House, Universities Committee on 3/11/2021

**HB 455: UNC BOG/Legislative Members** 

**HB 481: Firearm Disposal/UNC Campus Police** 

SB 546: UNC BOG/No Lobbyists/Spouses

SB 578: Study on Fixed In-State Tuition Plan for UNC

We are tracking other bills that have potential impacts to UNC System and will provide updates should those bills begin to move through the process.

## \$1.9 Trillion American Rescue Plan

## Signed into law March 11th

- √ \$350 billion for state and local governments
- ✓ \$1,400 direct stimulus checks
- √ \$300 weekly unemployment benefits (Sept)
- √ \$7.6 billion broadband access
- √ \$40 billion for higher education



# **HEERF III (Higher ED Emergency Relief Fund)**

> \$170 billion for education; \$40 billion for higher education

➤ Estimated \$700 million new funds for UNC System Institutions (\$500 million regular HEERF + \$191 million HBCUs/MSIs/SIPs for 10 campuses)

> Half for direct student aid; half institutional

# \$350 Billion State and Local Funds

### **American Rescue Act**

# \$9 billion for North Carolina (Dec. 31, 2024)

- > \$5 billion state; \$3.7 billion local governments (Tax Foundation Estimate)
  - ➤ Responding to COVID-19 emergency and addressing its economic impacts
  - Providing government services impacted by revenue reduction
  - > Investing in water, sewer and broadband
  - > Can't be used to fund pensions or tax cuts



### **American Jobs Plan**

### Infrastructure Stimulus - 'Build Back Better'

**Introduced March 31** 

Part I: \$2.25 Trillion (over eight years)

- > \$621 Billion Transportation Infrastructure
- > \$590 Billion Manufacturing, R&D, Job Training
- \$64 billion National Science Foundation (NSF) and National Institute of Standards and Tech (NIST)
- \$40 billion research infrastructure updates (\$20 b for HBCUs/MSIs)
- \$15 billion research Incubators for HBCUs/MSIs
- \$10 billion R&D at HBCUs/MSIs



### **American Jobs Plan**

> \$100 Billion to Expand Broadband Access and Internet Service

- > \$328 Billion Housing and Building Infrastructure
  - \$50 billion upgrade and build new schools with additional \$50 billion leveraged through bonds (K-12)
  - \$12 billion community colleges facilities and improvements

### Part II: Human Infrastructure (Next Month)

- Healthcare
- Higher Education
  - Doubling Pell Grant Program

Goal: July 1 passage

Reconciliation?

Tax increase offsets?

No Bipartisan Support



### President's FY 2022 Budget Request

- 'Skinny' budget sent to Congress Feb. 9
- Complete budget late spring

### Highlights

- +\$106 billion (16%) in domestic (non-def) spending, \$769 b
- +\$12.3 billion (1.7%) in defense spending, \$753 b
- +40% increase Dept of ED funding
- +\$600 million for HBCUs/MSIs
- \$400 increase in max Pell Grant award; first step toward doubling Pell
- Kicks off annual appropriations; Congress will write bills



# **Community Project Funding (Earmarks)**

# Newly-Reformed Process

- ➤ Limited to 1% of discretionary funding, \$1.3 billion of \$1.3 trillion budget
- ➤ Members limited to 10 CPFs; 10 programmatic and language requests across all approps bills
- Not all spending bills will allow CPFs and limited to certain accounts
- > House Republicans voted to allow reformed CPFs
- ➤ Big unknown: Will Senate R's participate? Senate needs conference rules change
