April 21, 2021 University of North Carolina System Office Center for School Leadership Development, Room 128 Chapel Hill, North Carolina

This meeting of the Committee on Public Affairs was presided over by Chair C. Philip Byers. The following committee members, constituting a quorum, were also present in person or by video: N. Leo Daughtry, Steven B. Long, Dwight D. Stone, and Temple Sloan.

Chancellor participating was Darrell Allison.

Staff members present included Bart Goodson, Elizabeth Morra, and others from the UNC System Office.

1. Call to Order and Approval of OPEN Session Minutes (Item A-1)

Chair Byers called the meeting to order at 11:30 a.m., on Wednesday, April 21, 2021.

Chair Byers called for a motion to approve the open session minutes of February 21, 2021.

2. State Government Relations Update (Item A-2)

Chair Byers called on Mr. Bart Goodson to provide a state government relations update to the committee. Mr. Goodson highlighted the activities and meetings at the North Carolina General Assembly, with respect to efforts to promote the UNC System 2021 Budget and Legislative Agenda. All of the UNC System priorities have been filed via bills in either the House or Senate. Many of these bills passed at least one chamber and staff continues to press

these issues as the May 13 crossover date approaches. Staff expects the remainder of the items to be included in the state budget. The Senate filing deadline passed and the House filing deadline is in early May. The state relations team is tracking over 150 bills this session. Lastly, Mr. Goodson updated the committee on meetings with members regarding the UNC System 2021 Budget and Legislative Agenda and Capital Request.

3. Federal Government Relations Update (Item A-3)

Chair Byers called upon Ms. Elizabeth Morra to provide a federal government relations update to the committee. Ms. Morra gave an update on the latest stimulus bill, The American Rescue Plan, and what it could mean for UNC System campuses in terms of funding and policy. She also outlined plans for two infrastructure bills making their way through Congress and previewed what was included in President Biden's FY2022 budget request. Finally, Ms. Morra told the committee about the newly reformed earmark process introduced in Congress, which is now called community project-funding requests.

4. Military Affairs Update (Item A-4)

Chair Byers called upon Ms. Kathie Sidner to provide a military affairs update to the committee. Ms. Sidner gave an update on the Patriot Star Scholarship program, a \$1 million state appropriated scholarship program for eligible military children and spouses. The UNC System administers this scholarship program through two North Carolina non-profit organizations, the Patriot Foundation and the Marine Corps Scholarship Foundation. Through April 2021, \$860,000 of the \$1 million funds for FY2021 had been distributed to 145 students attending 20 public, private, twoyear, and four-year institutions of higher learning in North Carolina. The majority of scholarship recipients (101 of 145) attend UNC System institutions.

Chair Byers introduced the new student representative to the committee Ray Palma from the University of North Carolina at Chapel Hill.

There being no further business and without objection, the meeting adjourned at 12:19 p.m.

SIX-YEAR INTENDED PROJECT ALLOCATION SCHEDULE

SECTION 40.2. It is the intent of the General Assembly to fund capital improvement projects on a cash flow basis and to plan for future project funding based upon projected availability in the State Capital and Infrastructure Fund. Nothing in this section shall be construed (i) to appropriate funds or (ii) as an obligation by the General Assembly to appropriate funds for the projects listed in future years. The following schedule lists capital improvement projects that will begin or be completed in fiscal years outside of the 2021-2023 fiscal biennium and estimated amounts (in thousands) needed for completion of those projects:
