General

The purpose of this memorandum is:

- a. To describe requirements for submission of the three-biennia capital improvements program.
- b. To set forth capital improvements program.

Three-Biennia Capital Improvements Program

It is desired that Forms DA-P-105, Statement of Need for Capital Improvement, shall be submitted for each of the three subsequent biennia as was done in preparation for the 1971-73 Capital Improvement Budget. The purpose of this request is to enable each institution, department, or agency to develop a six-year program of capital improvement requirements. It is to be noted that only the most pressing needs being of priority nature should be included in the 1973-75 requests, with projects of lesser priority and timely need to be set up for either the 1975-77 biennium or the 1977-79 biennium.

Form DA-P-105 (Revised October 1969) is available in quantity desired from the Property Control and Construction Division.

Particular attention is invited to that portion of Form DA-P-105 relating to cost estimate for equipment. Dollar value of equipment is to be estimated by the institution, department, or agency and should be shown both for fixed equipment and for movable equipment in the spaces provided. The value shown should be as realistic as possible based on current day prices. Appropriate

escalations where considered advisable will be accomplished in preparation of the final cost estimate by Property Control and Construction Division.

Schedule for Submission of Forms DA-P-105 (Rev. 10-69)

It is desired that all Forms DA-P-105 for all three biennia be submitted together and at one time. When prepared and completed, it is requested that all forms shall be forwarded to the Department of Administration, Property Control and Construction Division, in accordance with the following schedule:

Group I - On or before January 1, 1972
Group II - On or before February 1, 1972
Group III - On or before March 1, 1972
